BOARD OF INQUIRY.

At the Executive Council Chamber, Melbourne, the nineteenth day of October, 1972.

PRESENT:

The Acting Chief Justice of the Supreme Court of Victoria as Deputy for His Excellency the Governor of Victoria.

Sir George Reid Mr. Dunstan.

Whereas it is deemed expedient that a Board of Inquiry be appointed to inquire into and report upon matters contained in the under-mentioned terms of reference concerning the purchases and sales of land in Victoria by Alan Humphrey Croxford between the 29th September, 1961 and 17th October, 1972:

Now therefore, the Acting Chief Justice of the Supreme Court of Victoria as Deputy for His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth by this Order constitute and appoint—

WILLIAM OLIVER HARRIS, Q.C., LL.M.,

- to be a Board to inquire into and report upon-
 - 1. The purchases and sales of land in Victoria between the 29th day of September, 1961, and the 17th day of October, 1972, by Alan Humphrey Croxford and by any partnership syndicate or proprietary company of which he was a member or in which he had a direct or indirect pecuniary interest.
 - 2. Whether in relation to any such purchases or sales of land the said Alan Humphrey Croxford made use of information acquired by virtue of his position

as a councillor of the Shire of Doncaster and Templestowe, a Commissioner of the Melbourne and Metropolitan Board of Works or Chairman of the said Board which information was not generally available to the public.

- 3. Whether the said Alan Humphrey Croxford influenced or attempted to influence decisions of the Council of the Shire of Doncaster and Templestowe or the Melbourne and Metropolitan Board of Works in respect of any land in which he had a direct or indirect pecuniary interest.
- 4. Whether the said Alan Humphrey Croxford acted improperly illegally or without regard to the obligations of the office which he held at the relevant time in respect of any matter above referred to or any other transaction affecting land in which any person associated with him in business or by blood or marriage was involved.

And it is hereby directed that the said William Oliver Harris shall, with as little delay as possible, report under his hand on this inquiry.

Whereof the said William Oliver Harris and all other persons whom it may concern are to take notice and govern themselves accordingly.

And the Honorable Edward Raymond Meagher, Her Majesty's Chief Secretary for the State of Victoria, shall give the necessary directions herein accordingly.
