ACTS OF PARLIAMENT.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 8743. "An Act to amend the *Nurses Act 1958* to remove the prohibition in respect of Male Midwives and Mothercraft Nurses, to increase certain fees payable under the Act, and for other purposes." (*Nurses (Amendment) Act 1975.*)
- No. 8744. "An Act to amend the *Lifts and Cranes Act 1967* and for other purposes." (*Lifts and Cranes (Amendment) Act 1975.*)
- No. 8745. "An Act to amend the *Police Regulation Act 1958* and for other purposes." (*Police Regulation (Amendment) Act 1975.*)
- No. 8746. "An Act to increase the Fees payable on Licences issued under the *Business Franchise (Tobacco) Act 1974* and for other purposes." (*Business Franchise (Tobacco) Act 1975.*)
- No. 8747. "An Act to amend the *Stamps Act 1958* and for other purposes." (*Stamps Act 1975.*)
- No. 8748. "An Act to ratify validate approve and otherwise give effect to an Agreement between the Forests Commission and Softwood Holdings Limited with respect to the Establishment of an Industry for the manufacture of Particle Board from Softwood Timber obtained from Forests under the control of the Forests Commission and for other purposes." (*Forests (Softwood Holdings Agreement) Act 1975.*)
- No. 8749. "An Act to amend the *Melbourne Harbor Trust Act 1958*, the *Geelong Harbor Trust Act 1958*, the *Harbor Boards Act 1958* and the *Marine Act 1958* in relation to the Protection of Harbors and Navigable Waters from Damage, and for other purposes." (*Harbors and Navigable Waters Protection Act 1975.*)

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this fifth day of November, in the year of our Lord One thousand nine hundred and seventy-five, and in the twenty-fourth year of the reign of Her Majesty Queen Elizabeth II.
