DIVISION OF DOUTTA GALLA PROVINCE INTO
SUBDIVISIONS.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its
Dependencies in the Commonwealth of Australia, &c., &c.,
&c.

Whereas it is provided by the *Electoral Provinces and Districts Act 1974* that where the seat of a member for any of the Electoral Provinces of the Legislative Council as declared by Proclamation of the fourteenth day of December, 1965, becomes vacant otherwise than by a general dissolution of the Legislative Council, or by his retirement due to effluxion of time, the Governor in Council may by Proclamation in the *Government Gazette* divide the Electoral Province in respect of which such member was a representative into subdivisions corresponding as nearly as possible to the subdivisions proclaimed pursuant to the *Electoral Provinces and Districts Act 1974* in order to enable as far as possible the rolls prepared pursuant to section 16 of the said Act to be used in lieu of the former rolls for such Electoral Province in connection with the election of a member to fill the place of the member whose seat has become vacant as aforesaid:

And whereas the seat of the member for the Electoral Province of Doutta Galla declared by Proclamation of the fourteenth day of December, 1965, has become vacant otherwise than by a general dissolution of the Legislative Council or by his retirement due to effluxion of time:

And whereas by a Proclamation issued by the Governor in Council on the twenty-fourth day of December, 1975, and published in the *Victoria Government Gazette* of the nineteenth of January, 1976, the new Electoral Districts and Electoral Provinces created pursuant to the *Electoral Provinces and Districts Act 1974* were divided into subdivisions.

Now therefore I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this my Proclamation divide the said Electoral Province of Doutta Galla into the subdivisions the names and boundaries of which are specified in connection therewith in the Schedule hereto.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this thirty-first day of August, in the year of our Lord One thousand nine hundred and seventy-six, and in the twenty-fifth year of the reign of Her Majesty Elizabeth the Second, Queen of Australia.

SCHEDULE

NAMES AND BOUNDARIES OF SUBDIVISIONS OF
DOUTTA GALLA PROVINCE.

SUBDIVISION OF ASCOT VALE

Commencing on the Maribyrnong River where Maribyrnong Road abuts thereon; thence easterly by Maribyrnong Road to Mount Alexander Road; thence north-westerly by Mount Alexander Road to Ormond Road; thence easterly by Ormond Road to the Moonee Ponds Creek; thence southerly by that creek to a point in line with Myrnong Crescent; thence westerly by a line, Myrnong Crescent and the southern boundary of the City of Essendon to Mount Alexander Road; thence south-easterly by Mount Alexander Road to Kent Street; thence westerly by Kent Street to Ascot Vale Road; thence southerly by Ascot Vale Road to Epsom Road; thence north-westerly by Epsom Road to the southern boundary of the City of Essendon; thence south-westerly by that boundary to the Maribyrnong River; and thence generally northerly by that river to the point of commencement.

SUBDIVISION OF BROADMEADOWS NORTH

Commencing at the intersection of the North Eastern Railway and Camp Road; thence generally northerly by that railway to Somerton Road; thence easterly by that road to the Hume Highway; thence south-easterly by that highway to Cooper Street; thence easterly by that street to the Merri Creek; thence generally southerly by that creek to a point in line with Lowson Street; thence westerly by a line and Lowson Street to Lord Street; thence southerly by that street to Disney Street; thence south-westerly by that street and a line to the Melbourne to Upfield Railway; thence north-westerly by that railway to Camp Road; and thence westerly by that road to the point of commencement.

SUBDIVISION OF BRUNSWICK EAST

Commencing at the intersection of Sydney Road and Moreland Road; thence easterly by Moreland Road to the Merri Creek; thence generally south-easterly by that creek to Willowbank Road; thence south-westerly, north-westerly and westerly by Willowbank Road, southerly by King Street and westerly by Miller Street to Nicholson Street; thence southerly by Nicholson Street to Pigdon Street; thence westerly by Pigdon Street to Bowen Crescent; thence northerly by Bowen Crescent to Park Street; thence westerly by Park Street to Royal Parade; and thence northerly by Royal Parade and Sydney Road to the point of commencement.

SUBDIVISION OF BRUNSWICK SOUTH

Commencing at the intersection of Park Street and Royal Parade; thence westerly by Park Street and a line to the Moonee Ponds Creek; thence generally northerly by that creek to Dawson Street; thence easterly by Dawson Street to Grantham Street; thence southerly by Grantham Street to Union Street; thence easterly by Union Street to Sydney Road; and thence southerly by Sydney Road and Royal Parade to the point of commencement.

SUBDIVISION OF BRUNSWICK WEST

Commencing on the Moonee Ponds Creek at Moreland Road; thence easterly by Moreland Road to Sydney Road; thence southerly by Sydney Road to Union Street; thence westerly by Union Street to Grantham Street; thence northerly by Grantham Street to Dawson Street; thence westerly by Dawson Street to the Moonee Ponds Creek; and thence generally north-westerly by that creek to the point of commencement.

SUBDIVISION OF CARLTON

Commencing at the junction of Faraday Street with Swanston street; thence southerly by Swanston Street to Grattan Street; thence westerly by Grattan Street to Royal Parade; thence northerly by Royal Parade to Cemetery Road West; thence south-easterly by that road and College Crescent to Cemetery Road East; thence north-easterly by that road to Princes Street; thence easterly by Princes Street to Nicholson Street; thence southerly by Nicholson Street to Faraday Street; and thence westerly by Faraday Street to the point of commencement.

SUBDIVISION OF CARLTON NORTH

Commencing at the intersection of Nicholson Street and Pigdon Street; thence southerly by Nicholson Street to Princes Street; thence westerly by Princes Street and south-westerly by Cemetery Road East to College Crescent; thence north-westerly by College Crescent to Cemetery Road West and further north-westerly by that road and northerly by Royal Parade to Park Street; thence easterly by Park Street to Bowen Crescent; thence southerly by Bowen Crescent to Pigdon Street; and thence easterly by Pigdon Street to the point of commencement.

SUBDIVISION OF CRAIGIEBURN

Commencing at the south-eastern angle of section 8, Parish of Yuroke; thence northerly by the eastern boundaries of sections 8, 13, 17, a line, and the eastern boundary of section 22 to the north-western angle of allotment B, section 23; thence easterly by the northern boundary of the Parish of Yuroke to the Merri Creek; thence generally north-easterly by the Merri Creek to the southern boundary of section 20, Parish of Merriang; thence easterly by the southern boundaries of sections 20 and 19 and further easterly by the southern boundaries of allotments 1 and 2, section 15, Parish of Toorourrong to the western boundary of section 10; thence southerly by the western boundaries of sections 10, 7 and 2, a line, the western boundaries of sections 18, 15, 10, 7 and 2 Parish of Yan Yean, a line and the western boundaries of portion 18, section 15, portion 10 and section 7 Parish of Morang to the southern boundary of the last mentioned section; thence westerly by the northern boundary of portion 1, Hendersons Road and Cooper Street to the Hume Highway; thence north-westerly by the Hume Highway to Somerton Road; and thence westerly by Somerton Road to the point of commencement.

SUBDIVISION OF ESSENDON

Commencing at the intersection of Carnarvon Road and Woodland Street; thence easterly by Woodland Street, a line, again Woodland Street and a line to the Moonee Ponds Creek; thence generally south-westerly and south-easterly by the Moonee Ponds Creek to Ormond Road; thence westerly by Ormond Road to Mount Alexander Road; thence south-easterly by Mount Alexander Road to Maribyrnong Road; thence westerly by Maribyrnong Road to the North Eastern Railway; thence north-westerly by that railway to Buckley Street; thence westerly by Buckley Street to Lincoln Road; thence northerly by Lincoln Road to Bulla Road; thence north-westerly by Bulla Road to Carnarvon Road; and thence northerly by Carnarvon Road to the point of commencement.

SUBDIVISION OF ESSENDON WEST

Commencing at the junction of Lincoln Road with Buckley Street; thence westerly by Buckley Street to the south-western angle of allotment A, section 13, Parish of Doutta Galla; thence northerly by the western boundary of that allotment to Keilor Road; thence south-easterly by Keilor Road to Lincoln Road; and thence southerly by Lincoln Road to the point of commencement.

SUBDIVISION OF FAWKNER

Commencing at the junction of Boundary Road with the western boundary of the New Melbourne General Cemetery; thence easterly by Boundary Road and the northern boundary of the City of Coburg to the Merri Creek; thence generally northerly by that creek to a point in line with Lowson Street; thence westerly by a line and Lowson Street to Lord Street; thence southerly by that street to Disney Street; thence south-westerly by that street and a line to the Melbourne to Upfield Railway; thence south-easterly by that railway to Box Forest Road; thence westerly by that road to the western boundary of the New Melbourne General Cemetery; and thence southerly by that boundary to the point of commencement.

SUBDIVISION OF FITZROY NORTH

Commencing at the junction of Nicholson Street with Freeman Street; thence northerly by Nicholson Street to the Royal Park to Fitzroy Railway; thence easterly by that railway and a line to St. Georges Road; thence north-easterly by that road to the Merri

Creek; thence south-easterly by that creek to Queens Parade; thence south-westerly by that parade to Napier Street, thence northerly by that street to Freeman Street; and thence westerly by that street to the point of commencement.

SUBDIVISION OF GLENROY

Commencing at the junction of Northumberland Road and Gaffney Street; thence westerly by Gaffney Street to the North Eastern Railway; thence north-westerly by that railway to a point in line with Hilton Street; thence easterly by a line and Hilton Street to the western boundary of the New Melbourne General Cemetery; thence southerly by that boundary and Sussex Street to Boundary Road; thence westerly by Boundary Road and Pascoe Street to Northumberland Road; and thence southerly by Northumberland Road to the point of commencement.

SUBDIVISION OF GLENROY NORTH

Commencing at the intersection of the North Eastern Railway and Camp Road; thence easterly by Camp Road to the Melbourne to Upfield Railway; thence south-easterly by that railway to Box Forest Road; thence westerly by that road, Hilton Street and a line to the North Eastern Railway; and thence northerly by that railway to the point of commencement.

SUBDIVISION OF GLENROY WEST

Commencing at a point on the Moonee Ponds Creek in line with Gaffney Street; thence north-westerly and northerly by that creek to the Thomastown-Keilor 220 K.V. S.E.C. transmission line; thence north-easterly by that transmission line to the North Eastern Railway; thence generally south-easterly by that railway to Gaffney Street; and thence westerly by Gaffney Street and a line to the point of commencement.

SUBDIVISION OF JACANA

Commencing at the intersection of the North Eastern Railway and Somerton Road; thence generally southerly by that railway to the S.E.C. Thomastown-Keilor 220 K.V. transmission line; thence south-westerly by that transmission line to the Moonee Ponds Creek; thence north-westerly by that creek to the S.E.C. Hazelwood-Keilor 500 K.V. transmission line; thence northerly by that transmission line to the southern boundary of portion 9, Parish of Will-will-rook; thence easterly by that boundary to the western boundary of the City of Broadmeadows; thence northerly by that boundary to Somerton Road; and thence easterly by that road to the point of commencement.

SUBDIVISION OF KALKALLO

Commencing on the Deep Creek where Craigieburn Road abuts thereon; thence easterly by Craigieburn Road to the south-eastern angle of section 22 Parish of Yuroke; thence northerly by the eastern boundary of section 22 to the north-western angle of allotment B section 23; thence easterly by the northern boundary of the Parish of Yuroke to the Merri Creek; thence generally north-easterly by the Merri Creek to the southern boundary of section 20 Parish of Merriang; thence easterly by the southern boundaries of sections 20 and 19 to the eastern boundary of the parish; thence northerly by the eastern boundary of the said parish to the road forming the southern boundary of the Parish of Wallan Wallan; thence westerly by that road to the south-western angle of allotment 5, section D; thence north-westerly and easterly by a road to the road forming the eastern boundary of allotment 18 section B; thence generally northerly and north-easterly by that road to the south-western boundary of the Kilmore Water Supply Catchment Area; thence generally south-easterly by that boundary to the Great Dividing Range; thence north-westerly and south-westerly by the Great Dividing Range to the south-eastern angle of allotment 158A, Parish of Bylands; thence north-westerly, south-westerly and westerly by a road and a line to the Wallan to Broadford road; thence northerly by the latter road to the south-eastern angle of allotment 11, section E; thence westerly by a road to the north-western angle of allotment 111; thence southerly by a road to the northern boundary of allotment 116; thence easterly by that

boundary and southerly by a road to the eastern boundary of allotment 9, section A; thence southerly by that boundary to the southern angle of the said allotment; thence westerly by a road to the Boyds Creek; thence southerly by that creek and generally south-westerly by the Deep Creek to the eastern boundary of the Parish of Havelock; thence southerly by that boundary and easterly by the northern boundary of the Parish of Bollinda to the Konagaderra Creek; and thence generally southerly by the Konagaderra Creek and the Deep Creek to the point of commencement.

SUBDIVISION OF MERRI

Commencing at the intersection of Miller Street and Nicholson Street; thence southerly by Nicholson Street to the Royal Park to Fitzroy Railway; thence easterly by that railway and a line to St. Georges Road; thence north-easterly by St. Georges Road to the Merri Creek; thence north-westerly by that creek to Willowbank Road; thence generally westerly by Willowbank Road to King Street; thence southerly by King Street to Miller Street; and thence westerly by Miller Street to the point of commencement.

SUBDIVISION OF MOONEE PONDS WEST

Commencing at the intersection of Maribyrnong Road and the Maribyrnong River; thence northerly and westerly by that river to the western boundary of allotment 1, section 7, Parish of Doutta Galla; thence northerly by that boundary to Buckley Street; thence easterly by Buckley Street to the North Eastern Railway; thence south-easterly by that railway to Maribyrnong Road; and thence westerly by Maribyrnong Road to the point of commencement.

SUBDIVISION OF PARKVILLE

Commencing at the intersection of Royal Parade and Park Street; thence westerly by Park Street and a line to the Moonee Ponds Creek; thence generally south-easterly by that creek to Mount Alexander Road; thence south-easterly by Mount Alexander Road and Flemington Road to Elizabeth Street; and thence northerly by Elizabeth Street and Royal Parade to the point of commencement.

SUBDIVISION OF STRATHMORE

Commencing at the junction of Mount Alexander Road with Keilor Road; thence north-westerly by Keilor Road to Treadwell Road; thence northerly by Treadwell Road, a line, again Treadwell Road and a line to the eastern boundary of the City of Keilor; thence north-westerly by that boundary to the Albion to Broadmeadows Railway; thence north-easterly by that railway to the Moonee Ponds Creek; thence generally south-easterly by that creek to a point in line with Woodland Street; thence westerly by a line, Woodland Street, a line, again Woodland Street to Carnarvon Road; and thence southerly by Carnarvon Road and south-easterly by Bulla Road to the point of commencement.

SUBDIVISION OF THOMASTOWN

Commencing at the intersection of Mahoneys Road and the Merri Creek; thence generally northerly by that creek to Cooper Street; thence easterly by that street, Hendersons Road and the northern boundary of portion 1, Parish of Morang to the north-eastern angle thereof; thence southerly and westerly by the eastern and southern boundaries of the said portion to the Darebin Creek; thence generally southerly by that creek to the northern boundary of the City of Preston; and thence westerly by that boundary, Keon Parade and Mahoneys Road to the point of commencement.

SUBDIVISION OF TULLAMARINE

Commencing at the intersection of the Moonee Ponds Creek and the Broadmeadows to Albion Railway; thence south-westerly by that railway to the eastern boundary of the City of Keilor; thence north-westerly by that boundary to the northern boundary of the Parish of Doutta Galla; thence westerly by that boundary

to the Maribyrnong River; thence generally north-westerly by that river to the Deep Creek; thence northerly by that creek to a point in line with Greenvale Road; thence easterly by a line, Greenvale Road and Somerton Road to the western boundary of the City of Broadmeadows; thence southerly by that boundary to the southern boundary of portion 9, Parish of Will-will-rook; thence westerly by that boundary to the S.E.C. Hazelwood-Keilor 500 K.V. transmission line; thence southerly by that transmission line to the Moonee Ponds Creek; and thence generally southerly by that creek to the point of commencement.

SUBDIVISION OF YUROKE

Commencing at a point on the Deep Creek in line with Greenvale Road; thence easterly by a line, Greenvale Road and Somerton Road to the south-eastern angle of section 8, Parish of Yuroke; thence northerly by the eastern boundaries of sections 8, 13 and 17 to Craigieburn Road; thence westerly by that road to the Deep Creek; and thence generally southerly by that creek to the point of commencement.
