Hospitals and Charities Act 1958.

PETITION TO INCORPORATE SHEPPARTON AND DISTRICT RETIREMENT VILLAGE.

It is notified in accordance with the provisions of section 46 of the *Hospitals and Charities Act 1958*, that the Hospitals and Charities Commission has received a petition signed by not less than twenty-five contributors to an organization known as Shepparton and District Retirement Village praying that the organization be incorporated as an institution under the provisions of the said Act.

The organization will have for its objects:—

- (a) To provide charitable relief to aged persons by providing permanent facilities for their daily accommodation and care within the institution, stipulating that, in premises, for which a grant under the Commonwealth Aged Persons' Homes Act 1954-1957 has been received, only aged persons as defined in that Act will be admitted; and provided further that at least 50 per cent. of the initial and all additional accommodation is to be made available for completely charitable cases; i.e. persons in necessitous circumstances.
- (b) Doing such other things which, in the Committee's opinion will provide for the economic, social and recreational well-being of the residents.

If a counter petition signed by an equal or greater number of contributors is not lodged with the aforesaid Commission at 555 Collins Street, Melbourne, within one calendar month of publication of this notice, the Governor in Council may, by Order pursuant to the *Hospitals and Charities Act 1958* declare the contributors for the time being to Shepparton and District Retirement Village to be a body corporate by the name set forth in such Order.
