HEALTH COMMISSION ACT 1977 No. 9023 COMING INTO OPERATION

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by an Act of Parliament of the State of Victoria passed in the twenty-sixth year of the reign of Her Majesty Elizabeth the Second, Queen of Australia, entitled the *Health Commission Act 1977 No. 9023*, it is amongst other things enacted that the several provisions of Parts I and II, except sections 6 and 7, Part V except section 32, and sections 55 and 56 shall come into operation on a day or on the respective days to be fixed by Proclamation or successive Proclamations of the Governor in Council published in the *Government Gazette*:

Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation fix Wednesday the eleventh day of January, One thousand nine hundred and seventy-eight as the day on which sections 1, 2, 3, 4, 5, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 30, 31, 35, 55 and 56 of the said *Health Commission Act 1977 No. 9023*, shall come into operation.

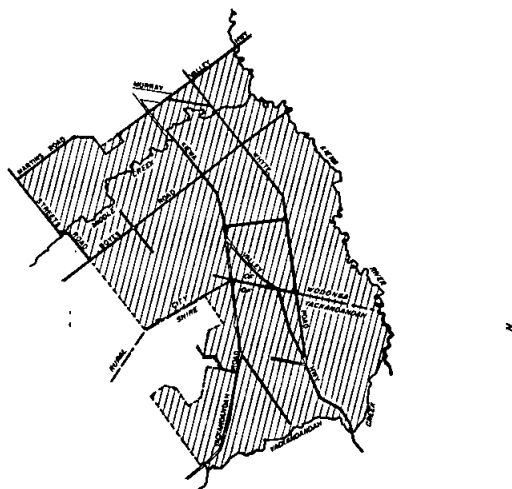

(b) For all water supplied in any meter year in excess of the maximum quantity referred to in paragraph (a) of this clause the charge is hereby fixed at—

25 cents per thousand gallons or 5.50 cents per kilolitre for the first 1,000,000 gallons or 4550 kilolitres.

18 cents per thousand gallons or 4 cents per kilolitre for the next 500,000 gallons or 2275 kilolitres.

13.5 cents per thousand gallons or 3 cents per kilolitre for all consumption in excess of 1,500,000 gallons or 6825 kilolitres for any meter year.

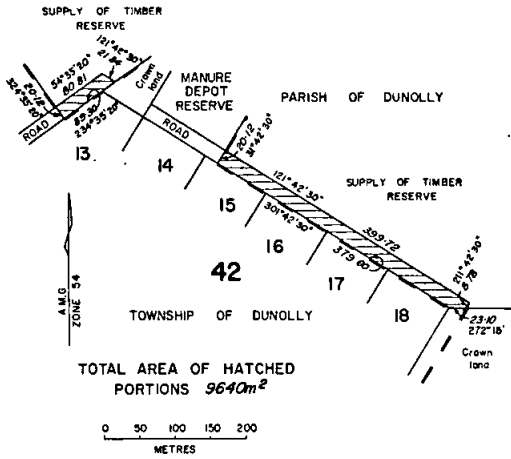

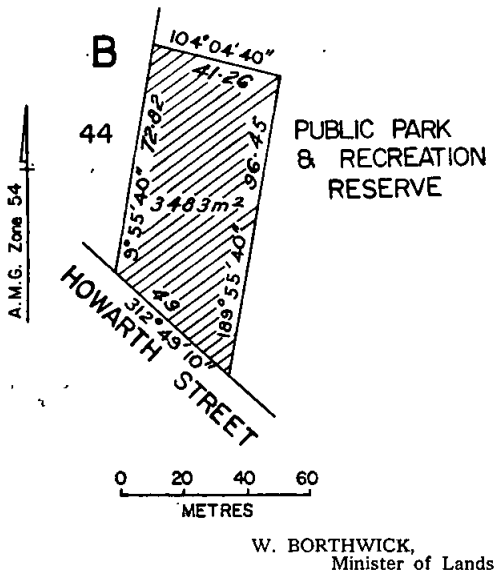

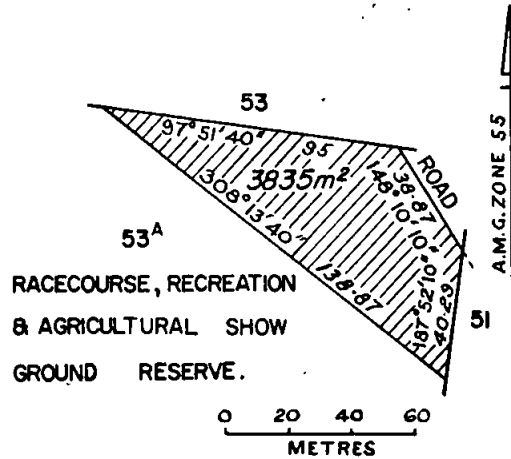
