## ACTS OF PARLIAMENT

### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia. &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 9084. "An Act to amend section 8 of the *Aerial Spraying Control Act 1966*." (*Aerial Spraying Control (Amendment) Act 1978*.)
- No. 9085. "An Act to repeal the *Dairy Products Act 1958* and for other purposes." (*Dairy Products (Repeal) Act 1978*.)
- No. 9086. "An Act to deem section 2 of the *Gas and Fuel Corporation (Borrowing Powers) Act 1976* to have come into operation on the 7th day of December, 1976, and for other purposes." (*Gas and Fuel Corporation (Borrowing Powers Amendment) Act 1978*.)
- No. 9087. "An Act to amend section 94 of the *Constitution Act 1975* to increase the Amount Payable out of the Consolidated Fund for the Clerk and Expenses of the Executive Council." (*Constitution Act 1978*.)
- No. 9088. "An Act to amend the *Marine Act 1958* with respect to Licences to act as Pilots for Port Phillip, charges payable by the Masters of Ships and other Matters." (*Marine (Amendment) Act 1978*.)

- No. 9089. "An Act to amend section 11 of the *Architects Act 1958* with respect to the Penalties which may be imposed on Persons who are guilty of Offences relating to the Professional Conduct of Architects." (*Architects (Professional Conduct) Act 1978*.)

- No. 9090. "An Act to amend the *Victorian Film Corporation Act 1976* to make Provision for and with respect to Committees." (*Victorian Film Corporation (Amendment) Act 1978*.)
