ACTS OF PARLIAMENT

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 9125. "An Act to amend the *Superannuation Act 1958* in relation to the Classifications of Contributors and for other purposes." (*Superannuation (Amendment) Act 1978.*)
- No. 9126. "An Act to establish a Department of State Development Decentralization and Tourism, to repeal the *State Development Act 1970* and for other purposes." (*State Development Decentralization and Tourism Act 1978.*)
- No. 9127. "An Act to amend the *Melbourne Harbor Trust Act 1958* to increase the Borrowing Powers of the Melbourne Harbor Trust Commissioners and to make further Provision with respect to Financial Accommodation." (*Melbourne Harbor Trust (Borrowing Powers) Act 1978.*)
- No. 9128. "An Act to amend the *Cluster Titles Act 1974*, the *Transfer of Land Act 1958* and the *Sale of Land Act 1962* and for other purposes." (*Cluster Titles (Amendment) Act 1978.*)
- No. 9129. "An Act to amend the *Victoria Conservation Trust Act 1972*, to amend the *Local Government Act 1958*, and for other purposes." (*Victoria Conservation Trust Act 1978.*)
- No. 9130. "An Act to amend section 280 of the *Melbourne and Metropolitan Board of Works Act 1958* and for other purposes." (*Melbourne and Metropolitan Board of Works (Rate Exemption) Act 1978.*)

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by an Act of Parliament of the State of Victoria passed in the twenty-seventh year of the reign of Her Majesty Elizabeth the Second, Queen of Australia, entitled the *State Development Decentralization and Tourism Act 1978, No. 9126*, it is provided by sub-section 2 of section 1 that the several provisions of the said Act shall come into operation on a day to be fixed by Proclamation of the Governor in Council published in the *Government Gazette*.

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State do by this Proclamation fix the Twenty-third day of May, One thousand nine hundred and seventy-eight, as the day on which the whole of the said *State Development Decentralization and Tourism Act 1978, No. 9126*, shall come into operation.
