PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by the Weights and Measures Act 1958, section 44, it is amongst other things enacted that the Governor in Council may at the request of two or more municipalities declare such municipalities to be a Union for the purposes of the said Act.

Now therefore, I, the Governor of the State of Victoria by and with the advice of the Executive Council of the said State and in pursuance of the powers conferred by the Weights and Measures Act 1958 and at the request of the

Councils of the Shires of Daylesford and Glenlyon, Creswick and Grenville do by this my proclamation declare the Shires of Daylesford and Glenlyon, Creswick and Grenville to be a Union for the purposes of the said Act under the title of "Shires of Daylesford and Glenlyon, Creswick and Grenville Weights and Measures Union" on and from 1 February 1980, and do further declare that the apportionment among such municipalities of the expenses devolving on such Union under the said Act shall be as follows:—

Shire of Daylesford and Glenlyon

60 per centum

Shire of Creswick Shire of Grenville 20 per centum 20 per centum

Vermin and Noxious Weeds Act 1958 PROCLAMATION AMENDED

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c. &c. &c.

Whereas pursuant to the provisions of section 3 (1) of the Vermin and Noxious Weeds Act 1958, Rabbits, Hares, Foxes, Dingoes, Wild Dogs, Dogs Run Wild, Pigs Run Wild, Wombats, Sparrows and Starlings were declared to be vermin throughout the State of Victoria for the purposes of the said Act, by Proclamation dated 17 July 1973 (see Government Gazette of 25 July 1973, page 2654).

And whereas the said Proclamation dated 17 July 1973 was revoked as to part by Proclamation dated 23 August 1977 (see Government Gazette of 31 August 1977, page 2774) so far only as it related to Wombats in respect of only the area of the State described therein.

Now, therefore, I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, pursuant to the provisions of section 3 (2) (c) of the said Act, do by this Proclamation amend the Proclamation of 17 July 1973 by substituting for the expression "Dingoes, Wild Dogs" the expression "Dingoes and their hybrids (except for recognized canine breeds such as the Australian Cattle Dog (Queensland Heeler) and the Australian Kelpie), Feral Dogs"

This Proclamation is made in lieu of the Proclamation made under the said Act on 11 December 1979 published in the Government Gazette No. 104 dated 19 December 1979 on page 3951, which is hereby rescinded.


