- (g) Prohibiting or regulating the soliciting or collection in any road or street or from house to house adjacent thereto of gifts of money or of subscriptions for any





PRIVATE ADVERTISEMENTS—Advertisements will be received by the Government Printer not later than the day preceding publication—at ordinary rates at or before one p.m. and at double rates between one p.m. and HALF PAST THREE p.m. The charge for Advertisements is 78 cents per line single column and \$1.56 per line double column. The charge for a full page is \$118. The title forms one or more lines as a heading. On an average ten words make a line of single column. Every signature must likewise be counted as a line. The final words of a paragraph though only portion of a line, must be counted as one line. Signatures (in particular) and proper names must be written very clearly in the text; ONE SIDE ONLY of each sheet of paper should be written upon.
