2. (1) Section 9 of the *Companies (Acquisition of Shares) (Application of Laws) Act 1981, No. 9564* is amended as from 1 October 1981 by Regulations made under Section 16 of that Act on 15 September 1981 No. 417.

(2) The *Companies (Acquisition of Shares) (Victoria) Code* is amended as from 1 October 1981 in accordance with the provisions of Part II of the *Commonwealth Companies (Acquisition of Shares) Amendment Act (No. 2) 1981* by reason of the operation of Section 4 of the *Companies (Acquisition of Shares) (Application of Laws) Act 1981*.

3. (1) Section 8 of the *Securities Industry (Application of Laws) Act 1981, No. 9562* is amended as from 1 October 1981 by Regulation 4 of the Regulations made under Section 15 of that Act on 15 September 1981 No. 416.

(2) Schedule 1 to the *Securities Industry (Application of Laws) Act 1981* is amended as from 1 October 1981 by Regulations made under Section 15 of that Act on 15 September 1981 No. 416.

(3) The *Securities Industry (Victoria) Code* is amended as from 1 October 1981—

- (a) in accordance with the provisions of Part II of the *Commonwealth Securities Industry Amendment Act (No. 2) 1981* by reason of the operation of Section 6 of the *Securities Industry (Application of Laws) Act 1981*; and
- (b) in accordance with the provisions of Regulation 5 of the Regulations referred to in sub-clause (2) above.
