



(No. 1of 1983)

Notice is hereby given that appeals to the Industrial Relations Commission of Victoria have been lodged against the reasons of the Chairman of the Mining Engine Drivers Conciliation and Arbitration Board in approving a resolution of the Board of 21 February 1983

The terms of the resolution approved by the Chairman is as follows:

"The Award be varied by the inclusion of certain classifications and wage rates as contained in the Factory Engine Drivers Award and the minutes of the Board the same day."

Section 16 (3) of the *Industrial Relations Act* 1979 provides that when an appeal is brought under this section the award or part of the award appealed against shall be deemed not to have come into operation until the appeal has been dealt with by the Commission.

## WATER RESTRICTIONS

Whereas the supply of water available to the Kilmore and District Waterworks Trust, an Authority constituted under the Water Act 1958, has fallen short of the quantity required to supply all entitlements proportionately in sufficient quantity to be of practical service; and

- 2. Occupiers of other than private residential properties shall be entitled to use a maximum quantity in accordance with the nature of occupation of such property as specified hereunder:-







# REGULATIONS "PENGUIN RESERVE" AND COASTAL RESERVES—PARISH OF PHILLIP ISLAND

I, Roderick Alexander Mackenzie, Her Majesty's Minister of Lands in and for the State of Victoria, in pursuance of the powers conferred on me by Section 13 of the Crown Land (Reserves) Act 1978 do hereby make the following Regulations for or with respect to the reserved Crown Lands in the Parish of Phillip Island shown coloured red on plan marked "P.I./9.9.82" attached to Department of Crown Lands and Survey correspondence No. Rs.7419 together with the land in the said Parish temporarily reserved for Conservation of Wildlife and Public Recreation by Order in Council of 23 November 1982 (vide Government Gazette dated 24 November 1982) and hereinafter referred to as the "Reserve".

The Reserve has been placed under the control of a Committee of Management (hereinafter referred to as the "Committee") with full power and authority to enforce these Regulations.

#### REGULATIONS

1. Summerland Beach being portion of the Reserve, shall be open to the public free of charge from 7.30 a.m. to 6.00 p.m., except during the months of May, June, July and August of each year when the said beach shall be open to the public free of charge from 7.30 a.m. to 4.00 p.m.

After the hours of 4 p.m. or 6 p.m. (as the case may be) admission charges as set out hereunder will be made and taken by any person authorized by the Committee to collect such admission charges.

- 2. A charge will be made for admission to the theatrette on the Reserve and will be taken by any person authorized by the Committee to collect such admission charge which shall be one (1) dollar for all adults and children fourteen (14) years and over and fifty (50) cents for all children from the age of ten (10) and up to fourteen (14) years.
- 3. No person shall remain in the Reserve at any time when lawfully directed to leave the same by any member or authorized officer of the Committee or by any member of the Police Force or by any Balliff of Crown lands.
- 4. No person, except any member of the Committee, or any employee or authorized officer of the Committee on duty, shall enter any portion of the Reserve for which an admission charge is payable without first paying the said fee, unless otherwise authorized by the Committee.
- Every person holding any receipt or permission issued in writing by the Committee shall make the receipt or permission available for inspection at all times.
- 6. No person shall in any part of the Reserve obstruct, disturb, interrupt or annoy any other person in the proper use of the Reserve, or obstruct or neglect to obey the lawful direction of any member or authorized officer of the Committee. Any person found in a state of intoxication or behaving in a disorderly manner or using obscene language or taking part in any disturbance shall be liable to be removed from the Reserve forthwith in addition to any other penalty to which such person may be liable.
- 7. All other persons entering the Reserve shall at all times remain on or in tracks, viewing stands or buildings or other areas, specifically provided and designated as being for public access or use.
  - 8. No person shall:
  - (a) bathe from the Reserve unless decently attired in a suitable bathing costume;
  - (b) erect any bathing box, boatshed, fence or other structure on the Reserve;
  - (c) use in any part of the Reserve a beach umbrella or similar device for providing shade or protection unless it shall be securely anchored;
    - (i) by means of a disc of weatherproof plywood at least 30 centimetres in diameter fitted over the shaft immediately above the tip and the disc buried in the sand to a depth of at least 30 centimetres, or
    - (ii) by means of a bag filled with at least 5 kilograms dry weight of sand securely tied to the shaft at sand level;
  - (d) damage, disfigure, climb upon or jump over any fences, seats, buildings or other structures, or use, displace, play

with or damage any life saving appliance or signal bell provided by the Committee for use in or adjacent to the Reserve unless such use or displacement shall be necessary for the purpose of saving life or of assisting a person in difficulties;

- (e) deposit or cause to be deposited any paper, bottles, fruit skins, food or other litter or refuse in or upon the Reserve except in receptacles provided for that purpose by the Committee, or wilfully or negligently deposit or leave anywhere in the Reserve any rubbish, bricks, manure, timber or other substances or materials.
- (f) break any glass of any kind in the Reserve, or leave thereon any substance likely to cause injury to any person;
- (g) brawl, fight or use indecent language, or make or cause to be made any violent outery, noise, disturbance, or sound, or act in any indecent, disorderly or offensive manner, or commit any nuisance in the Reserve or the property thereon;
- (h) bathe or wash clothes or other articles in any pond or other water in the Reserve.
- 9. No person shall without the consent in writing of the Committee or an authorized officer of the Committee:
  - (a) permit any animal belonging to him or in his charge to enter upon the Reserve. Any dog or cat found on or in the Reserve shall be liable to be destroyed;
  - (b) cut, pluck, injure or destroy any tree, shrub, grass, bush, plant or flower growing on the Reserve, or trap any bird, or lay or place any trap for the taking of birds, or take away birds eggs or nests or shoot or disturb any animal therein;
  - (c) dig, cut or remove any turf, sod, loam, sand, gravel, shell-grit or other substance in, on or from the Reserve;
  - (d) bring or place any motor vehicle or motorcycle on the Reserve except in a parking area which may be set aside by the Committee;
  - (e) enter upon any enclosure or play upon any part of the Reserve set apart or enclosed for the plantation of trees, shrubs, grass, flowers or other vegetation;
  - (f) enter upon any portion of the Reserve designated as a penguin breeding area or other prohibited area;
  - (g) carry, fire or discharge any gun, pistol or other firearm in or upon or over the Reserve, or throw or cause to be thrown any fireworks, stones, sand or other missiles;
  - (h) distribute, exhibit, hawk or offer for sale any goods or articles of any description in the Reserve, or sell or let for hire any article, place, seat or chair;
  - (i) play or perform in any band of music, or deliver or read any public speech, lecture, prayer, sermon or address of any kind, or use any loud hailer, either hand held or attached to a vehicle, or any loud speaker, or play any radio or tape other than in a vehicle, or enter into any public discussion, or hold or take part in any public assemblage on the Reserve:
  - (j) solicit or gather money on other thing in the Reserve;
  - (k) give out or distribute any handbill, placard, notice, advertisement, book, pamphlet or paper in the Reserve;
  - play cricket, football, hockey, handball, rounders, baseball, golf, tennis or other athletic games or sports except in portions of the Reserve set aside for such purposes;
  - (m) use any boat on inland waters within the Reserve;
  - (n) post or paint any bill, placard or notice in the Reserve or on any fence, building, structure or tree therein, or paint, write, carve or in any manner inscribe letters, figures or marks upon or otherwise disfigure any rock or any wall or other structure in the Reserve;
  - (o) use any flashlight, spotlight or torch in areas where such use is prohibited;
  - (p) light a fire on the Reserve, except in fireplaces specially provided by the Committee or in suitable receptacles provided by the user at places set apart for picnickers, and any person who lights a fire in the Reserve shall take all necessary precautions to ensure that the fire does not escape from control, nor shall any person wilfully, carelessly or negligently light any fire or do any act which may cause or be likely to cause damage by fire to anything growing, living or constructed on the Reserve;
  - (q) camp on or use as a camp or for the purposes of camping any portion of the Reserve.
- 10. Any person committing any breach of these Regulations who refuses to state his name and address to any member or authorized

officer of the Committee or any Bailiff of Crown lands or who in the opinion of such member or authorized officer or Bailiff of Crown lands states a false name or address shall be guilty of an offence under these Regulations.

- 11. Notwithstanding the provisions of any Regulation under this section for the time being in force controlling buildings, structures, works or improvements on such lands, no further buildings or structures are to be erected or works or improvements undertaken on such lands without the approval of the Minister of Lands first had and obtained.
- 12. The foregoing Regulations shall not restrict any Bailiff of Crown lands or any member of the Committee or any employee, authorized officer or agent of the Committee in the proper execution of their duty or work in or on the Reserve.

These Regulations are made in lieu of all previous Regulations made for or with respect to the Reserve, which are hereby rescinded—(Rs 7419).

## DIAMOND CREEK PUBLIC RECREATION RESERVE

GREENWOOD DRIVE PUBLIC PARK

   "Committee" means the Corporation of the Shire of Diamond Valley.
- "Motor Vehicle" means any vehicle or unit propelled or operated by internal combustion, steam, gas, oil, electricity or any other power but does not include a motor cycle.
- "Motor Cycle" means any vehicle or unit propelled or operated by internal combustion, steam, gas, oil, electricity or any other power other than a motor vehicle.
- 2. No person shall interfere with any tree, shrub, grass, flower, statuary, fountain, fish or any property in the Reserves, or throw any stone or missile, or beat carpets or dry clothes, or commit any nuisance in the Reserves or leave therein bottles or any litter except in a receptacle provided for such purpose.
- 3. No person shall light a fire in the Reserves except in a receptacle provided by the Committee for such purpose and then only in accordance with such Regulations, orders or restrictions made or issued from time to time by either the Country Fire Authority, the Metropolitan Fire Brigade or by any Government or other authority.
- 4. No person shall stick bills on any building, fence, gate, post or tree in the Reserves or cut letters or marks on any tree, seat, gate, post, fence or wall of any buildings therein or otherwise deface the same or write thereon.
- 5. No person shall bring into the Reserves any horse, motor vehicle or motor cycle for any purpose whatsoever which may create a nuisance to pedestrians, or cause damage to the Reserves, or enter plots of ground therein closed for plantation or other purposes.
- 6. No person shall bring into the Reserves any dog, unless led by a chain or cord and any dog, except as hereinbefore provided, or any goat, pig or poultry found in the Reserves shall be liable to be destroyed and the owner shall make compensation to be recovered before any Justice, for any damage done to property under the control of the Committee.
- 7. Any person found in a state of intoxication or behaving in a disorderly or objectionable manner, or creating or taking part in any disturbance, or committing any act of indecency in the Reserves

shall be liable to be forthwith removed by any authorised Officer or servant of the Committee, or by a member of the Victoria Police Force or by a Bailiff of Crown Lands and shall be guilty of an offence against these Regulations.

- 8. No person shall carry any firearm in or through the Reserves or shoot, snare or destroy any bird therein unless by authority of the Committee.
- No person shall play any unlawful game or make any wager for money or, by unseemly conduct, interfere with the comfort and enjoyment of others within the Reserves.
- 10. No person shall interfere with or in any way hinder or interrupt in their work any of the employees of the Committee engaged in the Reserves by conversation or otherwise.
- 11. No person shall sell or offer for sale within the Reserves any article of food or drink or any other commodity or operate any money-making amusement.
- 12. No person shall remain in the Reserves at any time when lawfully directed by any Officer or employee of the Committee, a Bailiff of Crown Lands or a member of the Victoria Police Force, to leave the same.
- 13. No person shall spit or expectorate on the paths or on any structure or erection in the Reserves.
- 14. The foregoing Regulations shall not restrict any servant, agent, representative or workman of the Committee in the proper execution of their duty or work in the Reserves (Rs1309, Rs10556).
