DATE OF COMING INTO OPERATION

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by an Act of Parliament of the State of Victoria passed in the thirty-second year of the reign of Her Majesty Elizabeth the Second, Queen of Australia, entitled the *Estate Agents (Reconstitution) Act 1983, No. 9925*, it is amongst other things enacted that the Act shall come into operation on a day to be fixed by Proclamation of the Governor in Council published in the *Government Gazette*.

Now therefore, I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation fix Tuesday, 12 July 1983, as the day upon which the said *Estate Agents (Reconstitution) Act 1983, No. 9925*, shall come into operation.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twelfth day of July, in the year of our Lord One thousand nine hundred and eighty-three, and in the thirty-second year of the reign of Her Majesty Elizabeth the Second, Queen of Australia.
