Court for the purposes of the enforcement in Victoria of a fine payable under a conviction or area of that Court against a body corporate in Victoria.

#### COUNTRY FIRE AUTHORITY ACT 1958

##### PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

In the Thirteenth Fire Control Region:

1. Healesville Urban Fire District Commencing at the intersection of the Lilydale-Healesville railway line and the south eastern corner of Crown Allotment 10, Parish of Tarrawarra, thence north westerly and north easterly to the Healesville-Yarra Glen Road, thence easterly and north easterly along the Healesville-Yarra Glen Road to the Chum Creek Road intersection, thence northerly along Chum Creek Road to the intersection of Ryans Road, thence easterly along the northern boundary of Crown Allotment 3A to the western boundary of Crown Allotment 46A 3, thence northerly along the western boundary of Crown Allotment 46A3 and easterly along the northern boundary of Crown Allotment 46A3 to its intersection with the western boundary of Crown Allotment 14A, thence north westerly along the western boundary of Crown Allotment 14A and north easterly along the northern boundary of Crown Allotment 14A to the western boundary of Crown Allotment 17A, thence north westerly along the western boundary of Crown Allotment 17A and north easterly along the northern boundary of Crown Allotment 17A to a line which is the continuation of the western alignment of Crown

Allotment 46B, thence northerly along the western boundary of Crown Allotment 46B to New Chum Creek, thence easterly by New Chum Creek to its intersection with Crown Allotment 47A, thence northerly along the western boundary of Crown Allotment 47A to the southern boundary of Crown Allotment 73D, thence westerly along the southern boundary of Crown Allotment 73D, thence westerly along the southern boundary of Crown Allotment 73D to Lowes Road, thence generally northerly along Lowes Road to the north western corner of Crown Allotment 70, Parish of Tarrawarra North, thence easterly along the northern boundary of Crown Allotment 70 to Myers Creek, thence south easterly along Myers Creek to the north western corner of Crown Allotment 23, Parish of Monda, thence easterly along the northern boundary of Crown Allotment 23, thence generally southerly along the eastern boundaries of Crown Allotments 23, 22, 21, 20, 14, 15 and 16 to the northern corner of Crown Allotment 7, thence easterly along the northern boundaries of Crown Allotment 7 and 19 to the north eastern corner of Crown Allotment 19, thence southerly along the eastern boundary of Crown Allotments 19 and 18 to the north western corner of Crown Allotment A4, thence easterly along the northern boundary of Crown Allotment A4 and southerly along the eastern boundary of Crown Allotment A4 to the most northerly part of the boundary of Crown Allotment A2 and the Watts River, thence generally south easterly along Watts River to the north eastern corner of Crown Allotment A, thence southerly along the eastern boundary of Crown Allotment A to the Maroondah Highway, thence easterly along the Maroondah Highway to the intersection of the north eastern corner of Crown Allotment 35, thence south easterly by the eastern boundary of Crown Allotment 35 to Graceburn Creek, thence westerly along Graceburn Creek to the north eastern corner of Crown Allotment 1, thence southerly along the eastern boundary of Crown Allotment 1 to Mount Riddell Road, thence westerly along Mount Riddell Road to Romeo Road, thence southerly by Romeo Road to Donald Road, thence westerly along Donald Road to the north eastern corner of Crown Allotment 14, thence southerly along the eastern boundary of Crown Allotment 14, thence westerly along the southern boundary of Crown Allotments 14 and 13 to Don Road, thence south easterly along Don Road to Toora Crescent, then south westerly, westerly and south westerly along Toora Crescent to Badger Creek Road; thence south easterly along Badger Creek Road to the south eastern corner of Crown Allotment 124; thence south westerly along the southern boundary of Crown Allotment 124 to the eastern boundary of Crown Allotment 123, thence southerly to the southern boundary of Crown Allotment 123, thence south westerly along the southern boundaries of Crown Allotments 123, 122, 121 and 120, thence north westerly along the southern boundary of Crown Allotment 120 to Albert Road, thence westerly along Albert Road to the Healesville-Koo Wee Rup Road, thence northerly along the Healesville-Koo Wee Rup Road to the south eastern corner of crown Allotment 162, thence south westerly along the southern boundary of Crown Allotment 162 to the Yarra River, thence northerly and westerly along the Yarra River to the road reserve

on the eastern side of Crown Allotment 12, thence generally northerly along the eastern boundary of Crown Allotment 12 to the commencement point on the Lilydale-Healesville railway line.

##### Fixing Fees for Connections to the Commission's Water Supply System

The Rural Water Commission, in pursuance and exercise of powers conferred by the Water Act, does hereby make the following By-law:

1. By-law No. 5970 is hereby revoked from 1 December 1985.

2. This By-law shall apply to and have force in the Millewa and Otway Rural Districts, the Carwarp, Dingee, Eastern Mallee, Koondrook, Macorna, Meringur, Mitiamo, Mornington Peninsula, Murrabit, Northern Mallee, Nyah, Nyah West, Otway, Piangil, Pyramid Hill, Southern Mallee, Southern Wimmera, Tallygaroopna, Werrimul and Western Wimmera Urban Districts, the Urban Districts supplied with water from the Coliban System of Waterworks, and the Mornington Peninsula and Otway Waterworks Districts.

3. As on and from 1 December 1985, fees for connections to the Commission's water supply systems in the beforementioned districts shall be calculated as follows using the component charges set out in Clause 4:

- (a) for new connections—the fee shall be the sum of the Tapping Charge and Meter Charge for the size connection;
- (b) for a connection replacing an existing connection of like or larger size—the fee shall be the Tapping Charge for the new connection size; and
- (c) for a connection replacing an existing connection of smaller size the fee shall be the sum of the Tapping Charge for the new connection and the difference in Meter Charges for the new and existing meter sizes.

4. The component charges to be used to calculate the connection fee are as follows:

- (a) for connections to rated or rateable properties within Urban and Rural Districts and for supplies by agreement from pipelines 300 mm or less in diameter where the tapping requires only standard tapping fittings.
  - (i) where the work is performed by the Commission—

- (ii) where it is not possible for the work to be performed by the Commission and permission is granted to a plumber to perform the work—

The Tapping Charge shall be \$5.00 plus the cost of any materials supplied other than the meter and the Meter Charge shall be as in (i) above.

- (b) for connection to properties supplied by agreement, from pipeline and aqueducts the Tapping Charge shall be the actual cost regardless of tapping size and the Meter Charge shall be as in (a) (ii) above, except where the pipeline is of 300 mm diameter or less, and the connection requires only a standard tapping saddle and ferrule cock.

5. Such person or persons as the Rural Water Commission may from time to time appoint for that purpose shall be and is or are hereby authorized to demand, receive, collect, and recover the said fees.
