

# SILVAN NO. 1 GROUP CONSERVATION AREA (PROPOSED)

Notice is hereby given that I, Joan Elizabeth Kirner, Her Majesty's Minister for Conservation, Forests and Lands for the State of Victoria, has received a joint recommendation from the Yarra Soil Conservation District Advisory Committee and the Soil Conservation Authority "that the area identified in Drawing No. L96 and to be known as Silvan No. 1 Group Conservation Area (GA/142) be constituted as a group conservation area in the public interest, under powers conferred by Division IA, section 24D of the Soil Conservation and Land Utilization Act 1958 (No. 6372)".



## CITY OF BERWICK

By-Law No. 14

Meetings Procedure By-Law

A By-Law of the City of Berwick made under section 197 of the *Local Government Act* 1958 and numbered 14 for the purposes of regulating proceedings of Council Meetings, Committee Meetings, and other Meetings conducted by the City of Berwick and for other purposes.

In pursuance of the powers conferred by the *Local Government Act* 1958 and of any and every other power it thereunto enabling the Mayor, Councillors and Citizens of the City of Berwick orders as follows:

#### 1. Short Title

This By-Law may be known as the Meetings Procedure By-Law.

By-Law No. 1 of the City of Berwick is hereby repealed.

#### 2. Rules of Parliament

In all cases not herein provided for, resort shall be had to the rules, forms and useages of Parliament of the State of Victoria which shall be followed as far as the same are applicable to the proceedings of the Council.

#### 3 Minutes

- 3.1 Minutes of the proceedings of Council shall be kept under the direction of the Town Clerk in sufficient detail to accurately record the events which took place at any meeting of Council.
- 3.2 Without affecting the generality of the foregoing clause the minutes shall record:
  - the date, place, time and nature of the meeting, the names of Councillors present
  - arrivals and departures of Councillors (including temporary departures) during the course of the meeting
  - all motions and amendments moved and seconded (including motions and amendments which lapse for want of a seconder) and whether they were carried or lost
  - where a division is called for, the names of Councillors voting for and against the motion or amendment
  - at the request of any Councillor whether that Councillor voted for or against any motion or amendment.
- 3.3 The Minutes shall be entered in a book to be provided for the purpose which shall be kept by the Town Clerk under the superintendence of the Council.
- 3.4 The Minutes of an Ordinary Meeting and where practicable the Minutes of a Special Meeting shall be confirmed at the next Ordinary Meeting of the Council and such Minutes after confirmation by the Council shall be signed by the Chairman of such next Ordinary Meeting.
- 3.5 A Copy of the Minutes shall be delivered or posted to every Councillor not later than 48 hours before the time fixed for the meeting at which the Minutes are to be confirmed. Provided that this clause shall not apply in respect to any Councillor who has been granted leave of absence pursuant to section 59 (1) g of the Local Government Act and who has not requested the Municipal Clerk in writing to continue to give notice of meetings to be held during the period of leave of absence.
- 3.6 If a copy of the Minutes of such preceding meeting has not been so delivered or posted and if it is the wish of the Council, the reading of and the putting of a question and confirmation of such Minutes may be taken.

- 3.7 The said Minutes shall be taken as read and no discussion thereon shall be permitted except as to their accuracy as a record of the proceedings of the Council meeting to which they relate.
- 4. Order of Business
- 4.1 The order of business of an Ordinary Meeting shall be as follows or as near thereto as may be practicable but for the greater convenience of the Council at any particular Meeting thereof it may be altered by resolution to that effect—
  - 4.2 Apologies.
- 4.3 Confirmation of Minutes.
- 4.4 Resumption of debate on motions or other business lapsed at the previous meeting.
  - 4.5 Question Time-Councillors.
- 4.6 Inward Correspondence—considering and ordering thereon.
- 4.7 Reports of Committees.
- 4.8 Officers Reports.
- 4.9 Motions without Notice relating to Ordinary Business.
- 4.10 Approval of Outward Correspondence.
- 4.11 Extraordinary Business not elsewhere included.
- 4.12 Petitions.
- 4.13 Orders of the Day.
- 4.14 Notices of Motion.
- 4.15 Questions from the Gallery shall be taken at 9.00 p.m. at all Ordinary Council Meetings or at a time directed by the Chairman.
- 4.16 The order of business at Statutory and Special Meetings shall be the order in which such business stands in the notice thereof unless altered by resolution of Council.
- 5. Correspondence and Officers' Reports
- 5.1 A copy of the agenda of business together with a copy of all reports to be considered at any ordinary meeting shall be posted or delivered to every Councillor not later than two clear days before the time fixed for the holding of the meeting.
- 5.2 Correspondence received by the City shall be opened by the Town Clerk or an officer appointed by him.
- 5.3 The Town Clerk shall determine what inward correspondence should be placed before Council for its decision and shall list the same in the notice paper.
- 5.4 The Town Clerk shall select such items of outward correspondence as he considers necessary to bring to the attention of the Council and shall list the same in the notice paper.
- 5.5 Correspondence addressed to any Councillor personally which requires a decision or direction of Council shall be referred by the Councillor receiving the same to the Town Clerk who shall include it in the inward correspondence referred to in Clause 5.2 above.

5.6 No correspondence, Officers' Reports or Committee Reports need be read in full at any meeting unless the Council requests that any particular item or items be so read.

#### 6. Committees

- 6.1 The Town Clerk shall convene a Meeting of any Committee within thirty days of its first appointment, and every meeting thereafter shall be convened by order of Council, the Committee, or on the written order of the Chairman of the Committee or of any two members of the Committee or the Town Clerk.
- 6.2 Every Committee so appointed may meet from time to time and may adjourn from place to place as the Council or Committee directs.
- 6.3 A Committee shall appoint one of its members to be its Chairman, and may appoint one of its members to be Deputy Chairman and may from time to time replace its Chairman or Deputy Chairman or appoint an Acting Chairman.
- 6.4 The Deputy Chairman shall take the Chair at the Committee Meeting in the absence of the Chairman, or at the Chairman's request.
- 6.5 Except when a casting vote is used every question at a Committee Meeting shall be determined by a majority of the votes of the members present.
- 6.6 Minutes shall be kept of the proceedings of any Committee.
- 6.7 All Committees may report to the Council and such reports may contain recommendations to the Council and shall be signed by the Chairman of the Committee.
- 6.8 Unless otherwise directed by the Committee, the Town Clerk shall circulate Committee Minutes instead of Committee Reports.
- 6.9 If minutes are delivered pursuant to the preceding clause the resolutions set out in them shall be treated as the Committee's recommendations to the Council and shall hereinafter be referred to as the report of the Committee.
- 6.10 The Town Clerk shall cause a copy of all reports or minutes of Committees to be included in the Agenda for the Meetings of the Council at which such reports or minutes are to be presented.
- 6.11 When the report or minutes are reached on the Agenda the Chairman shall ask if any Councillor objects to any recommendation thereon.
- 6.12 Should there be no such objection the Chairman shall call for a motion for the adoption of the Report or minutes.
- 6.13 In the event that any Councillor shall object to the adoption of any part of the Committee's Report or minutes then:
- 6.14 The Chairman shall call for a Motion adopting those items in the report against which no objection has been taken following which:

- The Councillor objecting shall state the item or items of the report or minutes to which he objects.
- (ii) Each such item objected to shall be considered separately in the order in which it appears in the report or minutes.
- (iii) The Councillor objecting shall have the right to move a motion relating to the recommendations objected to without speaking to his motion.
- (iv) The Seconder of such Motion shall not speak to it.
- (v) The Mover and Seconder of such Motion may thereupon speak to their Motion.
- (vi) The Motion is then open to debate, and shall be resolved according to the provisions of this By-Law.
- 6.15 Upon the adoption of a report or minutes by the Council, each recommendation contained in the report or minutes as adopted shall be treated in law as being a resolution of the Council.

## 7. Motions

- 7.1 No Councillor shall propose any Motion or shall speak to any Motion or other matter until given the Call by the Chairman of the Meeting.
- 7.2 Any Councillor desirious of proposing a motion or amendment or taking part in discussion thereon shall stand, address the Chairman, and shall proceed upon being given the call by the Chairman, and shall not be interrupted except by the Chairman or upon a point of order. If a Councillor is interrupted by the Chairman or upon a point of order, he shall resume his seat until the Chairman has ceased speaking or the point of order has been disposed of.
- 7.3 A Motion or amendment shall be relevant to an item of business properly before the Council.
- 7.4 No Motion or amendment shall be defamatory or objectionable in language or nature.
- 7.5 Every Motion shall be so worded that the meaning is clear.
- 7.6 At every meeting of the Council all Motions whether original Motions or amendments shall, if requested by the Chairman, be reduced into writing signed by the mover and shall be delivered to the Chairman at such time as he may direct.
- 7.7 No Motion or amendment shall be withdrawn without the consent of the majority of the whole number of members of the Council.
- 7.8 The procedure upon any Motion or amendment is:

the mover shall read it without speaking to it and shall shortly state its nature and intent;

the seconder shall say "I second it" with no more than a very brief explanation;

7.9 A Motion or amendment which is not seconded lapses.

7.10 If a motion or amendment is seconded: the Chairman shall ask—"Is the motion opposed?"; or "Is the amendment opposed?"; and

- if no Councillor indicates opposition it shall unless the Chairman permits further discussion be forthwith voted upon.
- 7.11 If any Councillor indicates opposition to a motion or amendment which has been seconded the mover shall address the Council upon it; the seconder shall speak to it; and it shall be open to debate.
- 7.12 No Councillor moving a motion shall speak to such motion for a period of more than five minutes.
- 7.13 No Councillor seconding a motion or amendment shall speak to such motion or amendment for a period of more than three minutes.
- 7.14 A Councillor, other than the mover of the motion, shall not speak to the motion or amendment before the meeting for a period of more than three minutes.
- 7.15 The mover of every original proposition in exercising his/her right of reply, in accordance with clause 7.18 of this By-Law, shall not speak for a period of more than three minutes.
- 7.16 No Councillor moving an amendment to the motion before the meeting shall speak to such amendment for a period of more than three minutes.
- 7.17 The time limits provided in the above proposals may be extended by resolution of Council. However, the speaker shall have no right to move a motion for an extension of time.
- 7.18 The mover of every original proposition at any Council Meeting but not of any amendment shall (if he has not spoken on any amendment to such original proposition) have a right to reply to be exercised at the conclusion of the debate (including debate on any such amendment) but save as aforesaid no Councillors shall be allowed to speak more than once on the same question unless permission be given to explain or unless for the purpose of calling the attention of the Chair to a point of order. For the purposes of this clause, a proposition shall be deemed to be an original proposition even though any amendment thereto has been carried.
- 7.19 In exercising his right of reply the mover of a motion shall not introduce new material and immediately at the end of a speech in reply, the Chairman shall put the question.
- 7.20 The mover of and amendment shall have no right of reply.
- 7.21 No Councillor shall speak a second time on the same question unless entitled to reply, or by leave of the Council, or with the approval of the Chairman, in explanation when he has been misrepresented or misunderstood.

- 7.22 A Councillor with permission of the Chairman shall have the right to ask for information on the subject before the meeting during the course of a debate.
- 7.23 A motion to the same effect as any motion which has been negatived by the Council shall not again be entertained within a period of three months except with the consent of a majority of the whole number of Members of the Council.
- 7.24 Should a majority of the number of members of Council present object to the debate of a Motion introduced without notice, the motion shall not be debated, but shall be placed on the notice paper of the Meeting of the Council next following.
- 7.25 No second or subsequent amendment, whether upon an original proposition or on a amendment, shall be taken into consideration until the previous amendment is disposed of.
- 7.26 If any words of an original question be rejected, the insertion of other proposed words shall form the next question, whereupon further amendments to insert other words may be moved.
- 7.27 If an amendment be negatived, then a second may be moved to the question to which the first-mentioned amendment was moved, but only one amendment shall be submitted to the Council for discussion at a time.
- 7.28 No Councillor who is the mover or seconder of a motion may move or second an amendment to such motion.
- 7.29 No Councillor may move or second more than one amendment to the same motion.
- 7.30 During the debate on an amendment, further amendments may be foreshadowed and shall be dealt with in the order they have been foreshadowed.
- 7.31 An amendment must not be a negation of the wording of the motion.
- 8. Voting
- 8.1 The Council shall vote by show of hands and any Councillor present and not voting, not being disabled by law from so doing, shall be guilty of an offence.
- 8.2 The Chairman shall in taking the sense of the Council put the question first in the affirmative, then in the negative, and the result thereof shall be recorded in the Minutes.
- 8.3 Any Councillors may before the Council moves into the next item of business demand a Division in which case the Councillors voting in the affirmative shall first stand and then those voting in the negative shall stand and the result shall be declared by the Chairman.
- 8.4 When a Division is demanded as aforesaid any vote already taken shall have no effect and the question shall be decided on the Division.
- 8.5 The Town Clerk shall record in the Minutes the names of the Councillors voting in the affirmative and those voting in the negative on a division.

- 9. Notice of Motion
- 9.1 All notices of motion shall be dated, and signed by the intending mover and given to the Town Clerk at least five days prior to the Meeting at which the intending mover wishes to propose such motion and on receipt of such notice of motion, the Town Clerk shall-

- (a) Number it
- (b) Date it
- (c) Enter it in the Notice of Motion Book kept for that purpose;

and shall give two clear days notice thereof to all Councillors.

- 9.2 Except by leave of the Council, motions shall be moved in the order in which they have been received and recorded by the Town Clerk in the Notice of Motion Book, and if not so moved or postponed shall be struck out.
- 9.3 If a Councillor who has given a notice of motion:
  - (a) is absent from the meeting; or
  - (b) fails to move the motion when called upon by the Chairman, any other Councillor may himself move the motion forthwith.

## 10. Formal Motions

- 10.1 The Formal Motions are-
- 10.2 Adjournment of the debate;
- 10.3 Adjournment of the Meeting;
- 10.4 The Closure;
- 10.5 Laying the question upon the table;
- 10.6 The Previous Question; and
- 10.7 Proceeding to the next business.
- 10.8 The "adjournment of the debate" or "of the meeting" may be moved as follows:

to a later hour on the same day;

to a later date; or

indefinitely.

- 10.9 No Councillor may move the adjournment if he has already moved, seconded or spoken to the motion or an any amendment of it.
  - 10.10 The adjournment shall not be moved-

During the election of a Chairman; or

While any Councillor is speaking.

- 10.11 No discussion shall be allowed on any motion for adjournment of the Council; but if on the question being put the motion be negatived, the subject then under consideration or the next on the notice paper shall be discussed, or any other that may be allowed precendence, before any subsequent motion for adjournment be made.
- 10.12 The "Closure" may be sufficiently moved as follows:

"That the question be now put."

The closure may be moved in respect of a motion or of an amendment.

No Councillor who has spoken to the motion then before the Council or to any amendment of it may move or second the closure.

If closure is carried, the motion or amendment in respect of which it is carried shall be put to the vote forthwith.

10.13 A motion to "Lay the question upon the table" may be moved as follows:

In respect of a motion or amendment or in respect of any document or question before the Council: and

By any Councillor who has not spoken to the matter in respect of which this motion is moved.

If this motion is carried in respect of-

a motion or amendment, neither the motion nor any amendment of it shall be further discussed or voted upon, until the Council resolves to take the motion or amendment from the table.

- 10.14 A document or question, shall not be further discussed or voted upon until the Council resolves to take the question from the table.
- 10.15 The "Previous Question" shall be moved as follows-

"That the question be now put."

the "previous question" shall not be moved-When any amendment is before the Council.

During the election of a Chairman, or

While any Councillor is speaking.

10.16 No Councillor who has spoken to the motion then before the Council or to any amendment of it may move or second the previous auestion.

If the previous question is carried the motion then before the Council cannot be further debated or voted upon at that Meeting.

If the previous question is not carried the motion then before the Council must be put to the vote forthwith without further amendment or discussion.

- 10.17 The previous question may be moved only by leave of the Chairman.
- 10.18 The motion to "proceed to the next." business" shall not be moved:

By any Councillor who has spoken to the motion then before the Council or to any amendment of it; or

While any Councillor is speaking;

The motion to proceed to the next business shall not be amended and shall be put to the vote immediately it is moved and seconded.

If the motion to proceed to the next business is carried in respect of an amendment the consideration of the motion then before the Council shall proceed wihout reference to that amendment.

If the motion to proceed to the next business is carried in respect of a motion, that motion cannot be further debated or voted upon at that meeting or any adjournment of it.

## 11. Conduct of Debate

- 11.1 The Councillors at meetings of Council shall designate each other by their official titles, namely that of Mayor, Chairman, Councillor or Officer as the case may require.
- 11.2 If two or more Councillors rise and address the Chair at the same time, the Chairman shall decide which Councillor shall first speak.
- 11.3 The Chairman shall rise when addressing the Council to discuss any question, and shall not leave the chair on such occassions.
- 11.4 No Councillor shall digress from the subjectmatter of the question under discussion, or comment upon the words used by any other Councillor in a previous debate; and all imputations of improper motives and all personal reflections on Councillors shall be deemed highly disorderly.
- 11.5 Whenever any Councillor makes use of any expression disorderly or capable of being applied offensively to any other Councillor, the Councillor so offending shall be required by the Chairman to withdraw the expression and shall to the satisfaction of the Council, apologize to the Chairman and Council.
- 11.6 Any Councillor using offensive or disorderly language and having been twice called to order or to withdraw or to apologise for such conduct and refusing so to do, shall be guilty of an offence.
- 11.7 Any Councillor may of right demand the production of any of the documents of the Council applying to the question under discussion.

## 12. Points of Order

12.1 A point of order shall be taken by stating—
The matter complained of; and

The reason constituting the point of order.

12.2 A Councillor may take a point of order by drawing the attention of the Chairman to—

The fact that a Councillor is out of order; or An Act of disorder notwithstanding that the Chairman or a Councillor is speaking at the time.

- 12.3 The Chairman may take a point of order although it has not been taken by any Councillor.
- 12.4 Rising to express a difference of opinion or to contradict a speaker shall not be treated as taking a point of order.
- 12.5 The Chairman may adjourn the Meeting to consider a point of order, but shall otherwise rule upon it as soon as it is taken.
- 12.6 The Chairman shall state the provision rule or practice which he deems applicable to the case without discussing or commenting on the same.

- 12.7 A personal explanation arising out of a statement at a Council Meeting shall be made immediately.
- 12.8 A personal explanation shall not be debated except upon a motion to censure the Councillor who has made it.

#### 13. Chairman's Ruling

13.1 A Councillor may move that the Chairman's ruling be disagreed with.

A motion under this clause:

- (a) shall specify the ruling to be substituted for the Chairman's ruling;
- (b) shall be considered in priority to any other business;
- (c) must be carried by a majority of the whole Council:
- (d) if carried shall be acted upon instead of the ruling given by the Chairman.

## 14. Councillor Called to Order

A Councillor called to order shall sit down unless permitted to explain by the Chairman of the Meeting

## 15. Question Time—Councillors

- 15.1 There shall be a question time at every ordinary meeting to enable Councillors to address questions to officers and/or Councillors but the provision of a question time shall not restrict the right of a Councillor to ask for information in the course of debate.
- 15.2 Questions may be asked with or without notice
- 15.3 A question upon notice shall be delivered to the Town Clerk by 4.00 p.m. on the day prior to any ordinary Council Meeting.
- 15.4 The Chairman may direct that an officer may reply in writing to any question without notice but any officer shall not be under a duty to answer a question without notice.
- 15.5 The Town Clerk shall, where necessary, cause a copy of the written answer to any question to be delivered to the Councillor who asked the question.
- 15.6 A question may be disallowed by the Chairman upon the ground that it:

Relates to a matter ultra vires the Council.

Is defamatory, disloyal, indecent, irreverant, abusive or objectionable in language or substance, or

Is trivial or is repetitive of a question already answered, whether at the same or any earlier meeting.

15.7 The time allotted to any one Councillor in question time shall not be more than 3 minutes and included in such time shall be the answer, unless the Chairman at his discretion otherwise directs.

- 15.8 The Chairman may direct that the answer to any question be taken in camera.
- 15.9 All questions and answers shall be as brief as possible and no discussion shall be allowed.
- 16 Question Time-Residents and/or Ratepayers
- 16.1 There shall be a question time at every ordinary meeting to enable residents and/or ratepayers to address questions to Councillors or Officers.
- 16.2 Questions must be presented in the following form:

Name of Persons Proposing Question

Address of Person Proposing Question

Question Directed to Councillor or Officer (Name of Councillor/ Officer)

16.3 The Town Clerk shall collect Question Papers at 8.45 p.m. or at a time directed by the Chairman.

. .

- 16.4 The Chairman has the right to refuse to deal with or withhold any question.
- 16.5 The Town Clerk shall read the Question and the Questioner shall stand in his place in the Gallery in order to identify himself during the reading of the question.
- 16.6 A Councillor who has been asked a Question may call on the Officer to assist in the answering of the Ouestion.
- 16.7 Any Councillor or Officer to whom a Question is directed shall have the right to reply at a subsequent Council Meeting or to forward a written reply to the person asking the question.

## 17. Petitions

- 17.1 No motion except that for receiving the same shall, unless under what the Council considers urgent circumstances, be made on any petition, memorial or other like application until the next ordinary meeting of the Council after that at which it has been presented.
- 17.2 It shall be incumbent on every Councillor presenting a petition to acquaint himself with the contents thereof, and to ascertain that it does not contain language disrespectful to the Council, and that the contents do not violate any By-Law or any provision hereof.

- 17.3 Every Councillor presenting a petition to the Council shall write his name at the beginning thereof.
- 17.4 Every petition presented to the Council shall be in writing (other than pencil) typing or printing and shall contain the prayer of the petitioners and shall be signed by at least one petitioner on every sheet on which it is written.
- 17.5 Every petition shall be signed by the persons whose names are appended thereto by their names or marks, and by no-one else except in cases of incapacity by sickness and the address of every signatory to the petition shall be clearly stated.
- 17.6 Every Councillor presenting a Petition to the Council shall confine himself to a statement of the persons from whom it comes, of the number of signatures attached to it, of the material allegations contained in it, and to the reading of the prayer thereof.

## 18. Deputations

- 18.1 A deputation wishing to be heard by the Council or a Council Committee shall make a written request to the Town Clerk not less than twenty-four hours prior to the latest time for delivering a Notice of Business.
- 18.2 A request for a deputation shall specify the name and address of a person authorized to receive notice on behalf of the deputation.
- 18.3 The Town Clerk shall inform the Chairman of the request for the deputation.
- 18.4 Unless otherwise directed by the Chairman or Council the Town Clerk shall list the hearing of the deputation on the next Ordinary Meeting or specified Council Committee Agenda.
- 18.5 If the deputation is listed for hearing the Town Clerk shall give to the person specified in the request written notice of the time, date and place of the meeting at which the deputation will be heard.
- 18.6 Nothing in this Clause shall prevent the Council from hearing a deputation at shorter notice as a matter of urgency.

## 19. Conduct of Visitors

- 19.1 Any person not being a Councillor who, having been admitted to any Meeting of the Council, is guilty thereat of any improper or disorderly conduct, or who does not leave when lawfully requested by the Chairman so to do, shall be deemed guilty of an offence.
- 19.2 Any such person who being lawfully requested by the Chairman to leave any such meeting may be forthwith removed; and any constable or peace officer or any persons requested by the Chairman so to do may remove such person.

## 20. Suspension of Standing Orders

20.1 Suspension of Standing Orders shall mean the suspension of the rules and regulations contained

4432

in this By-Law. Any one or more of the rules or regulations contained in this By-Law may be suspended for a particular purpose on Notice of Motion duly given and carried by a majority of the whole Council without Notice of Motion by a majority vote of not less than three-quarters of the Councillors at any duly convened Ordinary or Special Meeting of the Council. Such rules and regulations shall remain suspended until a further motion to "resume Standing Orders" is moved and carried.

#### 21. Council in Camera

21.1 At any Ordinary or Special Meeting of Council, any Councillor may move "That Council meet in Camera". If such motion is carried all members of the public and such Officers as the Council determines shall leave the Council Chamber, however, nothing in this sub-section shall prevent Council from permitting Council Consultants and Advisors or any other person from remaining in the Chamber. When the motion "That Council resume Open Council" carried, Council resumes the proceedings of the Meeting and any person may thereupon enter the Council Chamber.

## 22. Common Seal

22.1 The Common Seal of the Council shall be kept by the Town Clerk in a safe place and shall not be affixed to any document except by the authority of the Council and in the presence of the Chairman, one other Councillor and the Town Clerk; or in the presence of two Councillors and the Town Clerk.

## 23. General

808

23.1 The Council shall by resolution fix the closing time for each Council and Committee meeting. However, the closing time so fixed may be extended by a majority vote of Councillors at any meeting considered necessary.

## 24. Penalties for non compliance

- 24.1 Any person who contravenes or fails to comply with any of the provisions of this By-Law shall be liable to a penalty not exceeding ten penalty units.
- 25. This By-Law shall apply to and have operation throughout the whole of the Municipal District.
