## HOSPITALS AND CHARITIES ACT 1958

## ST. ALBANS COMMUNITY HEALTH AND RESOURCES CENTRE

Whereas pursuant to section 43A (1) of the *Hospitals and Charities Act 1958* a "community health service" means a community health service or a community health centre registered as an institution or benevolent society under this Act which in the preceding financial year received a grant from the fund or the Trust Account of the Treasury know as the Commonwealth Community Health Program Trust Account as a community health service or community health centre.

And whereas St. Albans Community Health and Resources Centre was registered as a benevolent society on 25 March 1975, pursuant to section 38 of the said Act.

And whereas section 43 (A) (2) of the said Act provided that, for the purposes of the Act, a certificate issued by the Treasurer of Victoria in any year that moneys have been paid as a grant from the Fund or the Commonwealth Community Health Program Trust Account to a registered institution or benevolent society as a community health service or community health centre shall be conclusive evidence that the institution or benevolent society is a community health service in the current financial year.

And whereas section 43 (A) (3) provides that, where, in the opinion of the Chief General Manager a community health service is inefficiently or incompetently managed or is failing to provide an

effective service or the committee of the community health service fails to obey a lawful direction of the Chief General Manager, the Governor in Council may, on the recommendation of the Minister, by Order published in the *Government Gazette* appoint a fit and proper person as administrator of the community health service and may by like Order remove a person so appointed.

And whereas section 43 (A) (4) provides that an administrator appointed under this section shall be deemed to be the committee of the community health service and shall have all the powers and may exercise any of the duties of the committee or its members and be subject to all the duties of the committee or its members.

And whereas section 43 (A) (5) provides that where an administrator is appointed under this section in respect of a community health service, the members of the committee of the community health service cease to hold office.

Now therefore, I, His Excellency the Governor of the State of Victoria by and with the advice of the Executive Council of the said State having regard to the opinion of the Chief General Manager, Health Department of Victoria that the St. Albans Community Health and Resources Centre is incompetently managed and on the recommendation of the Minister for Health, do by this Order appoint William F. Newton as administrator of the St. Albans Community Health and Resources Centre.

And the Honourable David Ronald White, Her Majesty's Minister for Health for the State of Victoria shall give the necessary directions herein accordingly.
