CONTRACTS ACCEPTED (Series 1986–7)

SUPPLY OF PASSENGER VEHICLES FOR STATE DEPARTMENTS FROM 1 February 1986 to 30 April 1987

Under these Contracts vehicles may be ordered for any State Government Department, or other State Government Instrumentality or Authority approved by the State Tender Board.

(Departments Only)

Passenger vehicles not provided for under these Contracts or Contracts now current for Commercial Vehicles, must be obtained in accordance with the provisions of Regulation 84 of the Treasury Regulations 1981 or under agreements entered into from time to time by the Tender Board.

PAWSON Secretary to the Tender Board Purchases (Departments Only)—Motor vehicles are to be purchased in accordance with instructions issued by the Director, Victorian Government Motor Vehicle Fleet as outlined in Standard Policies and Procedures Manual. Copies are available from the Directorate, 2nd Floor, Treasury Gate, 1 Little Collins Street, Melbourne, 3000. Telephone 654 3822.

Rates—The rates tendered do not include sales tax and are subject to "rise and fall". Departments etc. will be notified of all authorized variations.

Delivery Charges-Where applicable these are specified.

Optional Equipment—Details of optional equipment available but not included in the base cost of the vehicle are listed for each class of vehicle.

Dealers—Details of authorized vehicle dealers are available from the Director, Victorian Government Motor Vehicle Fleet.

Conditions of Contract—Extracts from the conditions of contract are shown below for the guidance of officers ordering and receiving vehicles.

- 1. The price of a contract motor vehicle shall include all equipment and services as specified in the specification hereto regardless of whether the extras specified are fitted by the Contractor or by a dealer.
- 2. A contract motor vehicle supplied to a Purchaser shall be the current model.
- 3. The compliance plates on a contract motor vehicle supplied to the Purchaser shall be dated not more than three (3) months prior to the date of delivery and without limiting the generality of the terms and conditions herein where the date exceeds three (3) months a Purchaser may seek an appropriate discount from the Contractor or may reject the vehicle.
- 4. The Contractor shall give the Purchaser 48 hours notice of delivery of a contract motor vehicle to the specified address for delivery.
- 5. The Contractor shall arrange for the dealer at no additional cost to the Purchaser to give the contract motor vehicle a thorough pre-delivery check in accordance with the instructions of the Contractor prior to delivery of the contract motor vehicle to the Purchaser.
- 6. The Contractor shall provide to the Purchaser evidence to verify that the Contractor's pre-delivery checklist has been satisfactorily carried out.
- 7. Where satisfactory evidence of the carrying out of a pre-delivery check is not provided by the Contractor to the Purchaser, the Purchaser may refuse to accept the vehicle.
- 8. Where delivery of a contract motor vehicle is delayed for more than thirty (30) days after the delivery date specified in the order, the Purchaser may cancel the order.
- 9. The Contractor shall be responsible for the safe transport of the contract motor vehicle and for any damage occasioned to the contract motor vehicle during delivery to the Purchaser.
- 10. The Contractor shall be liable for any damage to property of the State occasioned by the Contractor or any person engaged by the Contractor during the performance of any service required under the contract.
- 11. The Purchaser shall pay for a contract motor vehicle within thirty (30) days from the receipt of an invoice therefor.
- 12. The Purchaser shall be deemed to have accepted a contract motor vehicle when an authorized officer intimates to the Contractor that it has accepted the contract motor vehicle or when after the lapse of thirty (30) days it retains the contract motor vehicle without intimating to the Contractor that it has rejected the contract motor vehicle.
- 13. Except where otherwise stated in the order the Contractor shall register the contract motor vehicle prior to delivery in accordance with the instructions issued by the Purchaser and the Contractor shall be reimbursed by the Purchaser for the cost of registration.
 - 14. On site Police inspection fees in relation to contract motor vehicles shall not be charged to the Purchaser.
- 15. The Contractor shall invoice the Purchaser for the expenses of registration at the time of the delivery of the vehicle to the Purchaser together with satisfactory evidence that the sums claimed have been disbursed.

Ordering procedure and general information on Contractors.

1. AMI Toyota Ltd.

Orders must clearly state the model ordered, detail all options required, delivery address, Registration number and price agreed for trade-in. Vehicle will be delivered through Toyota dealer nominated by AMI Toyota Ltd.

Payment of Accounts:

AMI will invoice the agency for cost of vehicle or changeover price where a trade-in is involved. Cost of third party insurance and any other statutory charges will be invoiced separately after vehicle has been delivered. Payment is required within 30 days of receipt of invoice.

Delivery Time.

Maximum time for delivery of a vehicle is 30 days.

Delivery Charges:

Nil.

Price Protection:

In the event of a price variation (increase), the price charged for the vehicle will be that price ruling at the time of receipt and acceptance of order by AMI

Warranty:

12 months/20 000 km.
