### FIREARMS (AMENDMENT) REGULATIONS 1986

Pursuant to the Subordinate Legislation Act, the Ministry for Police and Emergency Services invites written comments from members of the public on the proposed Firearms (Amendment) Regulations

The objective of the regulations is to prescribe a number of provisions complementary to recent amendments to the Firearms Act. These include the prescription of new and amended forms, the specification of additional categories of persons eligible to hold a pistol licence and the prescription of security requirements for the safe-keeping of pistols.

A regulatory impact statement has been prepared which indicates that the potential benefits of more effective and equitable controls over pistols outweigh any disadvantages of additional costs.
