The *Victoria Government Gazette* (VGG) is published by VGPO for the State of Victoria and is produced in three editions.

VGG General is published each Wednesday and provides information regarding Acts of Parliament and their effective date of operation; Government notices; requests for tenders; as well as contracts and contracts accepted. Private notices are also published.

VGG Special is published any day when required for urgent or special Government notices. VGG Special is made available automatically to subscribers of VGG General.

VGG Periodical is published on Monday when required and includes specialised information eg. Medical, Dental, Pharmacist's Registers, etc.

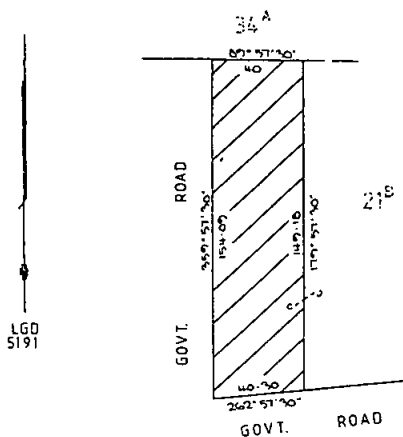

*Agricultural Chemicals Act 1958*  
**PROCLAMATION**

Prescribing DDT to be a Prohibited Constituent of any Agricultural Chemical

and

Prescribing Dieldrin to be a Prohibited Constituent of any Agricultural Chemical Used Other Than for Certain Purposes

I, J. Davis McCaughey, Governor of Victoria, acting with the advice of the Executive Council and under sections 6A and 10A of the *Agricultural Chemicals Act 1958*:

1. Amend the Proclamation made on 20 January 1987 and published in the *Government Gazette* of 21 January 1987 by deleting items 7 and 8 of the Proclamation.

2. Prescribe DDT to be a prohibited constituent of any agricultural chemical.

3. Prescribe dieldrin to be a prohibited constituent of any agricultural chemical used for any purpose other than as an insecticide—

- (a) for soil treatment for protection against subterranean termites in the case of buildings under construction, or for the treatment of subterranean termite infestation in existing buildings, except that in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals it may only be used for soil treatment for protection against subterranean termites in the case of buildings under construction; or
- (b) for the control of ants and argentine ants for quarantine purposes.

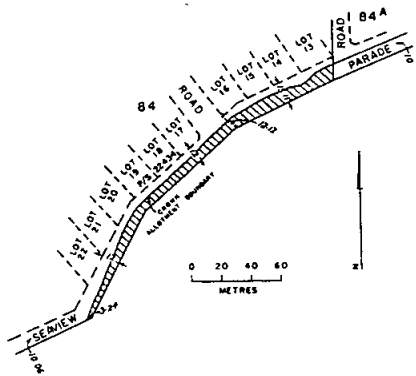
