PROCLAMATIONS

Agricultural Chemicals Act 1958

PROCLAMATION PRESCRIBING SUBSTANCES TO BE PROHIBITED CONSTITUENTS OF AGRICULTURAL CHEMICALS USED OR INTENDED TO BE USED FOR PRESCRIBED PURPOSES

I, J. Davis McCaughey, Governor of Victoria,
acting with the advice of the Executive Council and
under sections 6A and 10A of the *Agricultural
Chemicals Act 1958*:

1. Revoke the proclamation prescribing prohibited constituents of agricultural chemicals used or intended to be used for prescribed purposes that was made on 25 March 1986 and published in the *Government Gazette* of 26 March 1986.

2. Define the following terms used in this Proclamation:

"Closed fumigation chamber" means a fumigation chamber which is sealed after insertion of the product to be fumigated, and into which the fumigant is thereafter admitted for fumigation and subsequently purged at completion of fumigation before the chamber is opened.

"Closed soil application system" means a soil application system, consisting of a manifold with metering equipment, pressurized at less than 200 kpa, receiving ethylene dibromide (EDB) through a gastight joint directly from the container of ethylene dibromide (EDB) and delivering it through tubes leading into the seed row behind the tines and prior to covering the seed with soil.

"Misting Machine" means a machine or piece of equipment used for agricultural spraying which uses an air blast or air stream for dispersing the spray.

"Urban and semi-urban area" includes:

- (a) land used for residential, industrial or commercial purposes;
- (b) vacant land sub-divided for residential, industrial or commercial purposes;
- (c) open space predominantly surrounded by land of the class described in paragraphs (a) or (b); and
- (d) roads, railways or watercourses passing through or abutting land of the class described in paragraphs (a), (b), (c) or (d) as the case may be.

3. Prescribe the substance specified in column 1 of each item in the Schedule to be a prohibited constituent of any agricultural chemical used or intended to be used for any of the purposes set out in column 2 of that item.

Schedule

Column 1 Prohibited Substance	Column 2 Purpose
1. Any substance	As a vermin destroyer in cereal, oilseed or legume field crops for use in the control of mice.
2. Aldrin	As an agricultural chemical for any use other than as an insecticide— (a) for soil treatment for protection against subterranean termites in the case of buildings under construction; or for the treatment of subterranean termite infestation in existing buildings; or (b) for control of wood borers—except that in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals it may only be used for soil treatment for protection against subterranean termites in the case of buildings under construction.
3. Arsenic Compounds	As a stock pesticide.
4. Captafol	As an agricultural chemical.
5. Captan	As a fungicide on fruit, vegetable, cereal and field crops.
6. Chlordane	As an agricultural chemical for any use other than as an insecticide— (a) (i) for soil treatment for protection against subterranean termites in the case of buildings under construction; or for the treatment of subterranean termite infestation in existing buildings; or (ii) for control of ants by soil or surface treatment in industrial, farm, and public health uses other than inside private dwelling houses, boarding houses, apartment houses, common lodging houses or special accommodation houses; or

- (iii) for control of wood borers—
except that in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals it shall only be used for soil treatment for protection against subterranean termites in the case of buildings under construction; or
- (b) for control of ants including argentine ants, for quarantine purposes and in home gardens; or
- (c) for control of spiders in home gardens; or
- (d) for soil treatment for control of ants and black beetles in turf.
7. DDT
As an agricultural chemical for any use other than as an insecticide—
- (a) for control of carrot weevil on carrots; or
- (b) for use as a dip at transplanting for control of garden weevil on strawberry runners; or
- (c) for control of vegetable weevil on seedling tomatoes; or
- (d) for control of ants on eucalyptus seeds; or
- (e) for the control of body and head lice on humans.
8. Dieldrin
As an agricultural chemical for any use other than as an insecticide—
- (a) for soil treatment for protection against subterranean termites in the case of buildings under construction, or for the treatment of subterranean termite infestation in existing buildings, except that in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals it may only be used for soil treatment for protection against subterranean termites in the case of buildings under construction; or
- (b) for the control of ants and argentine ants for quarantine purposes; or
- (c) applied as a soil treatment when mixed with fertilisers only for control of wireworms or white fringed weevils in potatoes; or
- (d) applied as a soil treatment when mixed with fertilisers only for control of onion seedling maggots or wireworms in onions.
- As an agricultural chemical.
- As an agricultural chemical except as a fumigant for—
- (a) the treatment, in a closed fumigation chamber, of fruit and vegetables for fruit fly; or
- (b) the control, by use of a closed soil application system, of soil nematodes in cereal crops.
- As a vermin destroyer for control of birds.
- As a vermin destroyer for the control of rats or mice in industrial or domestic situations or in food premises.
- As an agricultural chemical for any use other than an insecticide for soil treatment for protection against subterranean termites in the case of buildings under construction or for the treatment of subterranean termite infestation in existing buildings, except that in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals it may only be used for soil treatment for protection against subterranean termites in the case of buildings under construction.
- As an insecticide for the control of insects—
- (a) on grapes; or
- (b) on apricots.
- As an insecticide—
- (a) for control of insects in dairies, milking sheds, poultry houses, sheep pens, pig sties, feed lot structures and other animal houses for food producing animals; or

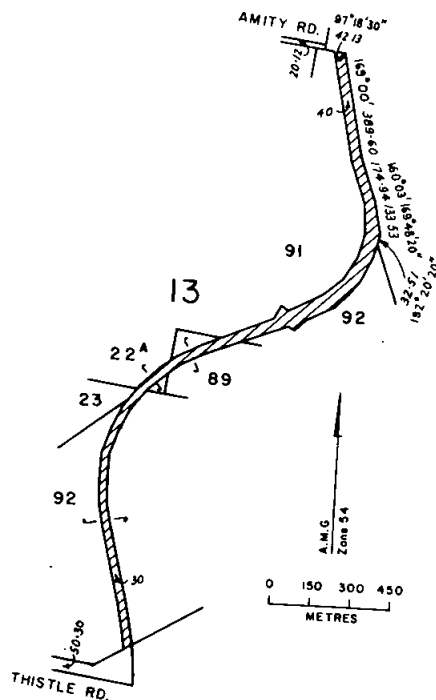

The Governor in Council under section 23 of the *Post-Secondary Education Act 1978* and with the advice of the Executive Council, amends the Order constituting the Council of the Chisholm Institute of Technology which was published in the *Government Gazette* on 3 March 1982 by substituting for sub-clause (32) of Clause 6, the following sub-clause:

"(32) In addition to the powers conferred by any other sub-clause of this Clause 6, acquire by purchase or otherwise, take on lease or hire and sell, mortgage, charge, lease or dispose of any real or personal property or any interest therein and enter into any agreements relating thereto (including option and like agreements) and enter into and give guarantees

and indemnities for the payment of money or the performance of contracts or obligations by any person or company and secure any such guarantee or indemnity by mortgage or charge over all or any of the real or personal property of the Institute provided that in the case of disposal or mortgage or charge over real property only with the consent of the Minister for Education on the recommendation of the Commission."

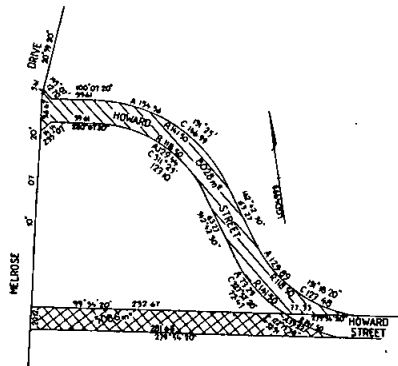

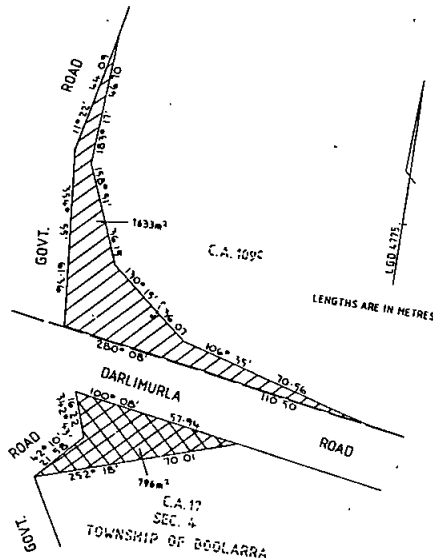

TRAVEL AGENTS EXEMPTION ORDER No. 1
Title

1. This Order may be cited as the "Travel Agents Exemption Order No. 1".

Commencement

2. This Order comes into effect on 1 February 1987.

Interpretation

3. In this Order, "the Act" means the *Travel Agents Act 1986*.

Exempt Government agencies

4. The following are not required to hold a licence under the Act:

- (a) Australian National Airlines Commission (trading as Australian Airlines);
- (b) Australian National Railways Commission;
- (c) Northern Territory Tourist Commission (trading as Northern Territory Government Tourist Bureau);
- (d) Queensland Tourist and Travel Corporation (trading as Queensland Government Travel Centre);
- (e) State Transport Authority of Victoria (trading as V Line Travel);
- (f) Tourism Commission of New South Wales;
- (g) Tourism Commission of New South Wales (trading as Travel Centre of New South Wales);
- (h) Transport Tasmania (trading as TT line);
- (i) Western Australian Tourism Commission (trading as Holiday WA Centre);
- (j) a Minister of the Crown in the right of the Commonwealth or of any State of the Commonwealth;
- (k) a Government Department of the Commonwealth or of any State of the Commonwealth;
- (l) a statutory corporation representing the Crown in the right of the Commonwealth or of any State of the Commonwealth.

Exemption for certain domestic agents

5. (1) A person who carries on business as a travel agent only by making arrangements for travel between places all of which are within the Commonwealth is not required to hold a licence in any financial year if—

(a) in that financial year the total value of those arrangements does not exceed \$30 000; and

(b) in the immediately preceding financial year the total value of those arrangements did not exceed \$30 000.

(2) In this clause, "financial year" means the period from 1 July in a year to the 30 June next following.

Exemptions for excursions, joy rides, &c

6. A person who carries on business as a travel agent only by making arrangements for journey in which each passenger travels from a place and returns to that place on the same day is not required to hold a licence.
