RURAL WATER COMMISSION OF VICTORIA

By-Law No. 6087

Rates—Urban Districts

The Rural Water Commission of Victoria under the provisions of the Water Act, hereby makes the following By-Law:

1. The following rates for the supply of water for domestic purposes are hereby made and shall be levied upon the occupiers or owners of lands and tenements within the respective Urban Districts as set out hereunder.

On all tenements in respect of which a notice has been given in accordance with the Eighth Schedule to the Water Act that a main pipe for the supply of water has been laid down—a rate of such amount in the Dollar of the Net Annual Value (N.A.V.) as set out in municipal valuation as at 30 June 1987, of such tenements as is set down in Column 2 opposite the respective Urban District in Column 1 of the Schedule below: provided that the total amount of the rate payable annually in respect of any such tenements (other than land on which there is no building) shall be not less than the amount set out in Column 3 of the Schedule and in respect of any land on which there is no building shall be not less than the amount set out in Column 4 of the Schedule.

- 2. Such rates are made and shall be levied for the year beginning with 1 July 1987, and ending with 30 June 1988, and shall be payable on 15 November 1987, at the office of the Rural Water Commission at the place set down in Column 5 opposite the name of the respective Urban District in Column 1 of the said Schedule.
 - 3. Interest will be chargeable on all rates remaining unpaid after 15 March 1988.
- 4. Such person or persons as the Rural Water Commission may from time to time appoint for that purpose shall be and is or are hereby authorised to demand, receive, collect and recover the said rates.




MALDON—The roads in the Parish of Maldon as indicated by hatching on plan hereunder—(L6-4430).




MALDON—The roads in the Township of Maldon as indicated by hatching on plans hereunder—(L6-4430).







By-Law 181

Municipal Buildings, Reserves and Playgrounds

- A By-Law of the City of Mordialloc made under the provisions of section 197 of the *Local Government Act* 1958, and numbered 181 for the purpose of:
 - (a) Preserving Public Decency;
 - (b) Suppressing nuisances;
 - (c) Controlling and managing and preserving public reserves including the following of which management is vested in the Council:
 - (i) gardens, garden plots, lawns and ornamental plantations and lakes;
 - (ii) trees, shrubs and plants planted and tree guards, statues, monuments, fountains and seats in any reserve etc.
 - (d) Regulating the conduct of persons using or being upon or in grounds or places of public resort or public recreation vested in or rented by the Municipality of the City of Mordialloc and requiring such persons to comply with the directions on any signs which the Council of the Municipality of the City of Mordialloc has caused to be displayed in such grounds or places.
 - (e) Preserving good order and decency in any building belonging to the Municipality or under the control and management of the Council and preventing damage to such building or to the furniture or fittings thereof and regulating any meeting or gathering held therein;
 - (f) Imposing collecting and receiving charges or entrance fees from clubs, associations or persons using or entering in or upon any pleasure grounds or places of public resort or public recreation on land purchased or vested or otherwise provided by or granted or given by any person to the Council for the provision of such grounds or places and also for the regulation of the conduct of persons using or being upon or in such grounds or places.
 - (g) The care, management and control of any land or building belonging to the Council.

Pursuant to the powers conferred by the Local Government Act 1958, and of any and every other power it thereunto enabling the Mayor and Councillors and Citizens of the City of Mordialloc orders as follows:

1. This By-law may be known as the Reserves By-law.

- 2. By-law No. 171 of the City of Mordialloc relating to Municipal Buildings, Reserves and Playgrounds is hereby repealed.
- In this By-law, unless inconsistent with the context or subject matter—"Authorised Officer" means and includes a Health Surveyor, Bylaws Officer or other Officer authorised in writing by the Council;
 - "Children's Playground" means and includes each and all of the lands described in the First Schedule hereto together with any other lands added to the First Schedule from time to time by Resolution of the Council;
 - "Consent" means the consent in writing of the Council under the hand of the Town Clerk;
 - "Council" means the Council of the City of Mordialloc;
 - "Management Committee" means the Honorary Committee, if any, appointed by the Council in accordance with section 241 A of the Local Government Act, 1958, to manage the particular reserve;
- "Municipal Building" means and includes any building belonging to the Municipality or under the control and management of the Council or a Management Committee;
- "Reserve" means and includes each and all of the land described in the Second Schedule hereto which have been purchased, rented or otherwise provided by the Council or been granted or given by some person for the providing of pleasure grounds or places of public resort or public recreation and any further lands added to the Second Schedule by Resolution and also includes children's playgrounds as herein defined.
- 4. This By-law shall apply to and have operation throughout the whole of the Municipal District of the City of Mordialloc and shall come into operation and have effect immediately upon its publication in the Victoria Government Gazette.
- 5. All reserves shall be open to the public from sunrise to sunset except on such days and at such hours as the Council or Management Committee may in the case of any reserve by resolution set aside as days upon which charges or entrance fees may be collected and received for Clubs, Associations or persons usings or entering in or upon such reserve. On any day so set aside there may be charged and taken such sum not exceeding Ten Dollars as may be fixed by the Council for the admission of any person and on any day so set aside the Council may determine the application of such funds so collected or received by Clubs and Associations.

- 6. No person shall without prior consent enter into or remain in any reserve between the hours of sunset and sunrise on any day.
- 7. Nothing in this By-law shall prevent the Council closing any reserve or portion thereof and excluding the public therefrom whenever it shall think fit.
- 8. No person, club, association, group of persons or Management Committee other than children under the age of 14 years occupied in playing ball games in children's playgrounds, displaying a notice erected by the Council or Management Committee permitting such ball games shall engage in nay organised game or sport including the practice of cricket, football, bowls, tennis, lacrosse or golf in or upon any reserve without the consent of the Council or Management Committee.
- 9. Every club, person or association receiving written permission from the Council to use any reserve or any part thereof for any purpose consistent with this By-law shall be responsible for any wilful damage caused to the reserve or any improvement thereon during the period of the permissive occupancy granted by the Council.
- 10. No person other than members of the Council or of the Management Committee, Officers of the Council and employees of the Council or Management Committee on duty shall enter any reserve when a charge is made for admission thereto without first paying the fee charged unless authorised in writing by the Council or Management Committee.
- 11. No person other than a player, official or competitor at any sports match or sports gathering duly authorised in accordance with the provisions of the By-law or a duly authorised officer or employee of the Council or Committee of Management shall enter or remain within or upon the playing arena in any reserve during the progress of such sports match or sports gathering or otherwise interfere with the same or interrupt any employee of the Council or Management Committee in the proper execution of his duty or work
- 12. No person shall cut, maim, or otherwise damage, interfere with or write upon or deface—
- (a) any building on any reserve or the furniture, water supply, fittings or equipment or machinery thereon;
- (b) any municipal building or the furniture or fittings therein.
- 13. No person shall interfere with or break or damage or remove any tree, plant, shrub or flower in or upon a reserve or walk on the flower beds or borders or climb, jump or get upon or over any fence, gate, building or part thereof or post

- bills or advertisements on any of the fences, gates, walls, seats or other structures or roll or throw stones or missiles or leave in any reserve or part thereof or building therein any bottle, can, broken glass, paper, fruit skins, or peel or any refuse or rubbish whatsoever except in the receptacles provided or spit upon or expectorate upon or otherwise foul any path or structure or remove, displace, disfigure or damage any noticeboard or scoreboard in or upon any reserve or Municipal building
- 14. No person shall carry a firearm or airgun in or through any reserve or shoot, attempt to shoot, snare, attempt to snare, destroy or attempt to destroy any bird or animal therein or thereon except by the written authority of the Council.
- 15. No person shall play any unlawful game or make any wager for money or carry on any form of gambling in any reserve without the written consent of the Council and all other relevant authorities or by any unseemly or indecent conduct or otherwise interfere with the comfort or enjoyment of other persons within any reserve.
- 16. No person shall sell expose or offer for sale within a reserve any article of food or drink or any other article or operate or cause to be operated any amusement for which a charge is made or make a collection of money for any purpose without the written consent of the Council or Management Committee.
- 17. No person shall behave in a disorderly manner or create or take part in any fight or disturbance or use any indecent or abusive language or commit any nuisance or in any way offend against decency by means of dress, language or conduct in a reserve and no person shall enter or remain in a reserve whilst in a drunken or intoxicated condition or whilst under the influence or any drug of addiction within the meaning of the *Poisons Act* 1962, or any statutory amendment modification or re-enactment thereof.
- 18. No person shall in any reserve use an amplifier or electronic device except in a manner and from a location as indicated by an Authorised Officer.
- 19. No person shall give out or distribute any hand-bills, placards, notices, advertisements, books, pamphlets, or papers in a reserve.
- 20. No person shall without the written consent of the Council camp in the reserve or assemble in a reserve for fetes, picnics, or concerts, or for the purpose of public worship, preaching or public speaking of any kind, or meetings of a like character.

- 21. No person other than an officer or employee of the Council or Management Committee shall enter any plots or areas which are set aside for the planting or growing of flowers, trees or shrubs in a reserve.
- 22. Otherwise than is provided in the next succeeding clause, no person shall permit or suffer any animal owned by him or of which he is in charge to be in or upon a reserve.
- 23. No person shall bring allow or have any dog in a reserve unless such dog is controlled by a leash chain or cord, or provided that such dog is taking part in sheep dog trials or dog obedience trials or training sessions in accordance with the written authority of the Council for the use of reserve for that purpose.
- 24. No person whilst in or upon a reserve shall without proper consent fly or permit to be flown any model aeroplane over such reserve.
- 25. No person shall without the written consent of the Council or Management Committee and the observance of all statutory restrictions which may be in force light any fire to remain alight in a reserve save in a fireplace provided by the Council.
- 26. Subject as is hereinafter provided no person without the consent of the Council other than an Officer or servant of the Council shall ride or drive any horse or any motor car, motor cycle or other vehicle or any bicycle into or upon a reserve provided always that this clause shall not apply to the parking of any motor car, motor cycle, bicycle or other vehicle in any parking are set aside for that purpose by the Council and provided further that this clause shall not apply to the wheeling of bicycles, prams, invalid wheelchairs, child or baby carriages and children's toys along any delineated footpath in a reserve or the riding of bicycles along designated bicycle paths.
- 27. In a reserve or portions of reserves where children's playgrounds have been established by the provision of playground equipment such as swings or are notified by notice on the land as being children's playgrounds—
 - (a) No person above the age of fourteen years shall enter upon or remain on such an area or use any of the swings or other appliances therein provided however that parents or other persons in charge of children shall not be prohibited from entering upon or remaining on the area or from using any seating which may be provided to watch over or supervise children in their charge;
 - (b) No person shall enter or remain in a children's playground between the hours of sunset and sunrise;

- (c) No person shall use any equipment therein save for the purpose for which it is provided;
- (d) The Council and/or Management Committee shall not be responsible for any accident occurring on any portion of such area or arising from the use of any of the swings or other appliances therein.
- 28. No person shall in a reserve or Council building—
 - (a) make or cause to be made any loud or violent outcry noise, disturbance or sound calculated to cause a nuisance or annoyance to other persons;
 - (b) make or cause to be made any loud sound or noise upon or play any music or noisy instrument.
- 29. No person shall remain in a reserve at any time when lawfully directed to leave the same by any Victoria Police Officer or any authorised officer or employee of the Council or Management Committee notwithstanding that a fee or charge for admission may have been paid.
- 30. Every person being on a reserve shall obey the direction of any Victoria Police Officer, officer of the Council or member of the Management Committee in respect of his or her conduct therein
- 31. All persons suspected of or contravening the terms of this By-law shall give their names and places of abode when asked to do so by any Victoria Police Officer, officer of the Council or member of the Management Committee or an authorised officer.
- 32. No person shall bet publicly or carry on the business of a book-maker in a reserve or Council building except with prior consent of the Council or Committee of Management at which licensed book-makers are permitted by law to operate.
 - No person shall—
 - (a) swim, wade, paddle, dive or jump in or in any way enter any lake, pond or fountain located in a reserve;
 - (b) throw, place, or cause or suffer to be thrown or placed any liquid, stones, rocks, sticks, paper, dirt, or rubbish or any other object or thing of any kind into any lake, pond or fountain located in a reserve; or
 - (c) row, sail, drive or in any way operate a boat, yacht or any other type of craft on or in any lake located in a reserve unless written permission of the Council has been first obtained.

34. Every person who is guilty of any wilful act or default contrary to any of the provisions of this By-law shall be liable on conviction to a penalty not exceeding four penalty units and any person guilty of a continuing offence contrary to this By-law shall be liable to a penalty of one penalty unit for each day on which an offence against this By-law shall be continued after a Conviction Order by any Court.
