REGULATIONS FOR THE CARE,
PROTECTION AND MANAGEMENT OF
THE SEBASTOPOL PUBLIC RECREATION
RESERVE

I, Joan Elizabeth Kirner, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria, pursuant to the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978* make the following Regulations for and with respect to the Crown Land in the Township of Sebastopol temporarily reserved for Public Recreation by Orders in Council dated 15 January 1980 and 23 August 1983 (see *Government Gazettes* dated 23 January 1980 and 31 August 1983 respectively) in respect of which a Committee of Management has been appointed.

Regulations

1. For the purposes of these regulations unless inconsistent with the context or subject matter:

"Act" means the *Crown Land (Reserves) Act 1978*.

"Cattle" includes bulls, cows, oxen, heifers, calves, steers, horses, mares, geldings, colts, fillies, asses, mules, pigs, rams, wethers, ewes, lambs, goats and kids.

"Committee" means the Committee of Management appointed from time to time to manage the Reserve.

"Recreational Purposes" includes games, team and other sports, equestrian events, horseracing, horse riding, agricultural shows, fetes and camping.

"Reserves" means the Crown land in the Township of Sebastopol temporarily reserved for Public Recreation on 15 January 1980 and 23 August 1983 and generally referred to as the M. R. Power Reserve.

Division 1—Applications for Permits and Licences.

Division 2—Functions, Powers and Duties of the Committee.

Division 3—Offences.

Division 4—General.

2. Division 1—Application for Permits and Licences:

2. (1) Where in these Regulations persons are prohibited from engaging in certain conduct

without a permit, if a person seeks to be exempted from such a prohibition, that person shall apply in writing to the Committee for a permit or licence.

(2) Every applicant for a permit or licence shall state:

- (a) the purpose for which the permit or licence is required; and
- (b) the period for which the permit or licence is required.

(3) Applications for a permit or licence shall be lodged with the Secretary of the Committee.

Division 2—Functions, Powers and Duties of the Committee:

Subject to the Act the Committee shall manage the Reserve and without limiting the generality of the foregoing:

3. (1) the Committee may at its discretion issue permits and licences authorising the following activities within the Reserve, namely:

- (a) the—
 - (i) carrying and use of firearms and other weapons;
 - (ii) emission of noise;
 - (iii) erection of buildings, booths or other structures;
 - (iv) grazing of cattle;
 - (v) provision of entertainment to the public;
 - (vi) racing of engine powered vehicles; and
 - (vii) use of buildings, booths, enclosures or other structures—

within the Reserve; and

- (b) the admission and entry to the Reserve of—
 - (i) bookmakers;
 - (ii) campers;
 - (iii) dogs;
 - (iv) intoxicating liquor and other alcoholic beverages; and
 - (v) members of the public.

(2) The Committee may impose collect and receive tolls, fees, rents, or other charges for or in respect of any permit or licence issued pursuant to sub-regulation (1).

4. (1) Where the Committee issues a permit or licence authorising a person to enter the Reserve for the purpose of camping within the Reserve, the Committee may attach such terms and conditions to the permit or licence which it considers necessary to ensure the safety of persons camping within the Reserve and the care and protection of the land by those persons.

(2) A person who has been issued with a permit or licence to enter the Reserve for the purpose of camping shall only erect a camp in those areas of the Reserve which the Committee may from time to time set aside for that purpose.

5. (1) Where the Committee has issued a person with a permit or licence to graze cattle within the Reserve and the Reserve is required for recreational purposes, the Committee shall serve the permit or licence holder with a notice in writing demanding the removal of the cattle from the Reserve by the time specified in the notice.

(2) Where a notice has been served pursuant to sub-regulation (1), the permit or licence holder shall remove the cattle from the Reserve in accordance with the notice.

6. (1) Where a person seeks admission to the Reserve for the purpose of pursuing the calling of a bookmaker, the Committee may charge that person a fee not exceeding \$100 for admission to the Reserve.

(2) A person who has obtained a permit or licence to enter the Reserve for the purpose of pursuing the calling of a bookmaker within the Reserve shall wear a ticket or carry or display a bag on which their name is clearly marked in capital letters.

7 (1) Where a person, association, club or society seeks to use any portion of the Reserve or to rent or hire any structure building or enclosure on the land for the purpose of providing entertainment (whether sporting or otherwise) to the public for a fee, the Committee may let any portion of the Reserve or any structure building or enclosure on the land for that purpose.

(2) Where a person, association, club or society seeks to use any portion of the Reserve or rent or hire any structure building or enclosure on the land for the purpose of providing entertainment (whether sporting or otherwise) to the public for a fee, that person, association, club or society shall apply in writing to the Committee not less than two months prior to the date on which any portion of the Reserve or any structure building or enclosure is required for a permit to use any portion of the Reserve or to rent or hire any structure building or enclosure on the land for that purpose.

(3) Where the Committee lets any portion of the Reserve or any structure building or enclosure on the land to a person, association, club or society, the Committee may impose such terms and conditions in relation to the use of the land or the renting or hiring of any structure, building or enclosure thereon as are necessary to ensure—

(a) the care and protection of the land; and

(b) the safety of persons on the land or occupying or using any structure of building or any part of any structure or building on the land.

(4) Where any structure building or enclosure on the land has been let in accordance with this Regulation the Committee may demand that a permit holder lodge with it security of an amount not exceeding \$100 as a guarantee for the proper care of any structure, building or enclosure let to the permit holder and the Committee may apply such security in either whole or part to restore or repair any damage arising out of the occupancy or use by the permit holder of the structure building or enclosure.

7. Division 3—Offences

(1) Whilst within the Reserve, a person shall not without first obtaining a permit or licence and paying such fees rents or other charges (as the case may be) as have been imposed by the Committee for issuing permits or licences, do or attempt to do or assist another person to do any or all of the following acts, namely:

- (a) place erect pitch or make use of a shelter, tent, hut, vehicle, caravan or other structure for the purpose of camping;
- (b) graze cattle;
- (c) pursue the calling of a bookmaker;
- (d) race any type of engine-powered vehicle; or
- (e) use or activate any amplifier, loud speaker, public address system or other apparatus or instrument having a similar purpose or effect.

(2) A person shall not without first obtaining a permit or licence and paying such fees or other charges as have been imposed by the Committee for issuing permits or licences do or attempt to do or assist another person to—

- (a) introduce spiritous liquor or other alcoholic beverages; or
- (b) bring a dog which is not controlled by means of a leash or other form of restraint—

into the Reserve.

8. A person shall not within the Reserve do or attempt to do or aid or abet another person to do any or all of the following acts namely:

- (a) expectorate upon any building erection or path;
- (b) climb or jump over any fence or gate;
- (c) damage or deface any building erection, structure fence or gate;
- (d) damage any flowers shrubs or trees;

- (e) leave litter of any description whatsoever other than in a receptacle provided for that purpose;
 - (f) light a fire other than in a fireplace provided for that purpose;
 - (g) hurl, roll or throw stones or any other missiles;
 - (h) ride a pushbike;
 - (i) whilst any competition, entertainment, game or sport is being offered conducted provided or played, walk or run across, climb on or be present at or otherwise trespass on any building, course enclosure, playing ground area, room structure or part thereof.
9. A person—
- (a) other than a labourer or workman employed to work within the Reserve, shall refrain from entering any enclosed areas planted with young trees or shrubs or other enclosed areas which have been prepared for planting;
 - (b) other than an employee of the Committee or other person authorised in that behalf shall not whilst within the Reserve—
 - (i) use a firearm; or
 - (ii) carry a firearm or any other weapon capable of inflicting injury or causing death.
10. Division 4—General
- (1) Where a person seeking admission to the Reserve—
- (a) uses indecent language; or
 - (b) behaves or is dressed in such a manner as to offend against generally accepted community standards governing public behaviour—

that person shall be refused admission to the Reserve.
11. A person who contravenes or fails to comply with any provision of these Regulations shall be guilty of an offence and liable to the penalty prescribed by the Act.

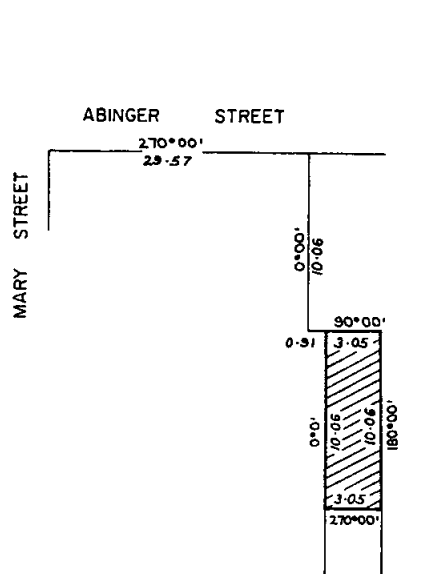

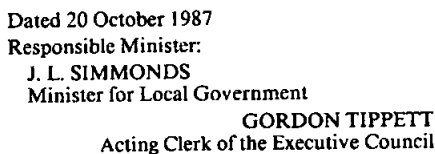

DETERMINATION

This Determination is made by the Victorian Dairy Industry Authority under the powers conferred by section 44 of the *Dairy Industry Act 1984* after consultation with the Prices Commissioner and shall come into operation on 1 November 1987.

The Determinations of milk prices made by the Victorian Dairy Industry Authority and published in the *Government Gazette* dated 9 September 1987 are hereby revoked.

Part 1

PRICES PAYABLE FOR SALES OF MILK

The prices payable for sales of daily pasteurised milk in all Milk Districts other than the Border Milk District shall be in accordance with Schedule 1.

The prices payable for sales of packaged milk in the Border Milk District shall be in accordance with Schedule 2.

The retail price for sales of packaged Ultra Heat Treated Milk in all Milk Districts shall not be less than the prices shown in Schedule 3.

The prices payable for milk products in the package types as shown in column 1 of the attached schedules shall be indicated in the appropriate columns according to the category of sale.

The categories of sale are defined as:

- (1) Wholesale sales are those by a milk processor to the owner of a dairy.
- (2) Semi-wholesale sales are those by the owner of a dairy to the owner of a milk shop, or other approved person.
- (3) Retail sales are sales by the owner of a dairy, a milk processor or a milk vendor of not more than 16 litres to a person on any one day, or any sale made by the owner of a milk shop.
- (4) Vending machine sales are retail sales from an automatic vending machine. The maximum retail price for vending machine sales of unflavoured milk shall be at the nearest five (5) cent multiple above the maximum gazetted retail price. Refer section 24 (2) and (3) of the *Dairy Industry Act 1984* for licensing requirements.
- (5) In the Border Milk District, Vendor sales are those by the owner of a dairy to a milk vendor located in that District who does not operate licensed dairy premises. The price of plain milk to vendors in the Border Milk District shall be in the range of 75% of the gazetted minimum and maximum retail prices set out in Schedule 2.
- (6) An institutional sale is a sale by a dairyman or vendor to:
 - (a) A charitable institution or benevolent society which is either exempt and/or registered under the Hospitals and Charities Act and subsidised by the Health Department of Victoria for maintenance purposes; or
 - (b) An institution which is operated under the Community Welfare Services Act.
- (7) Sales to institutions by the owner of a dairy shall be in the range of 95% of the gazetted minimum and maximum semi-wholesale delivered prices.

All persons conducting business as a dairy, factory, store, milk processor, milk vendor, milk carrier, milk shop or any combination of the foregoing are required to hold a current and valid dairy industry licence pursuant to section 24 of the *Dairy Industry Act 1984*.

Part 2

PRICES PAYABLE FOR MILK SUPPLIED BY DAIRYFARMERS

The Authority has determined that the price to be paid to dairyfarmers for milk supplied by dairyfarmers and accepted by the Authority for sale or distribution in Victorian Milk Districts shall be 34.11 cents per litre.

Part 3

PRICES PAYABLE FOR MILK SUPPLIED TO PROCESSORS BY THE AUTHORITY

The Authority has determined that the following prices must be paid for milk sold by the Authority to milk processors.

- (a) Standardised raw milk for processing as daily pasteurised milk available for sale in Victoria will be 41.89 cents per litre;
- (b) Standardised raw milk for processing into Ultra Heat Treated milk for sale in Victoria will be 39.74 cents per litre;
- (c) Standardised raw milk for processing into ultra filtered milk for sale in Victoria will be 42.89 cents per litre.

Part 4

MINIMUM AND MAXIMUM DETERMINED PRICES

In accordance with section 44 of the *Dairy Industry Act* 1984, the minimum prices set out in this Determination to be paid for market milk (other than flavoured milk and UHT milk) sold by wholesale and semi-wholesale or retail, are not more than 3% lower than the related maximum prices fixed in a previous Determination.

Part 5

FEDERAL SALES TAX ON FLAVOURED MILK

Federal Sales Tax, levied under Assessment Act No. 1 section 70A is included in minimum retail prices shown in Schedules 1, 2 and 3.

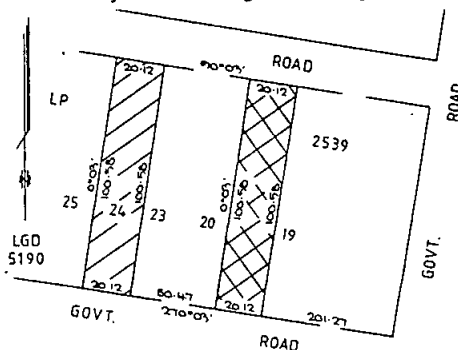
