PROPOSED LOTTERIES GAMING AND BETTING (RAFFLES AND BINGO PERMITS) (AMENDMENT) REGULATIONS 1988

The Minister for Sport and Recreation intends to make the above Regulations and invites public comment on the Regulations.

The objectives of the proposed Regulations are to give effect to provisions of the Lotteries Gaming and Betting (Amendment) Act 1987 by prescribing:

- (a) the kind of political party which may conduct raffles;
- (b) the form of application for a permit to conduct a series of lotteries for the promotion of a trade or business;
- (c) the statements of account for a series of trade promotion lotteries; and
- (d) amended prize values for raffles not requiring permits.

The Regulations are made pursuant to the Lotteries Gaming and Betting Act 1966.

PROPOSED LOTTERIES GAMING AND BETTING (SIDESHOW PERMITS) REGULATIONS 1988

The Minister for Sport and Recreation intends to make the above Regulations and invites public comment on the Regulations.

The objective of the proposed Regulations is to ensure that devices, games and minor lotteries at carnivals, fetes, fairs, gymkhanas, bazaars, recreational and tourist centres are conducted in a fair manner whilst not adversely affecting the livelihood of legitimate small business operators.

The Regulations, which are the preferred alternative, prescribe the forms for application and permit and conditions for sideshow devices or games to be issued by the Chief Commissioner of Police.

The Regulations are made pursuant to the Lotteries Gaming and Betting Act 1966.
