NOTICE OF REGULATORY IMPACT  
STATEMENT

Animal Preparations Regulations 1988

It is proposed that new Regulations be made with the objectives of:

- (i) protecting the domestic and export trade by making provision to ensure that unacceptable residues do not occur in food derived from stock; and
- (ii) protecting consumers by setting adequate standards for the safety, efficacy and quality of animal preparations; and
- (iii) protecting and promoting animal welfare by ensuring that animal preparations are safe and effective.

A Regulatory Impact Statement has been prepared in accordance with the *Subordinate Legislation Act 1962* and concludes that the regulations will provide the users of animal preparations with an assurance of safety, to both the animal and handler, of freedom from toxic and harmful residues and effective products.
