Declaration of Fire Danger Period

In pursuance of the powers conferred by section 4 of the *Country Fire Authority Act 1958*, I, Steven Marshall Crabb, Minister for Police and Emergency Services, after consultation with the Minister for Conservation, Forests and Lands hereby declare the following periods to be the fire danger periods in the municipalities or parts of municipalities specified, commencing on the date shown and, unless varied by subsequent declaration, ending at midnight on Sunday, 30 April 1989.

To commence from and inclusive of Monday, 28 November 1988.

Shire of Warracknabeal

Shire of Wycheproof (South). The portions south of the Woomelang-Banyan-Berriwillock road, the western, southern and eastern boundaries of the Township of Berriwillock and the Berriwillock, Springfield and Ultima Road.
