Preparation of Amendment

Metropolitan Region Planning Schemes

Amendment RL11

The Minister for Planning and Environment has prepared an amendment which—

(1) amends the Regional section of all Planning Schemes in the Metropolitan Region in the manner set out in Schedule A.

(2) amends the local section of the schemes set out in Schedule B in the manner described beside the name of each scheme.

The amendment can be inspected at the Ministry for Planning and Environment, 477 Collins Street, Melbourne.

The amendment as it applies to each Planning Scheme can be inspected at the place listed in the schedule beside the name of each scheme.

SCHEDULE A

(a) include Lot 13 LP 2387 corner Somerton and Oaklands Road, Oaklands Junction, in the Table to Clause 11A.

(b) make modifications to and introduce new height controls in Albert Road, St Kilda Road and Queens Road. Protect specified buildings, modify setback controls and modify objectives of zones along St Kilda and Queens Roads in the Cities of St Kilda and South Melbourne. Clauses 5E (1), 19A and Tables to Clause 25G and 25H are modified.

(c) remove the prohibition of the use—mechanical car wash in Residential C and Reserved Living Zones.

(d) introduce a new Clause 24A (7) to provide for a landscape buffer to land in the vicinity of South Gippsland Highway, Evans Road and the railway line, Cranbourne. (This land is also being rezoned in this Amendment under the Cranbourne Planning Scheme).

(e) include Lots 4 and 5 LP 7419, Lot 10 LP 131965 and Part Lot 13 LP 7419 bounded by Stuart Avenue, Fordholm Road and Hallam Road, Hampton Park in the Table to Clause 22A. (This land is also being rezoned in this amendment under the Cranbourne Planning Scheme).

(f) make appropriate amendments to introduce the Eltham Gateway Zone. (Land is also being rezoned in this amendment under the Eltham Planning Scheme).

(g) extend urban conservation controls to several new areas in the City of Heidelberg. Include sites in the Table to Division 3E. (The areas are also being designed as conservation areas in this amendment under the Heidelberg Planning Scheme).

(h) introduce Clause 24 (5i) to control residential development of land bounded by Duke, Surrey, Cumberland and Suffolk Roads, Sunshine. (This land is also being rezoned in this amendment under the Sunshine Planning Scheme).

(i) introduce Clause 25 (4A) (e) to control extractive industry operations on land bounded by Masons Lane, Epping Road, Bridge Inn Road and Bindts Road, Wollert. (This land is also being rezoned in this amendment under the Whittlesea Planning Scheme).

(j) amend Clause 25i (2) to allow an office development at 19-53 Punt Road, St Kilda, in accordance with plans approved by Council.
