**CODE OF PRACTICE FOR THE USE OF
ANIMALS FROM MUNICIPAL POUNDS IN
SCIENTIFIC PROCEDURES**

Introduction

This Code recognises that unwanted/stray animals exist in the community, that the majority of these animals will be humanely killed at a pound and that, subject to the strict conditions set out in this Code, they should be available for use in scientific procedures as an alternative to colony or purpose-bred animals.

This Code does not approve of the use of stray or unwanted identified animals in scientific procedures without the specific written approval of the owner.

Responsibilities of Municipalities

Municipalities should advise all ratepayers of Council policy in regard to the handling of stray, unwanted and abandoned animals, pound access times and the location of the pound. The pound should be suitably identified and access times prominently displayed.

All owners of identified animals received at the pound should be notified by the Council within 24 hours where possible.

Council must provide access to the pound for members of the public at specified periods during working hours and at reasonable times after hours or at weekends.

All animals must be held at the pound for a minimum of 8 days.

Selection of animals for use in scientific procedures should be made by a veterinarian. No animal identified in any way shall be provided to a scientific establishment, even if unclaimed, except on the written authorisation of the owner.

Animals should not be selected for transfer to a scientific establishment that are sick or debilitated or of a temperament likely to be unsuitable at a scientific establishment.

A register should be kept by the Council of all animals kept at the pound with a description of the breed, sex, approximate age, colour and distinctive markings of each animal. This register should be available for perusal by any member of the public at the pound, and at the Council offices at any time during normal office hours.

Council should provide any person who produces satisfactory proof of ownership, including either a registration or vaccination certificate, photograph or statutory declaration, with details of the scientific establishment to which the animal was taken and the date of release.

Responsibilities of Scientific Establishments

A veterinarian at a scientific establishment must inspect all animals on arrival from a pound and provide appropriate treatment where required. Animals should be given an individual identification number on arrival at a scientific establishment.

Establishments must keep a register of all animals received from municipal pounds. The register should be compiled under the supervision of a veterinarian and provide details of breed, sex, approximate age, colour and distinctive markings of each animal and the name of the municipal pound from which each animal was received and the date it was received. Members of the public should be allowed to examine the register of animals from pounds at a scientific establishment during normal working hours.

Staff experienced in animal care at the scientific establishment should inspect animals at least once daily. A veterinarian should be responsible for the prompt treatment of any animal that is distressed or behaving abnormally.

Establishments must hold animals received from municipal pounds for at least 21 days (including the 8 days the animal was held at the pound) prior to use in scientific procedures.

Members of the public with suitable proof of ownership of a particular animal, including either registration or vaccination certificate, photograph or statutory declaration, should be permitted to inspect animals of that description at a scientific establishment at any time in normal working hours during the 21-day holding period.

Establishments must surrender an animal to an owner if adequate proof of ownership is provided and then notify the Council of the municipality where the animal was obtained.

Daily exercise should be provided for animals kept after the 21-day holding period.

Establishments must keep details in the register of the fate of unclaimed animals received from municipal pounds:

the date of commencement of the scientific procedure and the number or other appropriate identification of the protocol for the scientific procedure as approved by the establishment's animal experimentation ethics committee.

If the animal is not used in scientific procedures, the date of euthanasia.

Animals from pounds must not be transferred between scientific establishments.

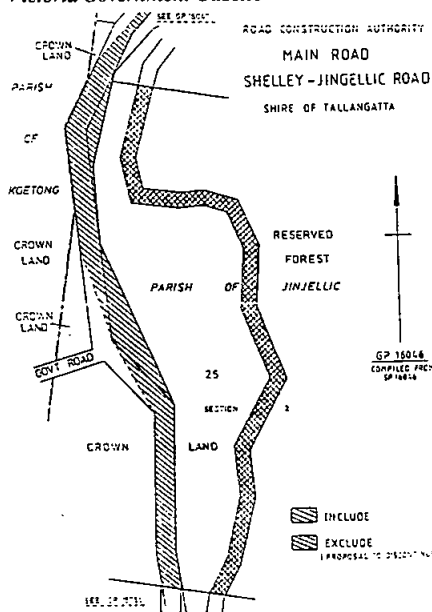
ROAD CONSTRUCTION AUTHORITY

REGULATIONS

Lake Moodemere Recreation Reserve and Public Purposes Reserve

I, Kay Setches, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria, in pursuance of the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978*, do hereby make the following regulations for and with respect to the reserved land in the Parishes of Norong and Carlyle as shown bordered red on plan CN/1.7.87 attached to Department of Conservation, Forests and Lands correspondence No. Rs. 57 (hereinafter called the "Reserve") in respect of which a Committee of Management (hereinafter referred to as the "Committee") has been appointed.

Regulations

1. In these regulations, unless inconsistent with the context or subject-matter—

"Vehicle" includes every conveyance capable of being propelled, pushed or drawn by human, animal, mechanical, electrical or other power and includes a motor car as defined in the *Motor Car Act 1958* but expressly excludes perambulators and push bikes.

2. The Reserve shall be open to the public at all times free of charge, except on such occasions as the Reserve or any portion thereof may be set apart for such activities as the Committee may decide or any of which occasions a fee as may be determined by the Committee from time to time may be charged and taken for admission of every person to the Reserve or any portion thereof.

3. The Committee may set apart any portion or portions of the Reserve for the purpose as the Committee may from time to time decide or as a pleasure ground or place of public resort or recreation.

4. No person shall cross or trespass on any areas set aside as hereinbefore provided during a function authorised by the Committee when such crossing or trespassing would be injurious or be an undue interference to the progress of such function.

5. No person shall climb, jump or get upon or over or under any of the fences or gates in or around the Reserve, or cut or damage or in any way remove any of such fences or gates or any buildings, seats, equipment, trees, shrubs or flowers therein, nor shall any person affix bills or advertisements or writings on any of such fences, gates, buildings, seats, equipment or trees without the consent, in writing, of the Committee.

6. No person shall, without written permission of the Committee, light a fire in the Reserve except in a proper fireplace.

7. No person shall dig or remove any turf or soil or enter any plot enclosed for a plantation of young trees or shrubs or walk on or over any flower bed therein or commit any nuisance or damage or destroy any property or thing in the Reserve.

8. No person shall throw, deposit or leave any glass, filth, rubbish, refuse, junk or waste material of any kind in the Reserve or cause any glass, filth, rubbish, refuse, junk or waste material of any kind to be thrown or deposited upon or left in the Reserve or in or upon any building or structure therein.

9. Any person using the Reserve or any building or structure therein for any purpose consistent with the purposes of the reservation shall, prior to leaving the Reserve, building or structure, collect and remove or cause to be collected and removed all waste material, scraps, bottles, glass or litter of any kind brought into or made by such person in the Reserve, and any person who fails or refuses to collect and remove or cause to be collected and removed all waste material, scraps, bottles, glass or litter of any kind brought into or made by such person therein shall pay to the Committee the cost of removing same and such cost may be recovered by the Committee before a Magistrates Court.

10. No person shall in or upon the Reserve kill, wound, trap or snare or attempt to kill, wound, trap or snare any native bird or other native game or have any dead native bird or other native game or the skin or pelt thereof in his possession.

11. No person shall sell or offer for sale in the Reserve any article of food or drink or any other commodity, or operate any amusement for which a charge is made or erect any tent, booth, stand, building or other structure in the Reserve without the permission in writing of the Committee.

12. No person shall behave in a noisy or disorderly manner or create or take part in any disturbance or commit any act of indecency or offend against decency as regards dress, language or conduct on the Reserve or in any building or structure thereon.

13. No person shall wilfully obstruct, disturb, interrupt or annoy any other person in the proper use of the Reserve, or wilfully obstruct, disturb, interrupt or annoy any employee of the Committee or member of the Police Force in the proper execution of his duty or work in the Reserve.

14. No person shall, without the written permission of the Committee first had and obtained camp in any part of the Reserve and then only in such part of the Reserve as may be set aside by the Committee for the purpose.

15. No person shall give out or distribute any hand-bill, placard, notice, advertisement, book, pamphlet or paper in the Reserve without the consent in writing of the Committee or litter the Reserve by scattering or throwing down any such hand-bill, placard, advertisement, book, pamphlet or paper.

16. (i) No person shall cause, suffer or permit any dog belonging to him or in his charge—

(a) to be brought into or enter or remain in the Reserve unless such dog is and continues to be at all times under proper control on a chain, cord or leash, and unless such dog be effectively restrained from causing annoyance to any person and from damaging or interfering in any way with any property in the Reserve;

(b) to be brought into or enter or remain in any camping area or any portion of the Reserve prohibited to the entry of dogs and indicated by notices.

(ii) Nothing in these regulations prohibits a blind person having in the Reserve a dog that is used by that person as a guide dog.

17. (i) Save as aforesaid no person shall without written permission of the Committee allow an animal belonging to him or in his charge to be brought into or enter or remain in the Reserve with the exceptions of a horse drawing a vehicle or a saddle hack in his charge.

(ii) The Committee may prohibit or limit the use of saddle hacks in the Reserve or portions thereof.

(iii) Any animal found in the Reserve contrary to these Regulations may be seized and impounded or destroyed, and the owner or custodian thereof shall be liable to pay compensation for any damage done by such animal to any property in the Reserve.

18. No person shall bring or cause to be brought into the Reserve an unregistered or uninsured motor cycle or recreational type vehicle.

19. Maximum vehicle speed limit in the Reserve area to be 25 km per hour.

20. No person shall remove, displace or disfigure any board, plate or tablet or any support, fastening or fitting used or constructed for the exhibition of any regulations or notice fixed or set up by the Committee in the Reserve.

21. The Committee shall have the power and authority to close the Reserve or any part thereof and exclude the public therefrom whenever the Committee considers it necessary to carry out repairs, alterations or reconditioning of turf or for any other purpose having as its object the proper care and management of the Reserve.

22. (i) Any person carrying or using any firearm, poison, trap or snare or net in the Reserve without written permission of the Committee shall surrender the same on demand to any authorised officer who shall issue a receipt therefor.

(ii) The person apparently entitled to any such article may collect it from the office of the Committee, after completion of investigations and legal proceedings, if any, by the Committee in relation to any offence alleged against the person who surrendered the same.

23. Any person offending against any of the Regulations may, in addition to any other penalty to which he may be liable, be removed from the Reserve, by a member of the Police Force or any employee of the Committee, and any person so removed shall not again enter the Reserve during the day he is so removed.

24. No person shall aid, abet, counsel or procure any other person in doing any act or thing which is a breach of these Regulations— (Rs. 57).

These regulations are in lieu of and revoke any previous regulations.

1. This Order is called the Office of Schools Administration Order 1988.
2. This Order is made under the powers conferred by section 23B of the *Public Service Act 1974* and all other enabling powers.
3. This Order takes effect on and after the date of its publication in the *Government Gazette*.
4. The purpose of this Order is to establish the Schools Division of the Ministry of Education as an Associated Administrative Unit known as the Office of Schools Administration to operate in accordance with the policies and directives of the Ministry.
5. Schedule Two of the *Public Service Act 1974* is amended by—
 - (a) adding, in relation to the administrative unit of "Ministry of Education" in column one, the unit of "Office of Schools Administration" to column three immediately before the unit of "Office of the State Board of Education"; and
 - (b) adding, in relation to the unit of "Office of Schools Administration" in column three, the office of "Chief General Manager, Office of Schools Administration" to column four.
6. The functions of the Office of Schools Administration are:
 - To improve the quality of education for all students.
 - To ensure that each student has the opportunity to be provided with a broad general education.
 - To ensure that public education is based on the principle of equity.
 - To develop structures and processes that enable the social justice objectives of the Ministry of Education to be realised.
 - To maximise the proportion of total resources made directly available to schools.
 - To develop mechanisms that redress disadvantage in the allocation of resources to schools.
 - To provide high quality curriculum and other support services to schools from locations close to schools.
 - To decentralise decision-making by the transfer of operational responsibilities to regions and schools.
 - To give schools greater discretion in the use of their resources.
 - To enhance the capacity of schools to determine their own educational programs within the framework provided by central policies and guidelines, available resources and industrial agreements.
 - To create a simplified and decentralised administrative system.
 - To provide a more effective, efficient and responsive administration.
 - To establish a strong policy focus so that Office of Schools Administration is able to play a proactive role in responding to future needs in education.
 - To provide an increased capacity for co-ordinated policy development and planning.
 - To enable the system to respond effectively to Government policy initiatives and to the changing needs of students, schools and the community.
 - To facilitate the involvement of parents, teachers and students in participative processes at the different levels of decision-making both directly and through representative groups.
 - To provide effective evaluation and accountability provisions through all levels of the system.
 - To ensure that schools are accountable to both their local community and to the Office of Schools Administration for the conduct of their educational programs.
 - To ensure that the administration is accountable for its performance in the provision of support to schools.

To provide for co-ordinated professional and staff development at all levels of the system.

7. The functions of the Office of Schools Administration shall be performed in accordance with the directions of the Chief Executive of the Ministry or in accordance with arrangements approved by the Chief Executive.

2. This Order is made under the powers conferred by s. 88 of the *Constitution Act* 1975, and all other enabling powers.

Notwithstanding anything in any other Order in Council (whether made on or after the commencement of this Order) a Member of Parliament or an officer in the Public Service who is appointed to a public office shall be entitled to any reasonable expenses or allowances but he or she shall not be entitled to any salary or remuneration payable in respect of that office.
5. EMPLOYMENT OF ELECTORATE OFFICERS ORDER 1988

1. This Order is called Employment of Electorate Officers Order 1988.
2. This Order is made under all enabling powers of the Governor in Council.

4. For the purpose of this Order "electorate officer" means a person who is employed with that designation to assist a Member of Parliament in discharging the Member's parliamentary duties within the Member's electorate and whose salary or remuneration is drawn from the Consolidated fund.
5. The purposes of this Order are to confirm the status of the employment of electorate officers as employment under the Crown and to designate the responsible Minister of the Crown.
6. The Minister for Property and Services is designated as the employer of electorate officers on behalf of the State.

The Minister for Property and Services is empowered to delegate to the Secretary of the House Committee of the Parliament or to any other person in the service of the State all or any of his or her responsibilities, powers, authorities, duties and functions that the Minister has in his or her capacity as employer of electorate officers.

8. Where a delegation is made under clause 7:

- (a) the delegation does not prevent the discharge, exercise or performance of the responsibility, power, authority, duty or function by the Minister;
- (b) the declaration may be made subject to such conditions or limitations as the Minister may specify;
- (c) a responsibility, power, authority, duty or function so delegated, when discharged, exercised or performed by the delegate, shall be taken to have been discharged, exercised or performed by the Minister; and
- (d) the delegation may be acted on by any person for the time being acting in or performing the duties of the office held by the delegate concerned.

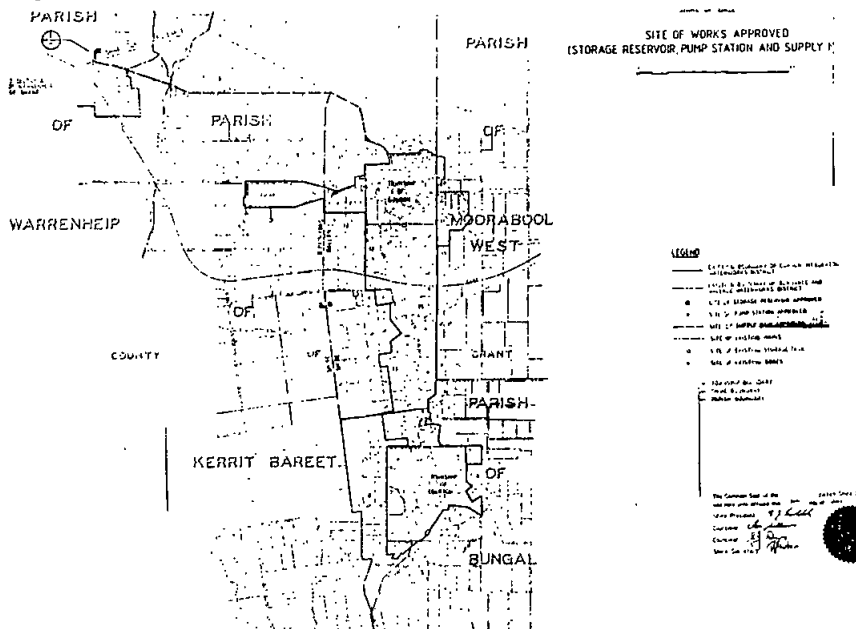

And whereas by and with that Order and three subsequent Orders dated 30 January 1985, 17 September 1985 and 24 May 1988 the Board became the responsible body with jurisdiction over eight Sewerage Districts, one Drainage Area, one Waterworks District, one Urban District, one Rural District and the area supplied by the Geelong Waterworks.

And whereas the Board currently levies the one rate over its Rural District, one rate over the balance of its Water Districts and one rate over all its Sewerage Districts and Drainage Area.

And whereas the Board wishes to consolidate and rationalise its operations and end up with one Rural District, one consolidated Waterworks District and one consolidated Sewerage District.

And whereas under the following provisions of the *Water and Sewerage Authorities (Restructuring) Act 1983*, the *Water Act 1958*, the *Water and Sewerage Authorities (Further Restructuring) Act 1984* and the *Geelong Waterworks and Sewerage Act 1958*, the Governor in Council may:

- (a) Section 16 (bb) Restructuring Act—declare any Urban District to be a Waterworks District;
- (b) Section 16 (ba) Restructuring Act—
 - (i) unite any two or more Waterworks Districts;
 - (ii) Unite any two or more Sewerage Districts.
- (c) Section 16 (b) Restructuring Act—Increase or diminish the extent of or abolish any District.
- (d) Section 234 Water Act—Unite any two or more Urban Districts.

(e) Section 61 Geelong Act—Declare what lands form part of Geelong's Drainage Area, and from time to time, increase the extent of that area.

- (e) Prescribing rules to be observed by persons occupying such stands (including rules for securing and cleanliness of carts, trucks, barrows, boxes, baskets and crates used by such persons and the wholesomeness and cleanliness of the commodities sold or offered or exposed for sale) and with respect to the conduct of such persons.
- (f) Prescribing the nature and size of hand-trucks barrows or other vehicles to be used on such stands and prohibiting any animal whether attached to any truck, barrow or vehicle or not from standing on any such stand during the time fixed for occupation thereof by street hawkers and itinerant traders.
- (g) Providing the form of authority to be issued by occupying such stands the conditions upon which such authorities are issued and under which they will be permitted to be transferred, and the fee to

be paid for a transfer of any such authority; and prohibiting any person who is not named in such an authority or is not a transferee of such an authority duly permitted under the said by-laws from occupying any such stand.
