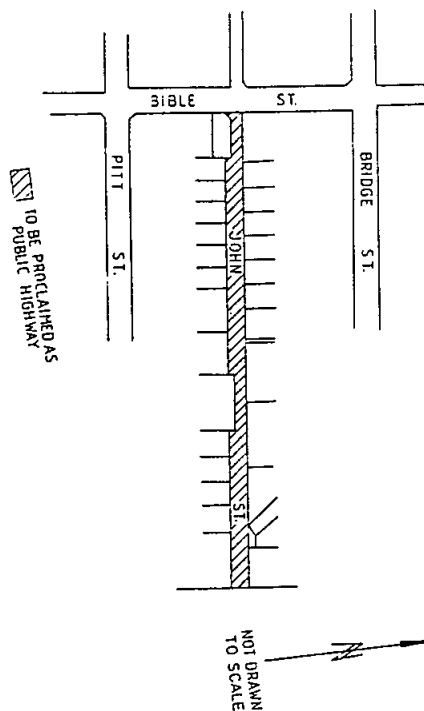

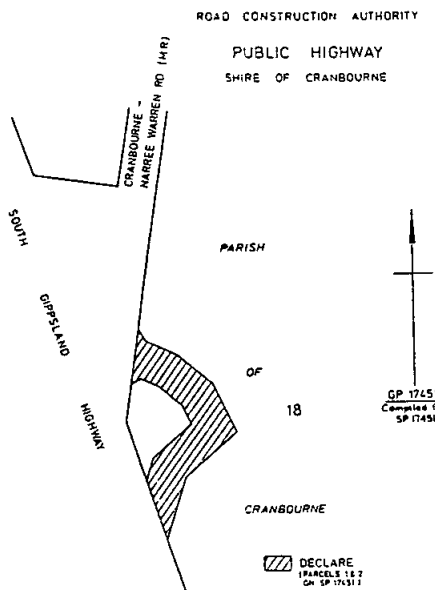

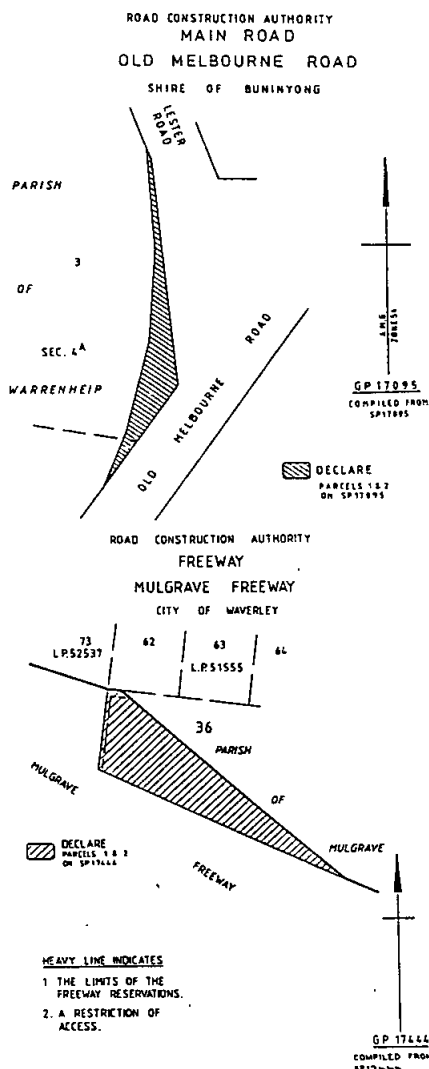
*Transport Act 1983***DECLARATIONS AND DEDICATIONS OF ROADS**

FUEL EMERGENCY ACT 1977

Schedule of Terms and Conditions relating to the sale and supply of motor spirit and automotive liquified petroleum gas (LPG).

Motor Spirit and LPG shall not be sold or supplied from any service station on or after 6.00 p.m. on 21 February 1988 unless the following conditions are complied with:

(a) The sale or supply of motor spirit and LPG to any person at any time shall not exceed in value \$15.

(b) Motor spirit and LPG shall only be sold or supplied on even-numbered days of the month to motor vehicles on which the last numeral of the number plate is an even number.

(c) Motor spirit and LPG shall only be sold or supplied on odd-numbered days of the month to motor vehicles on which the last numeral on the number plate is an odd number.

(d) Motor spirit and LPG shall only be sold or supplied on odd-numbered days of the month to motor vehicles on which there is no numeral on the number plate.

(e) Motor spirit and LPG shall only be supplied into the tank fitted to a registered road vehicle.

(f) The sale and supply of motor spirit and LPG is exempted from the restrictions of paragraphs (a), (b), (c) and (d) above where the person seeking supply—

produces to you or to any uniformed member of the police force, present at the service station, a written statement signed by a member of the police force for the time being in charge of a Police station to the effect that the person concerned has satisfied that member of the police force that, in connection with essential uses, he has a special, immediate and urgent need justifying the supply to him, if available of motor spirit and LPG during the period in respect of which this Direction operates.

(g) The sale or supply of motor spirit to motor cycles, motor scooters, mopeds or other like two wheeled vehicles shall be exempt from the restrictions of paragraphs (b) and (c) above.

(h) The owners, operators and employees of service stations listed in Schedule 3 may decline to provide motor spirit or LPG to any person not in possession of a written statement of the type referred to in paragraph (f).

(i) Subject to the above conditions, motor spirit and LPG shall be available for sale or supply to any person without discrimination.

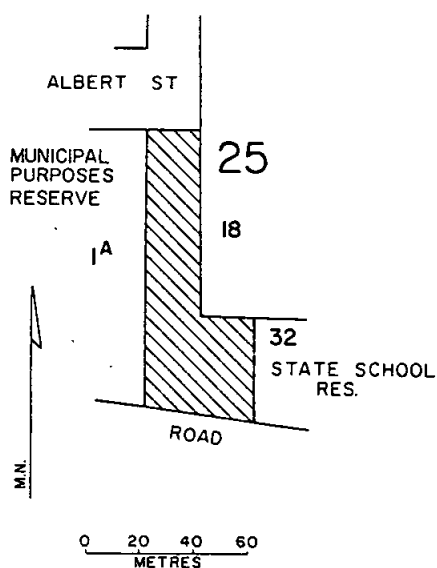

By-Law No. 50

Collection, Removal and Disposal of Refuse and Garbage

A By-Law of the Shire of Gisborne made under the *Health Act 1958*, section 93, and the *Local Government Act 1958* for the purpose of the collection, removal and disposal of refuse and garbage.

In pursuance of the powers conferred by the *Health Act 1958* and the *Local Government Act 1958* the President, Councillors and Ratepayers of the Shire of Gisborne order as follows:

1. In this By-Law, unless consistent with the context or subject matter—

"Approved" means approved in writing by the Council of the Shire of Gisborne.

"Cluster House" means a dwelling constructed on a separate lot comprised in a cluster subdivision or a cluster redevelopment as defined in the *Cluster Titles Act 1974*.

"Council" means the Council of the Shire of Gisborne.

"Flat" means a portion of a building used or intended adapted or designed as a separate dwelling and excludes a "cluster house".

"Officer" means an authorised officer of the Council.

"Multi Unit Development" means a development in which more than one flat or cluster house is constructed.

"Premises" means all premises in respect to which the Council makes a charge for the proper collection removal and disposal of refuse and rubbish and has the same meaning as in the *Health Act 1958*.

"Proprietor" means the proprietor of any premises and includes the owner, occupier, or any person having the management or control thereof.

"Refuse and Garbage" means any waste produced or accumulated in or about any house, building or premises but does not include sewerage and manure. Provided always that Council may refuse to collect any material which in its opinion is capable of causing bodily injury to the machinery operators or is likely to cause unreasonable damage to the machinery and/or equipment.

2. The proprietor of every house, building or premises shall keep and maintain at all times upon his premises a properly constructed receptacle in which he shall from time to time cause to be deposited all refuse in or about such house, building or premises.

3. Such receptacle shall be of an approved material, of not more than 240 litres capacity, and fitted with approved wheels, lid and handle to allow emptying of the contents by mechanical means.

4. Nothing in this By-Law shall prevent the use of receptacles made of galvanised iron or other approved material of not more than 50 litres capacity, fitted with approved lids and handles, up to and including 7 March 1988.

5. No person shall place or cause or permit to be placed any slops, ash or liquid waste in such receptacle, or any moist refuse in the receptacle unless the moist refuse has been effectively wrapped to prevent the escape of any moisture.

6. No person shall place in any receptacle any matter which is offensive or likely to become offensive, or any matter which is dangerous to health.

7. The proprietor of every premises shall keep and maintain each receptacle in good condition and in a clean and sanitary manner.

8. (a) The proprietor of all dwellings in a multi-unit development where a common garbage collection point is provided shall cause at such hours and on such days as may be appointed by the Council for the removal of refuse, such receptacles to be deposited at the garbage collection point in order that the contents of the receptacles may be conveniently removed by the contractor or other person authorised or employed in that behalf by the Council.

(b) The proprietors of all dwellings not in a multi-unit development or of dwellings in multi-unit developments where a common garbage collection point is not provided, shall cause at such hours of such days as may be appointed by the Council for the removal of refuse, such receptacles to be deposited close to and behind the kerb of the street on which such dwellings abutt in order that the contents of such receptacles may be conveniently removed by the contractor or other person authorised or employed in that behalf by the Council.

(c) A person shall not place or cause to be placed any such receptacles in or upon any road, pavement, footpath or right-of-way for the removal of refuse therefrom except in the case of business premises built on the street alignment and it is not possible to deposit the receptacle in compliance with Clauses 8 (a) or 8 (b) of this By-Law.

9. The proprietor of every house, shop, factory, warehouse or building where a collection service is not provided by Council shall keep and maintain at all times upon his premises properly constructed containers as may be approved by an officer from time to time in which he shall cause to be deposited all refuse produced or accumulated in or about such house, shop, factory, warehouse or building.

10. The proprietor of every house, shop, factory, warehouse or building where a collection service is not provided by Council shall cause refuse to be removed from such in properly constructed containers as are provided and disposed of in such manner as not to cause nuisance, danger to health or offensiveness.

11. The Council shall cause all refuse removed from any premises to be disposed of in an efficient, proper and sanitary manner, pursuant to the requirements of the *Health (General Sanitary) Regulations 1984*.

12. The Council shall cause all vehicles used for the collection and disposal of refuse to be properly constructed to an approved design, to be maintained in a sanitary manner and to be kept in a proper state of repair.

13. Any person doing any act forbidden to be done or failing to do any act directed to be done by this By-Law shall be guilty of an offence against this By-Law and upon conviction shall be liable to a penalty of up to the maximum allowed by the Local Government Act and in the case of a continuing offence shall be liable to a penalty up to the maximum allowed by the Local Government Act for each day the offence is continued after a conviction or order by any court.

14. This By-Law shall apply to and have operation throughout the areas within the Shire of Gisborne defined in the schedule attached hereto and as amended from time to time.

15. By-law No. 49 is hereby repealed.

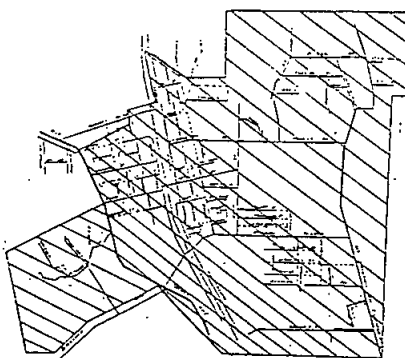

Fuel Emergency Act 1977

The Schedule of Terms and Conditions relating to the sale and supply of motor spirit and automotive liquefied petroleum gas (Schedule 2) applies to the whole of the State of Victoria.

Schedule 2

Fuel Emergency Act 1977

Schedule of Terms and Conditions relating to the sale and supply of motor spirit and automotive liquefied petroleum gas (LPG).

Motor Spirit and LPG shall not be sold or supplied from any service station on or after midnight on 22 February 1988 unless the following conditions are complied with:

- (a) The sale or supply of motor spirit and LPG to any person at any time shall not exceed in value \$10.

- (b) Motor spirit and LPG shall only be sold or supplied on even-numbered days of the month to motor vehicles on which the last numeral of the number plate is an even number.
- (c) Motor spirit and LPG shall only be sold or supplied on odd-numbered days of the month to motor vehicles on which the last numeral on the number plate is an odd number.
- (d) Motor spirit and LPG shall only be sold or supplied on odd-numbered days of the month to motor vehicles on which there is no numeral on the number plate.
- (e) Motor spirit and LPG shall only be supplied into the tank fitted to a registered road vehicle.
- (f) The sale and supply of motor spirit and LPG is exempted from the restrictions of paragraphs (a), (b), (c) and (d) above where the person seeking supply—
produces to you or to any uniformed member of the police force, present at the service station, a written statement signed by a member of the police force for the time being in charge of a Police station to the effect that the person concerned has satisfied that member of the police force that, in connection with essential uses, he has a special, immediate and urgent need justifying the supply to him, if available, of motor spirit and LPG during the period in respect of which this direction operates.
- (g) The sale or supply of motor spirit to motor cycles, motor scooters, mopeds or other like two-wheeled vehicles shall be exempt from the restrictions of paragraphs (b) and (c) above.
- (h) The owners, operators and employees of service stations listed in Schedule 3 may decline to provide motor spirit or LPG to any person not in possession of a written statement of the type referred to in paragraph (f) above.
- (i) Subject to the above conditions, motor spirit and LPG shall be available for sale or supply to any person without discrimination.

 - specify that the boundary of the area over which the Service has administrative jurisdiction is the boundary of the area occupied by the Municipalities of Arapiles, Ararat, Ararat (City), Avoca, Ballan, Ballarat, Ballarat (City), Birchip, Bungaree, Buninyong, Creswick, Daylesford and Glenlyon, Dimboola, Donald, Dunmunkle, Grenville, Horsham, Kaniva, Kara Kara, Kowree, Lexton, Lowan, Ripon, St. Arnaud, Sebastopol, Stawell, Talbot, Clunes, Warracknabeal and Wimmera, and Karkaroc, excepting that part comprising the parishes, or parts thereof, of Patchewollock North, Dering, Tyenna, Patchewollock, Dennyng and Gorya, and that part of the Municipality of Hampden comprising the Parishes of Skipton and Borriyalloak.
