Notice of Approval of Amendment Amendment L7

The Acting Minister for Planning and Environment has approved Amendment L7 to the Melbourne Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette

The amendment allows the demolition of the building on land at 179 Collins Street, Melbourne and the partial demolition of existing buildings known as the Theosophical Society Building and the Duty Free Building on land at 181–189 Collins Street, Melbourne and the development and use of the whole of the land at 179–219 Collins Street, Melbourne, for the purposes of the restoration and re-use of the Regent Theatre, office accommodation, shops, restaurants, cinemas and uses ancillary to these purposes including associated car parking and the redesign and development of the City Square.
