NOTICE OF CLOSURE OF LAKE
MUIRHEAD TO HUNTING

I give notice under section 86 of the *Wildlife Act 1975* that—

- (a) the taking, destroying or hunting of any kind or species of wildlife is prohibited in the areas described in the Schedule during the period beginning on 18 March 1989 and ending on 31 May 1989;
- (b) a person who takes, destroys or hunts any kind or species of wildlife in that area during that period is guilty of an offence and liable to a penalty not exceeding \$200.

Lake Muirhead, Shire of Ararat and land within 500 metres from any part of the water shoreline of Lake Muirhead.
