Notice of Approval of Amendment
Amendment RL55

The Minister for Planning and Environment has approved the above amendment.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment rezones land in the vicinity of Hampshire Road and Ballarat Road, Sunshine, to provide for the controlled development of a major expansion to the Sunshine District Centre. The amendment will in particular facilitate the development of—

- (1) a major shopping centre;
- (2) a peripheral area principally for offices and peripheral sales;
- (3) other peripheral land principally for offices;
- (4) a new road system including the widening of Anderson Road to service the expanded Sunshine District Centre; and
- (5) the closure of part of Hampshire Road and part of Service Street.

A copy of the amendment can be inspected free of charge, during office hours, at the office of the City of Sunshine, Municipal Offices, Alexandra Avenue, Sunshine and the Ministry for Planning and Environment, 477 Collins Street, Melbourne.

A copy of the Regional Section of the amendment can also be inspected at the offices of each Council within the Metropolitan Region.
