Notice of Approval of Amendment
Amendment S4

The Minister for Planning and Environment has approved Amendment S4 to all Planning Schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment sets out the planning policies for the retention and re-establishment of native vegetation on all land in Victoria comprised in parcels of more than 0.4 hectare.

The amendment provides for a permit to remove, destroy or lop native vegetation. It is a temporary control until 30 November 1990 to allow consideration of similar proposals in Amendment S5.

The Minister for Planning and Environment has prepared Amendment S5 to all Planning Schemes in Victoria.

The amendment sets out the planning policies for the retention and re-establishment of native vegetation on all land in Victoria comprised in parcels of more than 0.4 hectare and provides for a permit to remove, destroy or lop native vegetation.
