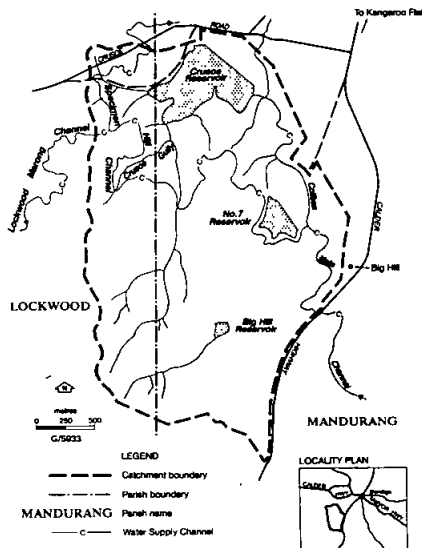

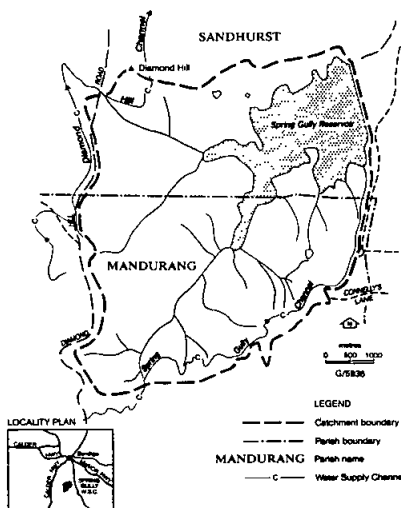
CRUSOE GROUP RESERVOIRS (BENDIGO) WATER SUPPLY CATCHMENT

The catchment to three service reservoirs (Crusoe, Big Hill and No. 7) controlled by the Rural Water Commission, a section of the Coliban Main Channel and an area of public land, situated on tributaries of Bendigo Creek in the Parish of Mandurang and as indicated on Plan No. S-1480, hereunder, to be known as the Crusoe Group Reservoirs (Bendigo) water supply catchment area.

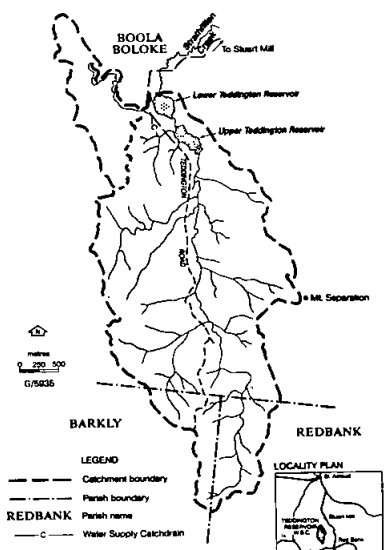


SPRING GULLY RESERVOIR (BENDIGO) WATER SUPPLY CATCHMENT

The catchment to a service reservoir controlled by the Rural Water Commission, the wall of which is situated on Spring Gully within section H of the Parish of Sandhurst and as indicated on Plan No. S-1479, hereunder, to be known as the Spring Gully Reservoir (Bendigo) water supply catchment area.

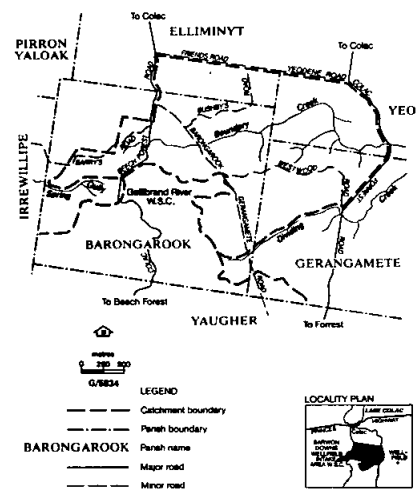


TEDDINGTON RESERVOIR (STUART MILL) WATER SUPPLY CATCHMENT

BARWON DOWNS WELLFIELD INTAKE AREA (GEELONG) WATER SUPPLY CATCHMENT

The catchment (intake area) to a wellfield located within the Parish of Gerangamete and controlled by the Geelong and District Water Board, the catchment being situated within the Barongarook Hills and consisting of parts of the parishes of Barongarook, Elliminyt, Gerangamete and Yeo and as indicated on Plan No. S-1483, hereunder, to be known as the Barwon Downs Wellfield Intake Area (Geelong) water supply catchment area.

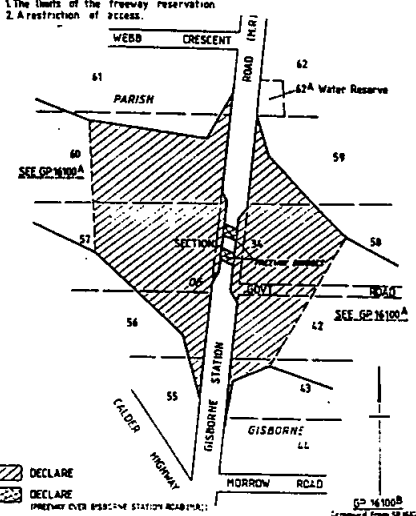
