\$100 000

The co-operation of the general public is sought with a view to establishing the identity of the person responsible for the abduction of Sharon Wills, aged 10 years, from her home in Hillcrest Road, Ringwood, early on the morning of Tuesday, 27 December 1988. The child was later sexually assaulted by the offender at an unknown location. After being detained for some eighteen hours, the child was subsequently released by the offender in the grounds of the Bayswater High School, Orchard Road, Bayswater, at approximately midnight on 28 December 1988.

A reward of one hundred thousand dollars (\$100 000) will be paid at the discretion of the Chief Commissioner of Police, by the Government of Victoria for information leading to the apprehension and conviction of the person or persons responsible for this offence.

Industrial Relations Commission of Victoria DENTAL TECHNICIANS CONCILIATION AND ARBITRATION BOARD 4% Second Tier Wage Increase

On 19 April 1989 the Dental Technicians Conciliation and Arbitration Board made an Award increasing wage rates for dental nurses and technicians employed under Part 1 of the Dental Technicians Award by 4%. Included in the Award is the following provision relating to enterprise agreements.

Any employer who has not reached a second tier agreement with the Union prior to the operative date of this Award may initiate negotiations with the Union for a restructuring and efficiency agreement in accordance with the Commission's March 1987 Wage Fixing Principles. Any dispute in relation to such negotiations may be referred to the Board. This provision shall not apply after 1 July 1989.

Any employer may make application to the Board seeking an enterprise agreement pursuant to this clause. Any such employer will be exempted from the Award made on 19 April 1989, upon the Secretary of the Board's receipt of the application. Employers seeking an

exemption from the operation of the Award in order to negotiate an enterprise agreement with the Union should contact the Federated Miscellaneous Workers' Union of Australia (Victorian Branch) and the Board's Secretary as soon as possible.

NURSERYMENS CONCILIATION AND ARBITRATION BOARD

The Nurserymens Board gives notice that it intends to vary the Nurserymens Award to provide for a 4% Second Tier increase in wage rates. The Board in doing so will be guided by the Commission in Full Session's decision in the State Wage Case of March 1988 (Decision No. 88/0036). Providing that where the vast majority of employees in the trade have received the benefit of a Second Tier Movement, the decision of Deputy President Keogh of the Australian Conciliation and Arbitration Commission (Print H. 0121) regarding the Metal Industry Award 1984, may be seen as an appropriate guide for Conciliation and Arbitration Boards.

The Nurserymens Board directs employers subject to its jurisdiction who have not already done so to immediately enter into negotiations with its employees and/or The Australian Workers' Union of Australia, an association of employees, which has requested such negotiations. Employers may elect to conduct such negotiations through an employer association or federation.

The Nurserymens Conciliation and Arbitration Board will meet at 10.00 a.m. on Wednesday, 21 June 1989. At that meeting the Board proposes to vary the Nurserymens Award to provide for a 4% second tier increase.

Any employer who has not finalised a plant or enterprise agreement in accordance with the State Wage Case of April 1987 by 16 June 1989 is at liberty to apply for exemption from the proposed second tier award. Any employer seeking information on the proposed award variations should contact either the Registrar of the Commission or the Secretary to the Conciliation and Arbitration Board.

Consumer Affairs Act 1972
**INTERIM ORDER PROHIBITING THE
SUPPLY OF DANGEROUS GOODS**

Whereas Glenn Carleton, Acting Director of Consumer Affairs, notwithstanding that he has not fully investigated the matter, has recommended to me pursuant to section 57C (1) of the *Consumer Affairs Act 1972* that the supply of goods, namely:

Blowgun Survival Weapon should by reason of their being dangerous be prohibited.

And whereas I, Thomas William Roper, Minister for Consumer Affairs believe that the supply of goods of that class or description ought, in the interest of the safety of the public, be prohibited immediately.
