**PROCLAMATION**

Prescribing Tributyl Tin to be a Prohibited Constituent of any Agricultural Chemical used other than for certain purposes

I, Sir John McI. Young, Administrator of Victoria, acting with the advice of the Executive Council and under sections 6A and 10A of the *Agricultural Chemicals Act 1958*:

1. Amend the Proclamation made on 20 January 1987 and published in the *Government Gazette* on 21 January 1987, as amended by proclamations made on 28 July 1987, and 29 November 1988 and published respectively in the *Government Gazette* on 29 July 1987 and 30 November 1988 by adding the following item 41 to the Schedule of the Proclamation—

41. Tributyl tin	As an agricultural chemical except where written consent has been given by the Environment Protection Authority.

Regulations

**SANDALONG PARK, MILDURA**

I, Kay Setches, Her Majesty's Minister for Conservation, Forests and Lands for the State of Victoria, in pursuance of the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978* do hereby make the following regulations for or with respect to the remaining Crown lands in the Parish of Mildura temporarily reserved as sites for Public Recreation by Orders in Council of 10 October 1932, 18 November 1935, 26 July 1948 and 27 April 1977 and known as Sandalong Park (hereinafter called "the Reserve") in respect of which a Committee of Management (hereinafter called "the Committee") has been appointed.

Regulations

1. The Reserve shall be open to the public free of charge except on such days as the Reserve may be set apart for sporting or athletic events, shows, fetes, musical performances, outdoor gatherings or holiday amusements, or any other special event, on any of which occasions an admission fee may be charged.
2. No person shall—
  - (a) Enter or remain in the Reserve who may offend against decency as regards dress, language or conduct, or who may behave in a disorderly or offensive manner, or create or take part in any disturbance.
  - (b) Carry or discharge any firearm or airgun in the Reserve.
  - (c) Obstruct, hinder or interfere with any person under authority from or employed by the Committee at the Reserve.
  - (d) Bring or sell or distribute in the Reserve, any intoxicating liquor unless authorised in writing by the Committee and holding a licence or permit as required pursuant to the provisions of the Liquor Control Act and then only in such place or places, or portion of the Reserve as may be set apart for the purpose by the Committee.
  - (e) Gamble publicly in any part of the Reserve without permission in writing of the Committee first obtained.
  - (f) Light a fire in the Reserve except at such places as are set apart for the purpose by the Committee.
  - (g) Damage or remove any trees, shrubs, plants or flowers in the Reserve.
  - (h) Remove any earth, sand, stones, marble, gravel or any other material from the Reserve.

- (i) Exercise or train any horse or pony on the Reserve or any part hereof without the consent in writing of the Committee.
  - (j) Cause or permit any outcry, sound or noise to be emitted from an amplifier, loud speaker, public address system or like instrument without first obtaining the written permission of the Committee and such permission may be granted subject to such terms, conditions and restrictions as may be imposed by the Committee.
  - (k) Deposit or leave any glass bottle, tin can, waste paper, garbage or litter of any kind in the Reserve except in a receptacle provided for that purpose by the Committee.
  - (l) Damage or injure in any way any of the buildings and fittings, gates, fences, seats or any other property in the Reserve and in the event of such damage occurring, the person, club or other organisation responsible shall pay the Committee the cost of making good and repairing such damage.
  - (m) Enter the Reserve or pass over the playing area or oval with any vehicle or on horseback without the permission of the Committee first obtained, nor ride or drive amongst or to the danger or annoyance of persons assembled on any part of the Reserve.
  - (n) Commit any nuisance in the Reserve.
  - (o) In or upon the Reserve, kill, wound, trap or snare, or attempt to kill, wound, trap or snare, any bird or other native game, or have any dead bird or native game or skin or pelt thereof in his/her possession.
3. The Committee shall have the power to hold sporting and athletic events, entertainments, shows or performances in the Reserve, and to make a charge for admission thereto as herein provided.
4. The Committee shall have power to let any portion of the Reserve to any club, association, person or society, for the purpose of holding entertainment, performances, shows or sports, subject to the payment of such fees and on such terms as it may be deemed to be reasonable and consistent with these regulations, and to authorise any club, association, society or person to make a charge for admission thereto as provided herein before.
5. No club, association, society or person shall hold any event, entertainment, performance show or ceremony in any part of the Reserve without the authority of the Committee.
6. No person except the Committee or its Officers or employees on duty shall enter any

part of the Reserve when a charge is made for admission without first paying the fees chargeable for admission.

7. No person shall park a motor car vehicle or motorcycle within the Reserve except at such places as are set apart for the purpose by the Committee.

8. No person shall put in the Reserve any cattle, horses, sheep, goats, pigs or any other animals without the permission in writing of the Committee first obtained. All dogs must at all times be controlled by a chain or leash within the Reserve.

9. No person shall camp in the Reserve or erect herein any building or any other structure without the consent in writing of the Committee being first obtained.

10. No person shall sell or offer for sale in the Reserve any article without the prior permission in writing of the Committee and then to such conditions as the Committee may determine.

11. No person shall erect or display any signs, advertising material or notices within the Reserve without the permission of the Committee in writing.

These Regulations are in lieu of all previous Regulations, relating to the said lands, which are hereby rescinded.

#### REGULATIONS FOR THE CARE PROTECTION AND MANAGEMENT OF THE TEESDALE RECREATION RESERVE

I, Kay Setches, Her Majesty's Minister of Conservation, Forests and Lands in the State of Victoria in pursuance of the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978* do hereby make the following regulations for or with respect to the Crown land in the Township of Teesdale, Parish of Carrah temporarily reserved for Public Recreation by Order in Council dated 5 November 1986 (hereunder called the "Reserve") in respect of which a Committee of Management (hereinafter referred to as the "Committee") has been appointed.

1. No person shall—

- (a) Enter or remain in the Reserve who behaves in a disorderly manner or creates or takes part in any disturbance or

commits any act of indecency as regards dress, language or conduct.

- (b) Light or cause to be lit any fire in the Reserve except in fire places as may be provided by the Committee.
- (c) Deposit in the Reserve any lighted tobacco, cigarette, cigar or match or any other burning material or thing within the reserve.
- (d) Bring or allow any animal to graze or trespass in the area.
- (e) Obstruct, disturb or annoy any officer or employee of the Committee in the lawful execution of his work or duty.

2. No person shall unless authorised in writing by the Committee—

- (a) Carry or bring into the Reserve traps, poisons, snares, firearms or any weapon capable of discharging a missile.
- (b) Deposit in the Reserve any rubbish, litter or refuse of any kind except in receptacles for that purpose, nor post bills on fences gates or trees or paint names or letters, marks or other matter on trees, gates, post or fences or otherwise deface same nor break, cut dig-up, damage or injure in any way or take away the whole or portion of any tree, shrub, plant, seed, undergrowth, fern, flower, property, soil or any vegetation in the Reserve.
- (c) Remove, displace or damage any board or fitting for the exhibition of any regulations or any notice fixed or set up in the Reserve.
- (d) Ride or drive any vehicle, motor or otherwise, within the Reserve, except on the roadways, and then only at a speed not exceeding 10 km/h.
- (e) Camp nor erect or place any building, tent, booth or other structure in any part of the reserve.

Every person infringing these Regulations in any respect shall be liable to expulsion from the Reserve in addition to any other penalty to which such person may be liable—(Rs. 13314).

AMENDMENT TO THE REGULATIONS  
FOR THE CARE, PROTECTION AND  
MANAGEMENT OF THE RESERVE FOR  
PUBLIC PARK AND GARDEN AND FOR  
RECREATION AND CAMPING PURPOSES  
IN THE TOWNSHIP OF WARRAGUL

I, Kay Setches, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria in pursuance of the powers conferred on me by section 13 of the *Crown Land Reserves Act 1978*, do hereby amend the Regulations made on 22 January 1952 (see *Government Gazette* dated 30 January 1952) and amended from time to time, the last time being 4 October 1983 (see *Government Gazette*, dated 12 October 1983 page 3351) for or with respect to the above Reserve as follows:

Regulation 9 of the said Regulations shall be amended to read—

“The charges for camping in the portion or portions determined from time to time apart for the purpose shall be set by the Council of the Shire of Warragul”.

REGULATIONS FOR THE CARE,  
PROTECTION AND MANAGEMENT OF  
THE FYANSFORD RECREATION  
RESERVE

I, Kay Setches, Her Majesty's Minister for Conservation, Forests and Lands in the State of Victoria in pursuance of the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978* do hereby make the following Regulations for or with respect to the Crown Land in the Township of Fyansford, Parish of Gheringhap, temporarily reserved for Public Recreation by Order in Council dated 20 November 1984 (hereinafter called the reserve) in respect of which a Committee of Management (hereinafter referred to as the “Committee”) has been appointed.

*Entry to the Reserve*

1. (a) The Reserve shall be open to the public from sunrise to sunset, free of charge except on the days and between the hours determined by the Committee from time to time.

(b) The Committee may close the Reserve or any part thereof at any time for cleaning maintenance or other works or if in the opinion of the Committee undue risks will arise if the Reserve remains open to the public.

(c) The Committee may fix fees for entry to or use of the Reserve from time to time.

(d) No person shall enter or use the Reserve without first paying the fee fixed by the Committee or pursuant to these Regulations for such entry or use.

(e) Membership tickets tokens or licences issued to any person for entry to or use of the Reserve shall not be transferable to any other person.

(f) No person shall without the authority of the Committee enter or remain within or use the Reserve or any part of the Reserve at any time during which it is closed to the public.

#### *Removal of Persons from a Reserve*

2. (a) Any person who offends against these Regulations or who in the opinion of the Committee is about to offend against these Regulations shall if requested by the Committee or an Officer of the Committee immediately leave the Reserve.

(b) An Officer of the Committee may remove from the Reserve any person who refuses to obey a direction to leave.

#### *Officers and Employees*

3. (a) Nothing in these Regulations shall prevent any of the Committee, member of the Police Force, contractor of the Committee or workman employed by a contractor from doing such things and taking such action as may be required in the course of his or her duties.

(b) No person shall interfere with, hinder or obstruct an employee of the Committee in the course of his or her duties within the Reserve.

(c) Every person within the Reserve shall obey the lawful directions of any employee of the Committee or member of the Police Force.

#### *Behaviour within Reserves*

4. No person shall:

- (a) Interfere with, break, damage, remove, displace or deface any vegetation garden bed, pavement, seat, table, fence, fixture, building improvement or structure within the reserve whether affixed thereto or not;
- (b) Throw or roll any stone or missile or carry or shoot any firearm within the Reserve;
- (c) Bring any refuse rubbish litter or offensive material into the Reserve or deposit or leave any refuse rubbish litter or offensive material within the reserve except in the receptacle provided for the purpose;
- (d) Commit or create any public or private nuisance or any annoyance to the public or any persons lawfully in the Reserve or behave in a disorderly indecent or offensive manner or create a disturbance, or use offensive or insulting language;

- (e) Make any unreasonable noise or play any instrument or other sound producing device so as to cause annoyance to interfere with the enjoyment of any other persons within the Reserve;
- (f) Enter or remain within the Reserve whilst in a state of intoxication or whilst under the influence of a hallucinatory drug;
- (g) Permit or allow any animal owned by him or her to enter or remain within the Reserve provided however that dogs kept at all times under proper control on a chain cord or leash may enter the Reserve;
- (h) Play or practice any cricket football bowls tennis golf or other like game or any organised sport within the Reserve or any part of the Reserve where a sign is displayed indicating that such activities are not permitted;
- (i) Interfere with, interrupt or obstruct any sports match, sports gathering or game being played within the reserve on a sports ground or playing area set aside for the purpose of such sport or game;
- (j) Drive or park any vehicle within the Reserve except on or within a roadway or parking area set aside for that purpose provided however, that nothing herein contained shall prevent any officer or employee of the Committee from driving or parking a vehicle within the Reserve in the course of his or her duties;
- (k) Ride any horse within the Reserve except within the Reserve or part of the Reserve set aside for that purpose;
- (l) Kill or injure any animal or bird within the Reserve;
- (m) Being over the age of fourteen years use any playground equipment or enter or remain in any playground between the hours of sunset or sunrise;
- (n) Enter or use any part of the Reserve for the time being set apart or appropriated for the use of the opposite sex except a child under the age of four years in the care of a responsible person;
- (o) Bring or come to be brought into the Reserve any unregistered or uninsured motor cycle or recreation type vehicle;
- (p) Use any minibike, trailbike or similar recreation type vehicle on the Reserve without the written authority of the Committee and then only under such conditions as may be determined by the Committee.

#### *Activities requiring a Permit*

5. No person shall except in accordance with a permit in writing:

- (a) Sell or offer for sale any article whatsoever within the Reserve;
- (b) Camp within the Reserve;
- (c) Light a fire or permit a fire to remain alight within the Reserve except in a fireplace provided for that purpose.

*Permits*

6. (a) Any application for a permit shall be in writing in such form as the Committee may determine from time to time.

(b) Any permit issued by the Committee may be limited in time or in its operation and where in the opinion of the Committee which has issued a permit, there has been a material change in circumstances or in the condition of the Reserve or where the terms or conditions attaching to any permit have not been complied with then the Committee may amend or revoke the permit.

(c) The Committee may from time to time fix and collect a fee for issue of any permit—(Rs 12861).
