GOVERNMENT NOTICES

REGULATIONS

Myrtleford Recreation Reserve

I, Kay Patricia Setches, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria in pursuance of the powers conferred on me by section 13 of the *Crown Land (Reserves) Act 1978* do hereby make the following regulations for and with respect to the remaining lands in the Parish of Myrtleford temporarily reserved as sites for Racing and Recreation Purposes by Orders in Council of 1 April 1867, 11 November 1868, 17 November 1959 and 19 January 1971 (hereinafter called the "Reserve") in respect of which a Committee of Management (hereinafter referred to as the "Committee") has been appointed.

Regulations

1. In these Regulations, unless inconsistent with the context or subject matter—

"Vehicle" includes every conveyance capable of being propelled, pushed or drawn by human, animal, mechanical, electrical or other power and includes a motor car as defined in the *Motor Car Act 1958* but expressly excludes perambulators and push bikes.

2. The Reserve shall be open to the public at all times free of charge, except on such occasions as the Reserve or any portion thereof may be set apart for such activities as the Committee may decide or any or which occasions a fee as may be determined by the Committee from time to time may be charged and taken for admission of every person to the Reserve or any portion thereof.

3. The Committee may set apart any portion or portions of the Reserve for the purpose as the Committee may from time to time decide or as a pleasure ground or place of public resort or recreation.

4. No person shall cross or trespass on any areas set aside as hereinbefore provided during a function authorised by the Committee when such crossing or trespassing would be injurious or be an undue interference to the progress of such function.

5. No person shall climb, jump or get upon or over or under any of the fences or gates in or around the Reserve, or cut or damage or in any way remove any of such fences or gates or any buildings, seats, equipment, trees, shrubs or flowers therein, nor shall any person affix bills or advertisements or writings on any of such fences, gates, buildings, seats, equipment or trees without the consent, in writing, of the Committee.

6. No person shall, without written permission of the Committee, light a fire in the Reserve except in a proper fireplace.

7. No person shall dig or remove any turf or soil or enter any plot enclosed for a plantation of young trees of shrubs or walk on or over any lower bed therein or commit any nuisance or damage or destroy any property or thing in the Reserve.

8. No person shall throw, deposit or leave any glass, filth, rubbish, refuse, junk or waste material of any kind to be thrown or deposited upon or left in the Reserve or in or upon any building or structure therein.

9. Any person using the Reserve or any building or structure therein for any purpose consistent with the purposes of the reservation shall, prior to leaving the Reserve, building or structure, collect and remove or cause to be collected and removed all waste material, scraps, bottles, glass or litter of any kind brought into or made by such person in the Reserve, and any person who fails or refuses to collect and remove or cause to be collected and removed all waste material, scraps, bottles, glass or litter of any kind brought into or made by such persons therein shall pay to the Committee the cost of removing same and such cost may be recovered by the Committee before a Magistrates Court.

10. No person shall in or upon the Reserve kill, wound, trap or snare or attempt to kill, wound trap or snare any native bird or other native game or have any dead native bird or other native game or the skin or pelt thereof in his possession.

11. No person shall sell or offer for sale in the Reserve any article of food or drink or any other commodity, or operate any amusement for which a charge is made or erect any tent, booth, stand, building or other structure in the Reserve without the permission in writing of the Committee.

12. No person shall behave in a noisy or disorderly manner or create or take part in any disturbance or commit any act of indecency or offend against decency as regards dress, language or conduct on the Reserve or in any building or structure thereon.

13. No person shall wilfully obstruct, disturb, interrupt or annoy any other person in the proper use of the Reserve, or wilfully obstruct, disturb, interrupt or annoy any employee of the Committee or member of the Police Force in the proper execution of his duty or work in the Reserve.

14. No person shall, without the written permission of the Committee first had and obtained, camp in any part of the Reserve and then only in such part of the Reserve as may be set aside by the Committee for the purpose.

15. No person shall give, cut or distribute any hand-bill, placard, notice, advertisement, book, pamphlet or paper in the Reserve without the consent, in writing of the Committee or litter the Reserve by scattering or throwing down any such hand-bill, placard, advertisement, book, pamphlet or paper.

16. (i) No person shall cause, suffer or permit any dog belonging to him or in his charge—

(a) to be brought into or enter or remain in the Reserve unless such dog is and continues to be at all times under proper control on a chain, cord or leash, and unless such dog be effectively restrained from causing annoyance to any person and from damaging or interfering in any way with any property in the Reserve;

(b) to be brought into or enter or remain in any camping area or any portion of the Reserve prohibited to the entry of dogs and indicated by notices.

(ii) Nothing in these regulations prohibits a blind person having in the Reserve a dog that is used by that person as a guide dog.

17. (i) Save as aforesaid no person shall without written permission of the Committee allow an animal belonging to him or in his charge to be brought into or enter or remain in the Reserve with the exceptions of a horse drawing a vehicle or a saddle hack in his charge.

(ii) The Committee may prohibit or limit the use of saddle hacks in the Reserve or portions thereof.

(iii) Any animal found in the Reserve contrary to these Regulations may be seized and impounded or destroyed, and the owner or custodian thereof shall be liable to pay compensation for any damage done by such animal to any property in the Reserve.

18. No person shall bring or cause to be brought into the Reserve an unregistered or uninsured motor cycle or recreational type vehicle.

19. Maximum vehicle speed limit in the Reserve area shall be 15 km per hour.

20. No person shall remove, displace or disfigure any board, plate or tablet or any support, fastening or fitting used or constructed for the exhibition of any regulations or notice fixed or set up by the Committee in the Reserve.

21. The Committee shall have the power and authority to close the Reserve or any part thereof and exclude the public therefrom whenever the Committee considers it necessary to carry out repairs, alterations or reconditioning of turf or for any other purpose having as its object the proper care and management of the Reserve.

22. (i) Any person carrying or using any firearm, poison, trap or snare or net in the

Reserve without written permission of the Committee shall surrender the same on demand to any authorised officer who shall issue a receipt therefor.

(ii) The person apparently entitled to any such article may collect it from the office of the Committee, after completion of investigations and legal proceedings, if any, by the Committee in relation to any offence alleged against the person who surrendered the same.

23. Any person offending against any of the Regulations may, in addition to any other penalty to which he may be liable, be removed from the Reserve, by a member of the Police Force or any employee of the Committee, and any person so removed shall not again enter the Reserve during the day he is so removed.

24. No person shall aid, abet, counsel or procure any other person in doing any act or thing which is a breach of these Regulations—(Rs 1859).

These regulations are in lieu of and revoke any previous regulations.

**Rezoning of Land Situated in Ross Street,

Introduction

This is an explanatory report pursuant to the requirements of section 12 of the Planning and Environment Act in respect of a proposed amendment to the Rodney Planning Scheme.

Context of the Proposed Amendment

The proposed amendment arises in the context of a landowner proposing to develop land for rural-residential purposes.

Subject Land and Surrounds
