EXEMPTION

Application No. 7 of 1989

On 3 August 1989 the Equal Opportunity Board considered an application under section 40 (1) of the *Equal Opportunity Act 1984* ("the Act") by the City of Keilor. Upon reading the material tendered in support of this application and hearing submissions on its behalf from Mr Ian Carpenter, Manager, Management Services, and Mr Mark Harvey, Personnel Manager, for the City of Keilor, the Board is satisfied that it is appropriate to grant an exemption from sections 21 and 59 of the Act in their application to the two positions of Patron Supervisor of the two leisure centres of the Applicant.

The Board was substantially assisted in this application by the representatives of the Applicant who cogently set out the rationale for the application as follows:

- (a) that Patron Supervisors as part of their duties must enter and patrol both male and female change rooms;
- (b) that patrons of the leisure centre are not comfortable with a Supervisor of the opposite sex performing the above duties as they involve entering an open area where patrons change, shower and use toilet facilities;
- (c) that such supervision of change rooms has proved necessary for—
 - (i) the protection of patrons' rights and their safety;
 - (ii) the security of patrons' possessions; and
 - (iii) the prevention of vandalism;
- (d) that without an exemption as sought the Applicant could not control a balance of male/female Supervisors;
- (e) that the two positions are the only positions out of a possible fifteen members of staff working at one time within the leisure centre for which the Applicant seeks an exemption.

The Board hereby grants an exemption from the operation of sections 21 and 59 of the *Equal Opportunity Act 1984* for the positions of Patron Supervisor at the City of Keilor leisure centres, such exemption to remain in force until 4 August 1992.

CARTERS AND DRIVERS AWARD PART V

The Carters and Drivers Conciliation and Arbitration Board gives notice that it has varied the Carters and Drivers Award to provide for a four per cent Second Tier Wage Increase (Common Rule), to take effect from the beginning of the first pay period to commence on or after 3 August 1989. The Board in doing so was guided by the Commission in Full Session's decision in the State Wage Case of March 1988 (Decision No. 83/1987).

In addition to the above, the Carters and Drivers Conciliation and Arbitration Board will consider the implementation of the State Wage Case (3 per cent and \$10.00) of September 1988 (Decision No. D88/0260) in relation to this part.

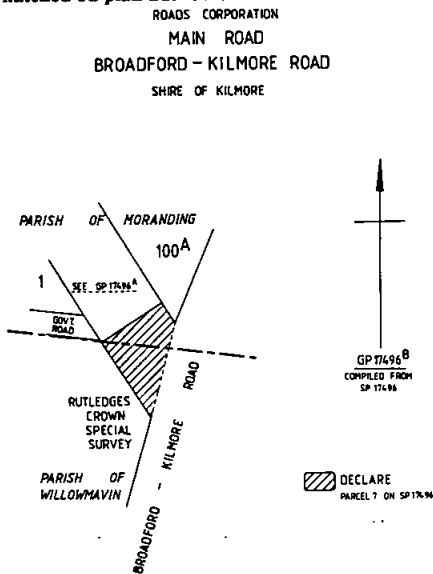

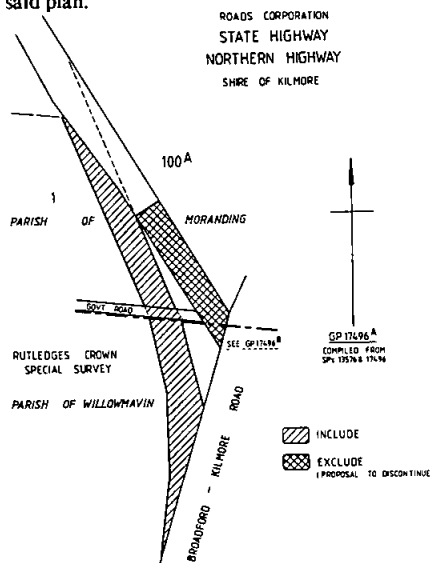

AMENDMENTS TO THE RULES OF THE PRAHRAN MECHANICS' INSTITUTION AND CIRCULATING LIBRARY

The Committee of the Prahran Mechanics' Institution and Circulating Library make the following Rules:

1. In these Rules the Rules of the Prahran Mechanics' Institution and Circulating Library as revised in February 1985, approved by the Governor in Council on 19 February 1985 and published in the *Government Gazette* on 6 March 1985 are called the Principal Rules.

2. In section 3 of the Principal Rules in paragraph 11 (b) for "\$15.00" substitute "\$20.00".

3. In section 6 of the Principal Rules, for paragraph 18 substitute—

"18. (1) Four ordinary members of the Committee shall be elected at the first annual general meeting following the date of commencement of this paragraph.

(2) Of the four members elected in accordance with sub-paragraph (1) one shall hold office for four years, one shall hold office for three years, one shall hold office for two years and one shall hold office for one year.

(3) The tenure of office in accordance with sub-paragraph (2) for the four members elected in accordance with sub-paragraph (1) shall be determined by lot.

18A. (i) At each annual general meeting after the first such meeting following the date of commencement of this paragraph one ordinary member of the Committee shall be elected.

(2) The member elected at each general meeting in accordance with sub-paragraph (1) shall hold office for four years."

4. In section 6 of the Principal Rules in paragraph 20—

(a) for "20. There shall be" substitute "20. (1) There shall be"; and

(b) at the end of the paragraph insert—

"(2) A member of the Committee may be elected as Treasurer but if the person elected as the Treasurer is not a member of the Committee he or she may attend Committee meetings but is not entitled to vote except on financial matters."

(5) In section 9 of the Principal Rules for paragraph 31 substitute—

"31. (1) Printed receipts shall be given by the duly appointed officer in the name of the Institute for members' subscriptions and for any lease payments received on behalf of the Institute or if a person specifically asks for a printed receipt.

(2) Except as provided in sub-paragraph (1) a printed cash register docket is sufficient receipt for any money received on behalf of the Institute and the printed cash register summary is sufficient as a record of the transactions recorded by the cash register."

6. In section 9 of the Principal Rules in paragraph 33 for "\$25 or upwards" substitute "\$300 or more (not including petty cash)".

7. In section 9 of the Principal Rules for paragraph 34 substitute—

"34. (1) A petty cash float of \$300 shall be kept on the imprest system.

(2) For each disbursement from the petty cash float a cash register docket shall be retained and a note of the type of disbursement entered on the docket.

(3) Every payment made by cheque on account of the Institute shall be signed by three Committee members of whom at least one shall be the Chairman, the Treasurer or the Secretary of the Institute.

(4) A list of cheques shall be prepared and submitted for endorsement at the monthly Committee meeting.

(5) The cash register journal tapes shall be retained for the purposes of audit."

8. In section 11 of the Principal Rules for paragraph 40 substitute—

"40. The Secretary may, subject to review by the Committee, issue Special Library Cards valid

for 12 months as the Secretary considers appropriate."

9. In section 11 of the Principal Rules in paragraph 42 for "fine" substitute "charge".

10. In section 11 of the Principal Rules in paragraphs 43 and 44 for "fines" (wherever occurring) substitute "charges".

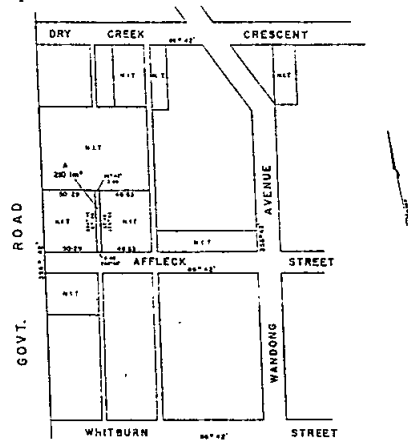

4. The appointment to Public Offices Order 1989 made on 24 January 1989 is revoked.

5. Notwithstanding anything in any Order in Council (whether made before or after the commencement of this Order):

(a) A member of Parliament who is appointed to a public office shall not be entitled to any salary or remuneration payable in respect of that office.

(b) Subject to clause 6 a person employed full time in the service of the State of Victoria who is appointed to a public office shall not be entitled to any salary or remuneration payable in respect of that office.

This clause does not prevent any person receiving the reimbursement of reasonable expenses incurred in respect of a public office.

6. Notwithstanding anything in clause 5 (b) a person employed full time in the service of the State of Victoria who is appointed to a public office shall so long as the person is not receiving salary or remuneration from his or her service be entitled to such salary as is payable in respect of the public office.

7. This Order has no application:

(a) To the appointment of a member of Parliament to a public office where an Act provides that that office is not regarded as an office under the Crown.

(b) To appointment of a person employed full time in the service of the State of Victoria to a public office where the Order in Council making the appointment states

Authorising Provision

Amendment of Rule 6

4. For Rule 6 of the Principal Rules and Regulations substitute—

'6. (a) The fee payable by persons seeking to carry on the business or vocation of a bookmaker at a race meeting at a racecourse conducted by any racing club specified in the Schedule (known as a "licensed betting fee") is not to exceed—

- (i) \$34.50 for any picnic race meeting;
- (ii) \$53.50 for any licensed race meeting held on a Saturday or Public Holiday; or

(iii) \$63.00 for any other licensed race meeting.

(b) Wherever, in accordance with plans submitted by the club and approved by the Executive Council under section 5 of the *Racing Act 1958*, there is provision for Rails Bookmakers, any person desiring to carry on the business or vocation of a Rails Bookmaker must pay an additional fee (known as a "rails fee") not exceeding—

- (i) \$69.00 for any picnic race meeting;
- (ii) \$107.00 for any licensed race meeting held on a Saturday or Public Holiday; or
- (iii) \$126.00 for any other licensed meeting.
