Pipelines Act 1967, No. 7541APPLICATION FOR A PERMIT TO OWN
AND USE A PIPELINE

1. In accordance with the provisions of section 11 (1) of the *Pipelines Act 1967*, notice is given that an application has been received by me from Cabot Australasia Pty Ltd for a Permit to Own and Use a Pipeline for the purpose of conveying liquid hydrocarbons within the Petrochemical Complex Area at Altona.

2. The proposed pipeline was laid before the commencement of the *Pipelines Act 1967* and the Company is now seeking to have it made subject to the provisions of the *Pipelines Act 1967*.

The proposed route of the pipeline is as follows:

A steel pipeline approximately 1350 metres in length with a nominal bore of 300 mm commencing at a pig launcher located midway between Tank 902 and Tank 903 in the Petroleum Refineries (Australia) Pty Ltd North Crude Tank Farm at Altona, thence proceeding in a generally northerly direction for a distance of approximately 80 metres to enter the South Western Railway Reserve and within an existing above ground pipe rack turning to continue in a generally westerly direction for a distance of approximately 700 metres, thence turning to continue in a generally southerly direction to leave the Railway Reserve to enter the PRA Refinery Area and enter a pig receiver station and take off point, thence turning to continue in a generally northerly direction to re-enter the Railway Reserve and within the existing above ground pipe rack turning to continue in a generally westerly direction for a distance of approximately 335 metres, crossing Millers Road en route, thence turning to continue in a generally northerly direction for a distance of approximately 110 metres to enter property owned by Cabot Australasia Pty Ltd, crossing the South Western Railway en route, and within such property turning to continue in a generally westerly direction for a distance of approximately 300 metres to terminate at an isolating valve located adjacent to the southern boundary of the Company's property, at a point approximately 300 metres west of Millers Road, on Crown Allotment 20, Section 4, Parish of Cut-paw paw.

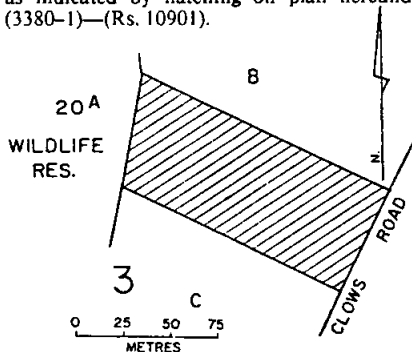
