# REVOCATION OF PROHIBITED PERIOD

In pursuance of the powers conferred by section 3 of the Forests Act 1958, I, Kay Setches, Her Majesty's Minister for Conservation, Forests and Lands in the State of Victoria, hereby vary the Declarations of a Prohibited Period previously made by me in the Victoria Government Gazette No. 49 dated 13 December 1989 and Gazette No. 50 dated 20 December 1989 insofar as they refer to the municipalities specified hereunder, and by this notice declare that in the specified municipalities the Prohibited Period in respect to any fire protected area (other than a State forest, National park or Protected public land) shall end as specified hereunder.

#### Schedule 1

The Prohibited Period shall end at 0100 hours on Saturday, 24 March 1990 in the following municipalities:

The Shires of Alberton, Avon, Bacchus Marsh, Gisborne, Bairnsdale, Ballan, Bannockburn, Barrabool, Buln Buln, Colac, Corio, Daylesford and Glenlyon, Heytesbury, Kyneton, Maffra, Melton, Morwell, Narracan, Newham and Woodend, Omeo, Otway, Romsey, Rosedale, Tambo, Traralgon, Warragul, and Winchelsea.

## Schedule 2

The Prohibited Period shall end at 0100 hours on Monday, 26 March 1990 in the following municipalities:

The Shire of Arapiles, Ararat, Kowree, Mount Rouse, Stawell, and Wimmera.

The Shire of Dundas—being that portion north of the Dunkeld to Cavendish to Balmoral Road.
