### Notice of Decision

I Steven Marshall Crabb, Minister for Conservation and Environment, hereby give notice under section 11 of the *Subordinate Legislation Act 1962* as follows:

The Wildlife (Game) Regulations 1990 have been the subject of a Regulatory Impact Statement.

Public comments and submissions were invited from the public and have been considered as required by section 12 of the *Subordinate Legislation Act 1962*.

I have decided that the proposed Wildlife (Game) Regulations 1990, with some modifications, should be made.
