Notice of approval of Amendment  
Amendment S11

The Minister for Planning and Urban Growth has approved Amendment S11 to all Planning Schemes in Victoria.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment extends the time of operation of the interim statewide vegetation retention measures from 30 November 1990 until 28 February 1991 to allow consideration of similar measures in Amendment S5.
