#### FISHERIES NOTICE

No. 7/1990

I, Steven Marshall Crabb, Minister for Conservation and Environment, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

# FISHERIES (SCALLOP FISHING CLOSURE) NOTICE 1990

#### Title

1. This Notice may be cited as the Fisheries (Scallop Fishing Closure) Notice 1990.

#### Commencement

2. This Notice comes into operation on 22 December 1990.

#### Objective

3. The objective of this Notice is to close Victorian waters to scallop dredging until 1 March 1991.

#### Authorising provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

#### Close season

5. A person must not use a dredge for taking scallops from Victorian waters during the period from the 23 December 1990 to the 28 February 1991 (Both days inclusive).

#### Penalty

6. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
