#### Proposed Motor Car Traders (Fees Amendment) Regulations 1990 NOTICE OF PREPARATION OF A REGULATORY IMPACT STATEMENT

Notice is hereby given in accordance with the provisions of the Subordinate Legislation Act 1962 of a proposal to make regulations to be known as the Motor Car Traders (Fees Amendment) Regulations 1990.

The object of these regulations is to increase fees payable under the Motor Car Traders Act 1986 to ensure sufficient revenue for the Motor Car Traders Guarantee Fund to meet its commitments under the Act.

A regulatory impact statement has been prepared in accordance with the provisions of the Subordinate Legislation Act 1962. The impact statement notes that:

(i) After paying justified claims, the Fund has not been able to meet all administrative expenses, requiring subsidisation from Appropriations; (ii) The Treasurer has determined these costs must be met as required under the Motor Car Traders Act 1986. Given present licence revenue, the Fund's ability to meet contingent claims will erode.

After examining alternatives, the impact statement recommends the least-cost option which will allow full cost recovery and provision for contingent claims.




