**NOTICE FIXING TOTAL ALLOWABLE  
CATCH FOR DECLARED ABALONE  
ZONES**

Under section 13c (3) of the *Fisheries Act 1968*,  
and after having regard to the recommendation  
of the Fisheries Management Committee, I  
hereby fix the total allowable catch for the abalone  
fishery for the twelve months from 1 April 1990  
as follows:

Eastern zone—460 tonnes

Central zone—700 tonnes

Western zone—280 tonnes.
