Notice of Regulatory Impact Statement

It is proposed to amend the Agricultural Chemicals Regulations 1981 to increase the fees prescribed for registration of agricultural chemicals and to modify the registration procedures for agricultural chemicals. It is further proposed to amend the Pesticide Regulations 1976 to revoke the prescribed fee for altering a label used in connection with a registered agricultural chemical.

A Regulatory Impact Statement has been prepared in accordance with the requirements of the *Subordinate Legislation Act 1962* and concludes that the increased registration fees substantially recoup the costs incurred by government in servicing the registrants of agricultural chemicals.
