REVOCATION (DANDENONG-SPRINGVALE WATER BOARD ORDERS) ORDER 1991

- 1. This Order is called the Revocation (Dandenong-Springvale Water Board Orders) Order 1991
 - 2. This Order takes effect on 25 June 1991.
 - 3. In this Order-

 - (b) the Change of Membership of the Dandenong-Springvale Water Board Order 1991 published in Government Gazette G23 of 19 June 1991; and
 - (c) the Change of Name of the Dandenong-Springvale Water Board Order 1991 published in Government Gazette G23 of 19 June 1991.
- 4. The Dandenong-Springvale Water Board Orders are hereby revoked.

EMERALD DISTRICT WATER BOARD AND DANDENONG-SPRINGVALE WATER BOARD

Transfer of Functions Order 1991

The Administrator in Council, under subsections 3 (3), 3 (4), 3 (5) and 3 (6) of the Melbourne and Metropolitan Board of Works Act 1958 (MMBW Act), and on the application of the Melbourne and Metropolitan Board of Works orders that:

- 1. The land specified in the attached schedule "Land") be included in the "metropolis" as defined in sub-section 3(1) of the MMBW Act.
- 2. No provision pursuant to section 3 (5) (a) (i) and (ii) of the MMBW Act be made.
- 3. The functions of the Dandenong Valley and Western Port Authority shall continue in relation to the land referred to in clauses (a) and (b) of the Schedule which is land within a waterway management district of this authority under the Water Act 1989 and the Melbourne and Metropolitan Board of Works shall not make and levy the Metropolitan Drainage and River Improvement Rate in respect of that land.
- 4. All the works and property (including, without limitation, all assets, powers and rights of every description and, to the extent that the same is property, the benefit of all contracts of employment) of the Emerald District Water Board and the Dandenong-Springvale Water Board vest in the Melbourne and Metropolitan Board of Works.
- 5. This Order takes effect on and from the date on which it is published in the Government Gazette.

- (b) the sewerage districts in relation to the Dandenong-Springvale Water Board set out in column 3 of Schedule 12 to the Water Act 1989 and every other sewerage district declared by the Minister pursuant to the Water Act 1989 at any time prior to the making of this Order to be under the authority of the Dandenong-Springvale Water Board.

WATER ACT 1989

Pursuant to section 105 (2) of the Water Act 1989 I abolish the Dandenong-Springvale Water Board and the Emerald District Water Board.

Victoria Government Gazette

This order is made in consequence of the Order of the Governor in Council extending the metropolis to include the areas of the Emerald District Water Board and the Dandenong-Springvale Water Board ("the former Authorities") which Order of the Governor in Council was published in the Government Gazette on 25 June 1991. By reason of the said Order in Council neither of the former Authorities has any function to perform.


All works and property of the former Authorities that have not already been vested in the Melbourne and Metropolitan Board of Works ("the Board") are hereby vested in the Board.
