WATER ACT 1989

I, Peter Sheehan, Director, Water Industry Management as Delegate of the Minister for Conservation and Environment, make the following Order:

AMENDMENT OF THE APPOINTMENT OF THE MID-GOULBURN REGIONAL WATER BOARD ORDERS 1991

(Numbers 1 and 2)

1.
