Shop Trading Act 1987

PROCLAMATION

Exemption of Shops from the closing provisions
of Part 2 of the Act

I, J. Davis McCaughey, Governor of Victoria,
acting with the advice of the Executive Council
and under sections 8 (8) and 8 (9) of the *Shop
Trading Act 1987*, by this proclamation exempt
shops from the closing provisions of section 7 (3)
of the Act on Sunday, 21 July 1991.

This Proclamation does not exempt shops from
the closing provisions of section 7 (2).
