Direction under section 247 (3) of the *Water Act*
1989 and all other Enabling Powers

Pursuant to section 247 (3) of the *Water Act*
1989 and all other enabling powers I direct the
City of Sale to make the following variations in
its 1991/92 Business Plan:

- (i) Refrain from making any contribution
from water and sewerage funds for the
new City of Sale office proposal, until the
Director-General, Department of
Conservation and Environment has
approved the project evaluation in
accordance with the Department of Water
Resources Victoria, Report No. 35
Investment Planning and Project
Evaluation in the Victorian Water Sector.
- (ii) Refrain from entering into any contract
for the sale or lease of City of Sale water
and sewerage assets in excess of \$5000,
without firstly obtaining the approval of
the Director-General, Department of
Conservation and Environment.
