

WATER ACT 1989

I, Steve Crabb, Minister for Conservation and Environment make the following Order:

APPOINTMENT OF THE MACEDON REGION WATER AUTHORITY ORDER (No. 1) 1991

1. This Order is called the appointment of the Macedon Region Water Authority Order (No. 1) 1991.
2. This Order is made under the powers conferred by Division 2 of Part 6 of the *Water Act* 1989 and all other available powers.
3. This Order takes effect on the date of its publication in the *Government Gazette*.
4. In this Order—  
 "Act" means the *Water Act* 1989.  
 "Former authority" means the Sunbury Water Board.
5. On and from the date on which this Order takes effect the Macedon Region Water Authority is appointed to take over the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the Former Authority including the management and control of the existing water districts named below:  
 Bulla-Diggers Rest Urban;  
 Bulla-Oaklands Junction Rural;  
 Sunbury Urban;  
 Sunbury Waterworks;  
 and the management and control of the existing sewerage districts named below:  
 Diggers Rest Sewerage;  
 Sunbury Sewerage.
6. The Macedon Region Water Authority takes over the staff of the Former Authority from the date of this Order.
7. On and from the date on which this Order takes effect, the interim membership of the Macedon Region Water Authority is increased to include three additional members listed below:  
 John Burgess;  
 John McMahon; and  
 Des Nelson.
8. The Former Authority is abolished.
9. (a) This is an Order referred to in section 98 (2) (a) of the Act.

(b) Under section 100 (2) (a) of the Act, the affected Authorities have applied to me for the Order to be made.

(c) Under section 98 (2) (a) of the Act, I have agreed to the terms and conditions for the takeover made by this Order with the affected Authorities.

 Riddells Creek Sewerage.
6. The Macedon Region Water Authority takes over the staff of the Former Authority from the date of this Order.
