**BROADMEADOWS, COBURG AND
PRESTON PLANNING SCHEMES**

Notice of Approval of Amendment

Amendment RL146

The Minister for Planning and Housing has approved this amendment to the Broadmeadows, Coburg and Preston Planning Schemes.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment removes that part of the F2 Proposed Main Road reservation between Bell Street, Coburg and Mahoneys Road, Thomastown, because the Government is of the view that the land is no longer required for road purposes and is more appropriately used as part of the metropolitan strategic open space network and for other uses similar to those on adjoining land.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Planning and Housing, Ground Floor, 477 Collins Street, Melbourne and at the Municipal Offices of the Cities of Broadmeadows, Coburg and Preston.
